The Pakistani army with the help of their local collaborators picked up RP Shaha and his son from their Narayanganj office on this day during the Liberation War in 1971 but they did not return.


It was assumed that they had been killed for supporting the Liberation War.

# Indo-Bangla joint body meets today

Dipu Moni leaves for New Delhi

Foreign Minister Dipu Moni went to New Delhi yesterday to take part in the first Bangladesh-India Joint Commission meeting and discuss bilateral issues including the Teesta water-sharing deal with India. Dipu Moni would co-chair the meeting

with Indian External Affairs Minister SM Krishna at 12:30pm today. Sources said issues, including the Teesta

water sharing deal, implementation of land boundary agreement and an extradition treaty would be high on the agenda. Foreign ministry sources said the delega-

tion level Joint Commission meeting would be followed by a joint media interaction where the two ministers would be present. According to her programme schedule,

Dipu Moni would meet Indian Water Resources Minister Pawan Kumar Bansal tomorrow at 2:30pm. She would also meet with Home Minister Palaniappan Chidambaram at 4:15pm and Prime Minister Manmohan Singh at his official residence at 5:30pm tomorrow.

The Joint Commission was formed under the Framework Agreement on Cooperation for Development signed during Indian Prime Minister Manmohan Singh's visit to Dhaka on September 6-7, The Joint Commission was envisaged as

an annual event at foreign/external affairs minister level to jointly coordinate and oversee implementation of initiatives as well as to explore newer avenues for cooperation. Sources said Dhaka and New Delhi would discuss and review implementation

of agreements, initiatives and decisions

agreed upon during Prime Minister Sheikh Hasina's visit to New Delhi in January, 2010, and Manmohan Singh's Dhaka visit last vear. India has been pushing for early signing of an extradition treaty but Dhaka is work-

ing on a draft and has not yet finalised any decision whether to sign. Both sides would talk about strengthening cooperation on security, combating

insurgents, countering terrorism and other

border related issues. Dipu Moni would be the guest of honour at the closing ceremony of the year-long joint celebrations of the 150th birth anniversary of Rabindranath Tagore at Vigyan Bhavan in New Delhi later today.

## Govt influences court: Moudud

Accusing the government of influencing court as police has kept the Supreme Court cordoned, the BNP-led opposition lawmakers yesterday said that political confrontation would increase if the path of justice was closed.

Addressing a press conference at the Parliament Media Centre, BNP's front ranking leader Barrister Moudud Ahmed MP said that the accused could not appear before the Supreme Court for anticipatory bail as police has kept the court cordoned.

The press conference was organised to protest the government action implicating eight opposition MPs in two cases setting fire to a bus near PM's office and bomb blasts at the Secretariat during hartal on April 29.

Modud alleged that the court was influenced by the government and said the government had made the country "a police state."

### Domestic help 'raped' by employer

A 13-year-old domestic help, now undergoing treatment at Dhaka Medical College Hospital's (DMCH) One Stop Crisis Centre (OCC), filed a case on Saturday accusing her employer of raping her.

The girl, in her first information report, stated that her employer, Imam Hossain Wasim, resident of Block C in the capital's Bashundhara Residential Area, occasionally raped her from the second year of her three-year work period.

Two months ago when the girl informed Imam's wife, Moitree Hossain Mumu, of the abuse, she abetted him and started beating her regularly, she added.

The girl was able to flee from the couple on May 2. A female bus passenger, hearing of her plight, took her to Lalbagh Police Station.

She was then transferred to the custody of Aparajeyo Bangladesh Child Health Line, which admitted her to DMCH on May 3. Medical tests conducted on May 4 confirmed that the girl

had been raped and tortured, said OCC Chief Coordinator Dr

Bilkis Begum, adding that marks of injury, both fresh and old, were found on the girl's body. The case was filed with Bhatara Police Station under

Women and Children Repression Prevention Act.

The case's Investigation Officer Sub-Inspector Syed Al Mamun said police will take the girl to identify the house so that the accused can be arrested.

# Equal rights for people of all faiths ensured, says PM

Prime Minister Sheikh Hasina last night said her government wants everyone, irrespective of religion, caste and creed, to live with equal rights and follow their religion freely and with festivity.

"The government has been working hard to create such an environment," she said.

Hasina was addressing members of the Buddhist community at her official Gono Bhaban residence in the capital marking Buddha Purnima.

Referring to the 15th amendment to the constitution, she said her government ensured equal rights for believers of all religions and restored the spirit of the 1971 Liberation War through this

amendment. "People of all faiths in the country are enjoying their religious rights equally and peacefully due to the bold and

prudent steps of the present government," she said.

Hasina said the previous BNP-Jamaat alliance government tarnished Bangladesh's image and projected it to the world as a country of militancy.

"But, we have brightened the country's image by rooting out militancy and terrorism," she said.

She said, apart from Awami League acitivists, people of Muslim, Hindu, Christian and Buddhist communities were also brutally tortured and repressed during the five-year "dark chapter" of the BNP-Jamaat alliance

government from 2001. "As many as 21,000 AL leaders and workers and 16 journalists were killed during this time," she said.

Hasina said her present government, after assuming office in 2009, did not take any revenge for the torture and repression as AL does not believe in the

politics of vengeance.

"Rather, we applied our all out strength for the welfare of the people and development of the country," she said, adding that this resulted in tremendous development in different fields of the country.

Extending her heartiest greetings to the people of the Buddhist community on the occasion, Hasina called upon all to work unitedly to ensure advancement of the country by following the message of non-violence of Lord Buddha.

"We want to build Bangladesh as a hunger and poverty-free peaceful country in South Asia following the teachings of Lord Buddha," she said.

## Cop presses for murder case withdrawal: Complainant

The complainant of a murder case alleged that a police official has been pressing him to withdraw an under trial case which he filed for "killing" his sister.

In a written statement, Jamal Miah of village Rajapur in Madhabpur upazila under Habiganj alleged that Sub-Inspector (SI) Kamal Hossain of Madhabpur Police Station of the district has been pressing him to withdraw the case which is now under trial at the additional district & session judge court.

Jamal Miah, a poor farmer, made the allegation at a press conference at Habiganj Press Club on Saturday afternoon demanding departmental enquiry and action against the

Getting a phone call, Jamal went to the police station in the evening of March 30 this year and found the accused of his sister's murder case sitting in front of the police officer, Jamal alleged. Later, the SI asked him to withdraw the case but he denied the proposal. At one stage, SI Kamal gave him a good beating in the hajat room and threatened to

case against him, alleged Jamal in the state-

Following the day, the police officer produced Jamal before the Upazila Nirbahi Officer, also executive magistrate, showing him arrested in a case for possessing two Yaba tablets. The magistrate asked for producing him before a mobile court. It was done accordingly but the magistrate acquitted him of the charges as there was no witness or evidence, said Jamal.

However, the police officer then sent him to the jail hajat through a judicial magistrate court in the drug case. Spending 18 days in the jail hajat, he got bail, Jamal claimed.

Jamal said police recovered his sister Marufa Khatun's hanging body at her husband's house at Rajapur village on April 7, 2006. Later on April 9, Jamal filed the murder case accusing 13 of her father-in-law's family. Sub-Inspector Moloy submitted a charge sheet against six of them in the murder case.

Contacted yesterday, SI Kamal Hossain refuted the allegation and said Jamal is "an addict" and he had filed the case against Jamal send him to jail after filing a drug possessing after recovery of two Yaba tablets from him.
