Jatka catching goes on as culprits slip thru' dragnet

Huge fry seized in Dhaleswari drives but none held or purnished

Law enforcers seized 1,005 maunds of jatka ((young during the ban period. hilsa bellow nine inches long) from passenger launches in the Dhaleswari River in the district during February to April but none has been arrested or punished for the callous act that poses threat to hilsa stock.

To help growth of the popular fish, the government imposes ban on catching of *jatka* from February 1 to May 31 every year.

But frequent drives and seizure of huge jatka in

Munshiganj district have apparently failed to stop illegal catching of jatka

From February to April, the coastguard conducted 66 drives and seized huge jatka in 21 of the drives, said Ferdous Alam, station commander of Coastguard Bangladesh in Narayanganj.

"The jatka is being seized mostly from passenger launches but the jatka owners cannot be identified after seizure. If we take initiative to seize the launch or arrest launch staff, passengers get agitated," he said.

When asked how they identified the launches before drives, Ferdous said jatka is often carried in the Dhaka-bound launches coming from Bhola, Borhanuddin and Barguna and these launches cross

ing jatka. However, authorities could not take any action against around a hundred current net producing factories in Munshiganj due to 'legal complications'.

According to Fish Resources Preservation Act catching, carrying and selling of jatka is banned from The law enforcers also February 1 to May 31. The punishment of such

crime is jail term from one month to six months or Tk 1000 fine, or both. If anyone gets involved in the illegal act for the second time the punishment will be doubled.

When asked why none

was punished for such crimes till now, the district fisheries officer of Munshiganj said, "We have stopped jatka catching in the district. Most of the seized jatka comes from other areas in launches. Action against authorities of jatka carrying launches is needed to check the illegal act."

"Only a mobile court can give verdict on the spot, but no mobile court was present during the drives. The upazila nirbahi officers have fund for mobile court drives," he added.

Munshiganj Sadar Upazila Nirbahi Officer Shahanara Yesmin Mili said Munshiganj rivers are free from jatka catching and so, their mobile courts conduct drives in different markets. "The jatka is often car-

ried in large passenger launches that come from other districts. If a mobile court conducts drives in the launches and seize any launch on charge of carrying jatka, we will have to take the responsibility to send the passengers to their destinations," she said.

She suggested conducting mobile court drives in Bhola and Barguna areas from where jatka is taken onto the launches.

Munshiganj Deputy Commissioner Azizul Alam said they had urged the launch owners not to carry illegal jatka. As the instruction is ignored, the authorities concerned are being ordered to take necessary steps.

During three of the most successful drives on March 23, April 2 and April 5, coastguard seized 150 maunds, 210 maunds and 100 maunds of jatka respectively from passenger launches in the Dhaleshwari River and dumped the item on the riverbank.

Human chain, rally on first day of agitation

said their agitation demanding withdrawal of the case will continue until May 14. If the demand is not met by May 14, the mayor, councillors and municipal staff will begin an indefinite strike from May 15, they added. Chaired by Mayor GK Gous, the rally was

addressed, among others, by Pourasava secretary Zaved Iqbal Chowdhury, councillors Dilip Das, Abul Hashim, Junaid Ahmed, Mohammad Alamgir, Zahir Uddin, Nur Hossain and Lovely Begum. The agitating officials and employees of

the municipality will abstain from work for six hours today, hold a protest rally on the Pourashava ground on May 10, observe a half-day hartal on May 13, and daylong work abstention on May 14.

Court yesterday granted bail to Mayor GK Gous and four others in the case.

At the Monday's press conference, Mayor GK Gous, also the general secretary of BNP district unit, alleged that a group of ruling party men came to the municipality office in a procession during opposition-called hartal on April 22 in the name of handing over a memo to him protesting the proposed municipal tax.

Suddenly, the AL men went on the rampage and vandalised the pourasava office and some vehicles in front of the office, he alleged. The mayor said Pourasava Secretary Zaved

Iqbal filed a case with Habiganj Police Station the same day against town unit AL President Sharif Ullah, General Secretary Mukul Acharya, former district BCL president Motassirul Islam, general secretary Sultan Mahmud and 40 to 50 others ruling party men, but police did not record the case.

Being influenced by the ruling party men, police recoded a 'false' case against me and staff of the municipality after 12 days of the incident, the mayor further alleged.

Mayor and others told the press conference that one Abdul Awal of Josher Abda area in the municipality filed the case as complainant.

In the case statement, he alleged that mayor and staff members physically assaulted them when they went to the municipality office for handing over a memo on April 22.

Later Zahir along with his friends caught Dulal and took him to a maize field on the bank of a canal. There they killed Dulal with sharp weapons and dumped the body on the spot. Police arrested Zahir on Monday.

Kid burnt alive

19 more fall sick in Khagrachhari

At least 32 people of Guimarapara area under Matiranga upazila in the district fell sick during the last couple of days as a mass psychogenic illness spread in the area. Ten of the affected people

"The disease first appeared in the village on April 2 and affected 15 teenaged boys and girls in a week. Consequently it sprayed to the whole village, said Haripada Tripura, member of Guimara union parishad.

The patients fell down suddenly and became unconscious with convulsion. After regaining consciousness, they felt weakness and pain in the body and started behaving in a crazy way, said Ratandhan Tripura, father of a patient, who was hospitalised yesterday.

Ratandhan blamed some local charmers for 'causing' the disease by incantations to gain financial benefit.

Khagrachhari District Civil Surgeon Dr Hassan Imam Chowdhuary said three medical teams are working in Guimarapara area and the situation is under control now.

"Outbreak of mass psychogenic illness usually occurs during time of worry and anxiety. The sickness is aggravated by malnutrition, tension and lack of tolerance. The victims mostly belong to the age group of 12

to 25 years," he said.
