Putin vows to make a strong Russia

President Vladimir Putin, speaking in Moscow's Red Square with military generals at his side, said he would promote Russia's might on the world stage in a patriotic speech yesterday glorifying the Soviet victory over Germany in World War Two.

Vladimir Putin Two days after being sworn

in for a six-year term that has drawn protests against his return to the Kremlin, Putin used the address to troops and war veterans at the annual military parade on Red Square to reinforce appeals for national unity.

Putin faces a battle to reassert himself after the biggest protests since he rose to power in 2000 and the detention of hundreds of protesters this week to keep a lid on dissent.

"Russia consistently follows a policy of strengthening global security and we have a great moral right to stand up determinedly for our positions because our country suffered the blow of Nazism," Putin said on a podium flanked by military chiefs bristling with medals under the Kremlin's red walls.

He did not refer to any enemy other than it must be on equal terms with Washington. evoking the victory over Nazi Germany in 1945 at a great human cost, including millions of Soviet victims, at a parade in which goose-stepping troops, tanks and trucks carrying missiles filed past him.

"Barbarians were plotting to destroy whole nations," he said. "The inevitable

Putin, 59, has often used tough statements on foreign policy to rally people and resorted to anti-American rhetoric in the run-up to the March 4 presidential election. The tactic was also used by Soviet leaders, and featured prominently on national

holidays such as Victory in Europe day. During the election campaign, Putin accused US Secretary of State Hillary Clinton of stirring the protests against his 12-year rule

by encouraging "mercenary" Kremlin foes. A Russian general also warned last week that Moscow could carry out pre-emptive strikes on future Nato missile defense installations. Nato called such threats "unjustified" and said the system posed no threat to Russia's security.

Putin has said he is ready to go a long way to develop ties with the United States, Moscow's former Cold War enemy and its fellow veto-wielding member of the United Nations Security Council, but has made clear

Russia has already reasserted itself on several fronts, opposing Western-promoted sanctions aimed at Moscow's long-standing allies Syria and Iran. It has emerged as Syrian President Bashar al-Assad's main foreign supporter in the conflict there, a stand that has created tension with Western powers.

Myanmar leader takes charge of rebel talks

Myanmar's president has taken charge of peace talks with armed ethnic groups for the first time, his office has said, in a new push to end bloody fighting that has marred recent reforms.

Thein Sein was named as chairman of the government negotiating team, in an overhaul that removed elements of the previous delegation seen as obstacles to a deal with fighters in Kachin State in the country's far north.

An order from the president's office, dated May 3 but sent to AFP yesterday, said the high-level committee would "work in a leading role during discussions with ethnic armed groups".

The former general, whose exact involvement in the new negotiations was not specified, met leaders of a major ethnic minority group, the Karen National Union (KNU), for the first time in April.

Myanmar has signed tentative ceasefire deals with a number of rebel groups in recent months as it seeks to draw a line under civil conflicts that have racked parts of the country since independence in 1948. But fighting in Kachin, where a 17-year ceasefire broke

down last June, has continued to rage, forcing tens of thousands of civilians from their homes.

The Kachin Independence Army (KIA) has previously said it lacks confidence in government negotiators and accused the military of planning a large-scale offensive against their stronghold near the border with China.

India Congress chief tells partymen

"We must all shed all manner of factional behaviour and fight as one disciplined team at all levels. That will be the single-most important factor to decide whether we win or lose", she told at a meeting of Congress lawmakers including Prime Minister Manmohan Singh. Sonia said, "People look to us but we need

unity if we are to convert this sentiment into electoral victories".

Commenting on the results of recent elections in five state legislatures including

India's most populous state Uttar Pradesh where the party could not perform as expected, Gandhi said, "While we can take satisfaction in the fact that we returned to power in Manipur for the third time and formed the government in Uttarakhand, the results in Punjab and Goa are very

disappointing". "In Uttar Pradesh, even though we did not perform as well as we had hoped to, we increased our vote share quite considerably and were seen as a serious player for the first time in 22 years. Of course, there is much work to be done there as in

other states", Sonia said. She said that with a series of state elections approaching in the coming months, Congress workers "must draw upon lessons of the previous polls."

She also asked partymen to project the works of the party-led government at the Centre and "expose the hollow claims of opposition-rule state governments".

No one can torce me out of office

Says Pakistani PM

Pakistan's defiant Prime has said that no one could force him out of office through unconstitutional means and he would trial following his conviction of contempt by the Supreme Court.


"I have no yearning to stick to power but I will take it to the finality and exhaust all avenues," he told journalists who accompanied him on an official visit to Britain.

"When they found it difficult to try Jamaat leaders under the 1973 Act [International Crimes (Tribunals) Act-1973], they made suitable amendments in 2009," he said.

Razzaq claimed that the purpose of the International Crimes (Tribunals) Act, 1973 was only to try 195 Pakistan army men for committing crimes against humanity during the Liberation War and there was no scope to try any civilian under the act. There was the collaborator act for trying civilians, he said.

But the 1973 act reads, "A tribunal shall have the power to try and punish any person irrespective of his nationality who, being a member of any armed, defence or auxiliary forces commits or has committed [crimes], in the territory of Bangladesh, whether before or after the commencement of this Act..."

The government brought amendment to the act including the words "any individual or group of individuals" in 2009.

Razzaq claimed that the 195 Pakistan army personnel were the principal accused of atrocities. Citing

some court verdicts he said any of their abettors could not be tried unless the main accused were tried.

An Awami League-led government was in power between 1996 and 2001 but they did not take any initiative to hold the trial, said Razzaq, adding that the prosecution failed to explain the reason behind the delay. Quader, who is facing

seven charges of crimes against humanity, was produced in the dock yesterday. The defence counsel read out the discharge petition on Tuesday. In the formal charges, the

prosecution had said Quader was known as a butcher since he and his accomplices--Razakars and Al Badrs-created a horrendous situation in Mirpur and surrounding areas committing crimes against humanity. The three-member

Tribunal-2, headed by Justice ATM Fazle Kabir with members Justice Obaidul Hassan and Judge M Shahinur Islam, adjourned the proceedings against Quader until May 13 following the time petition from the defence. After the lunch break,

Tajul Islam, one of the defence counsels of Abdul Alim, placed arguments supporting discharge of his client.

Tajul said his client was released because of "scanty evidence" against him.

He said although the prosecution mentioned Abdul Alim as the chairman of Joypurhat Peace Committee during the Liberation War, they failed to prove it. Earlier, Prosecutor Rana

Dasgupta had told the tribunal that Alim, an influential leader of East Pakistan Conventional Muslim League, formed Peace Committee and Razakar Bahini (two collaborator forces) in Joypurhat in 1971 and committed killings genocide, rape, looting, arson and other crimes against humanity in association with the auxiliary forces and the Pakistan army.

Tajul said the Razakar force was formed under the Razakar Ordinance on August 2, 1971 but the prosecution told the tribunal that Alim formed the force in May.

It was not possible, said Tajul, adding that the prosecution failed to provide documents in this regard.

To this, Rana Dasgupta Tajul said on March 9, objected and said Razakar force was formed earlier but it was given legitimacy later through the ordinance.

The tribunal would resume hearing the defence today.

Relaxed visa regime likely for Indo-Pak businessmen

With the Interior/Home ministries of the two countries coming to an understanding on a liberalised visa regime for businessmen, Indian High Commissioner to Pakistan Sharat Sabharwal was on Tuesday confident of an agreement to this effect being signed later this month.

He disclosed this at the second 'Aman Ki Asha' (hope for peace) Indo-Pak Economic Conference in Lahore. The next round of Interior/Home Secretarylevel talks within the composite dialogue framework is scheduled to be held in Islamabad on May 24-25.

Though similar assurances have been given in the past about a relaxed visa regime for businessmen, the High Commissioner was categorical this time round pointing out that already the Indian High Commission in Islamabad was fast-tracking applications of Pakistani

Also, according to Sabharwal, efforts are on to simplify the visa procedure for all Pakistanis. Lesser documentation will be required and the attempt will be to issue the visa within 30 days. Presently, it takes a minimum of 45 days provided the clearance comes from the Home Ministry in New Delhi.
