Society banking faces restriction

Seven-year jail for illegal operation; draft of amendment to cooperative act approved

STAFF CORRESPONDENT

The cabinet yesterday approved the final draft of the Cooperative Society (amendment) Act 2012 that prohibits cooperative societies from running any credit programme among their members.

The draft law also bans receiving deposit or subscription from those who are not members of the cooperative.

Also, it has provisions for maximum

seven years' imprisonment and a fine of Tk 10 lakh for doing banking without approval from the Bangladesh Bank.

"The highest penalty for breaching the law in the past was only one year," Cabinet Secretary Mosharraf Hossain Bhuiyan told journalists after the cabinet meeting at the secretariat with Prime Minister Sheikh Hasina in the chair.

The fine has been raised to Tk 10 lakh

It was none but technocrat Minister Dilip Barua who has urged Prof Muhammad Yunus and Sir Fazle Hasan Abed to join politics to test their popularity before speaking about the coun-

try's politics. He might have forgotten his own popularity, public support behind him and tried to please the prime

minister by blasting the two iconic characters for their suggestions for restoration of caretaker government for peaceful parliamentary polls at a meeting with US Secretary of State Hillary Clinton in Dhaka.

It is usual that Barua will remain grateful to Prime Minister Sheikh Hasina as she made him a fortunate man. In his long political career, Barua was never elected an MP and even could not contest the December 29 parliamentary polls in 2008 as Awami League had picked its own leader to contest the battle of ballots from the con-

stituency from where Barua sought to contest. Hasina inducted him as a minister in her cabinet and gave portfolio of the industries ministry, giving much

illegally operating on a commercial basis in and around the capital. Issuing a suo moto rule, the HC asked the concerned authorities to explain why they should not be directed to cancel their registrations.
