DEATH OF BIBHAS Journos for resignation of shipping minister

Protesting the death of Bibhas Chandra Saha, journalists staged a demonstration before Jatiya Press Club in the capital yesterday halting traffic movement on the road for more than one hour.

They also burnt effigy of Shipping Minister Shajahan Khan demanding his resignation for "defending drivers."

Bibhas, 46, chief crime reporter of The Independent, was killed when a bus crashed his motorcycle in Dhanmondi area on Friday.

Journalists from different media houses under the banner of Crime Reporters Association of Bangladesh (CRAB) brought out a procession from its Segunbagicha office yesterday.

After the procession that paraded different areas of Segunbagicha and Paltan, the protestors held a rally in front of the press club around 12:00pm suspending traffic movement on the road.

The journalists said they would stage a demonstration in front of secretariat if the shipping minister and the officer-in-charge (OC) of Dhanmondi Police Station are not removed by Tuesday morning.

OCMohammad Moniruzzaman charged batons on the journalists on Friday when they were demonstrating at the accident

CRAB President Akhtaruzzaman Lablu and Secretary Isaraf Hossain spoke at the rally. Earlier, Dhaka Reporters'

Unity (DRU) held a meeting at its auditorium commemorating its member Bibhas. DRU and CRAB leaders

demanded exemplary punishment to the driver of the killer bus and compensation to the family of Bibhas Saha. They also demanded

naming the road, on which Bibhas was killed, after Bibhas Das.

PM wants vibrant ties with Myanmar

Prime Minister Sheikh Hasina yesterday said her government was keen to build vibrant relations with neighbouring Myanmar in the backdrop of its changing political situation.

She said Dhaka greatly gave value the importance of strengthening relations with Yangon as the country was the first stepping stone for Bangladesh to build bridge with South East Asia.

Hasina said this when outgoing Ambassador of Myanmar in Bangladesh U Min Lwin paid a farewell call on her at Gono Bhaban in the capital.

PM's Press Secretary Abul Kalam Azad said Hasina congratulated the envoy for his valuable contribution during his stay in Dhaka to improving the bilateral relations between the two countries.

Expressing satisfaction over the settlement of long-standing demarcation of the maritime boundary issue, the premier said Bangladesh was willing to forge stronger relations with Myanmar for greater interests and welfare of the people of two countries.

She referred to the excellent historic

relation, bondage, cultural traditions and people-to-people interactions and common aspirations saying direct road and rail connectivity would give a tremendous boost to trade opportunities between the two countries, Azad said.

Stressing the need for putting in place a multi- modal regional connectivity, Hasina said easy communication would facilitate boosting regional trade and strengthening cooperation in other areas of economy to alleviate poverty from South Asia.

Expressing happiness on recent revision of Air Service Agreement and inclusion of private sector airlines between Bangladesh and Myanmar, she hoped that direct flight between Dhaka/Chittagong and Yangon would resume soon.

She appreciated the assurance of Myanmar president to resume repatriation of his country's Rohingya refugees living in two camps in Bangladesh for the last two decades and called for expeditious action in this regard.

Hasina also expressed her government's interest to enhance cooperation with Myanmar in energy sector saying Bangladesh was keen to import surplus hydro-electric power from Rakhine and Chin states of Myanmar at mutually convenient rate.

She urged the Myanmar government to remove policy barriers to import more Bangladeshi pharmaceuticals and consider importing Bangladeshi products including RMG, electronic equipment, jute and jute products and leather goods. Hasina renewed her invitation to

Myanmar President Thein Sein and Madam Khin Khin Win to visit Bangladesh and hoped that the visit would take place shortly at a mutually convenient time.

The envoy praised the role and dynamic leadership of Hasina for overall development of Bangladesh and regional cooperation.

Ambassador at-Large M Ziauddin, PM's Special Assistant Abdus Sobhan Golap and Press Secretary Abul Kalam Azad were present on the occasion.

U Min Lwin has been assigned as Ambassador and Permanent representative of Myanmar to the Association of Southeast Asian Nations (Asean).

Qauder Mollah counsels end argument

The defence counsels yesterday completed their arguments on the petition seeking discharge of Jamaat-e-Islami leader Abdul Quader Mollah from the charges of crimes against humanity he is facing

After the lunch break, Abdur Razzaq, chief of defence counsels, resumed his arguments for the second day on the discharge petition.

Referring to the first count, Razzaq said there was no witness in support of the charge, which had been brought on the basis of a newspaper report, and the newspaper made the report quoting a 2007 book

the charge, the defence counsel said, quoting some news reports about the March 14 proceeding of Tribunal-1. As there is no witness, the charge could not be framed, Razzaq said and

appealed to the tribunal for not

accepting the petition.

He placed his arguments on all seven charges brought against the Jamaat assistant secretary general and sought discharge of his client from the charges.

The three-member Tribunal-2, headed by Justice ATM Fazle Kabir, fixed May 16 for recording the prosecution's reply in this regard.

Justice Obaidul Hassan and Judge M Shahinur Islam are two other members of the tribunal.

The chief defence counsel also placed his arguments against the prosecution's petition, which sought permission to make some correction, addition and omission of the formal charges.

Quader Mollah was not produced yesterday as per the tribunal's earlier direction.

BNP lawmaker Abdul Alim

The defence counsels of former BNP lawmaker Abdul Alim placed their arguments for second subsequent day yesterday, supporting their discharge petition, which was filed in response to the prosecution's prayer to indict the former minister.

As yesterday's proceeding began at 10:40am, Tajul Islam, one of the defence counsels of Alim, resumed his arguments referring to a website.

Prosecution documents show the website calls Abdul Alim a Razakar.

Tajul Islam said the website was built on March 23, 2009 in the USA, and it is not "dependable" and "authentic", as it is an individual's website. So it could not be used as a document, he said.

The defence counsel then went through the counts of crimes brought against the former minister and placed his arguments.

Tajul referred to the first count where the prosecution said Alim along with the Pakistani army and other auxiliary forces looted the house of a local Awami League leader in Joypurhat and then torched it on April 20, while the formal charges said the Pakistan Army came to Joypurhat on April 21.

"So how it was possible to commit such crimes on April 20", he asked. "The prosecution brings the allegation as it, by some way, wants to

implicate me [Alim]".

Tajul yesterday completed his arguments on 13 out of 28 incidents of crimes allegedly committed by the lawmaker, who had been elected three times.

The tribunal adjourned the case proceeding till today.

Alim, who is facing 74 charges of crimes against humanity, was present in court yesterday.

Meanwhile, the International Crimes Tribunal-1 recorded the crossexamination of Investigation Officer Mohammad Helal Uddin, the 28th and last prosecution witness against Jamaat-e-Islami Delawar Hossain Sayedee, for the eighth day yesterday.

resume today.

The Jamaat Nayeb-e-Ameer was produced before the court. He is facing 20 specific charges of crimes against humanity that he allegedly committed during the Liberation War of 1971.

QUICK PURCHASE OF ESSENTIALS TCB exempted from PPA for three years

Trading Corporation of Bangladesh (TCB) was exempted from the obligations of Public Procurement Act for three years so that the state agency can buy essential commodities quickly from local and global markets to keep their prices stable.

A commerce ministry official said TCB took initiatives to procure edible oil, sugar, lentil, gram, onion, milk powder and dates on an emergency basis to keep market prices stable during Ramadan, starting in July.

The commerce ministry, in its proposal, said TCB, in the current fiscal year, will purchase 75,000 metric tonnes (MT) of sugar, 50,000 MT of refined and 5,000 MT of crude soybean oil, 5,000 MT of lentil and 2,000 MT of gram.
