#### UP member shot dead

A gang of criminals shot dead a union parishad (UP) member in Khan Jahan Ali area of the city on Sunday night. The deceased is Manzur Shikdar, 40, a member of Giratola Union Parishad in Sadar upazila. Son of Haris Shikdar of Matamdanga village in the union, Manzur came under attack near Srinath School while he was returning home in the area at around 10:30pm. He was rushed to Khulna Medical College and Hospital where the doctors declared him dead.

## Man gets life for killing wife

A court here yesterday sentenced a man to life imprisonment for killing his wife. The convict is Zafar Ullah, 40, son of Abu Taher of Dubba village in Sonagazi upazila. The court also fined him Tk 50,000, in default he is to suffer another three months in prison. According to the prosecution, Zafar strangled Jaheda Akhtar, mother of two children, for dowry on May 11, 2008. Later, victim's brother filed a case accusing Zafar. After examining the witnesses and records, Additional District and Sessions Judge Mohammad Harunur Rashid pronounced the verdict.

## Boy drowns

#### Fake revenue stamps seized

Acting on a tip-off, detectives raided the area at around 10:00am and arrested Habi along with the fake stamps.

#### 7 rescued from traffickers

His legs were tied while several injury marks found in his head, the SI added. Victim's son alleged that his uncle killed him to capture a disputed land.

# 12 houses burnt down in Bagerhat arson attack

# Jessore polytec closed sine die as BCL goes on rampage

The authorities closed Jessore Polytechnic Institute for an indefinite period as activists of Bangladesh Chhatra League (BCL) went on widespread rampage on the campus yesterday noon.

The BCL men got agitated as the authorities declined to meet their illegal demand for admission of five students to the institute.

"Some unruly students ransacked the principal's room, laboratory, workshops and the academic building as we did not meet their illegal demand for five students' admission," Prof Shamsul Alam, principal of Jessore Polytechnic Institute, said.

"We closed the institution for an indefinite period considering the safety of our students. A case will be filed

in this connection," he said. Eyewitness students and locals also gave evidence to BCL activists' widespread vandalism on the institute campus.

Asked about the matter, Anwar Hossain Bipul, general secretary of the BCL district unit, claimed that the offenders are not activists of Chhatra League.

# Angry people confine PDB engineers to office in Noakhali

Angry people yesterday confined two engineers of the Power Development Board (PDB) at their office rooms at maijdee Court protesting frequent load shedding in the area.

Several hundred people led by former lawmaker Fazle Elahi and Muktijoddha Commander Fazlul Haque Badal came to the local PDB office in a procession and confined Superintendent Engineer Anup Kumar Das Gupta and Executive Engineers Md Fakrul Alam in their rooms for an hour from 11:00am.

The protester said they get electricity for 3 to 4 hours a day and face load shedding after every 15 minutes. "We confined the engineers to mount pressure on the authorities concerned to resolve the problems," they said.

The engineers said the frequency relay equipment, set up at Sonaimuri, Chatkhil and Datterhat, is one of the reasons for disruption in power supply in the town. The power-hungry peo-

ple withdrew the programme after the engineers assured them of removing the equipment as early as possible.

# Four to die, one gets life for murder in Madaripur

The District and Sessions Judge's Court here yesterday awarded death sentence to four people and life term imprisonment to another on charge of killing a man in 2000.

Judge Bimol Chandra Shikdar passed the verdict, giving death sentence to Liakat Beldar, Ferdaus Khondokar, Alam and Sona Mia and life term imprisonment to Sima Aktar.

According to the case statement, Hafez Chokdar, son of Halan Chokdar of Chhilarchar village in Madaripur Sadar upazila, went to his in-laws' house at Dakkhin Crockchar village in Shibchar upazila on September 14 in 2000.

Hafez's wife Sima Aktar along with her lover absconding, court Liakat Beldar and three sources said.

other accomplices Ferdaus Khondokar, Alam and Sona Mia took Hafez for a boat ride in adjacent Arial Kha River on the night. Later, the gang strangled Hafez Chokdar to death, tied a sand bag with the body and

dumped it into the river. Four to five days after the incident, Ferdaus confessed to their crime when locals caught him and gave him a sound beating.

Consequently, police recovered the body from the river according to Ferdaus' confession.

The victim's father Halan Chokdar filed a murder case with Shibchar police station on September 21 in 2000.

# 4 commit 'suicide'

Four people allegedly committed suicide in Satkhira and Sylhet districts yesterday and the day before.

In Satkhira, three people committed suicide in Kaliganj and Sadar upazilas following a family feud, reports our correspondent.

They are Patu Mondal, 14, son of Gobinda Mondal of Berakhali village in Kaliganj, Sufal Mondal, 35, son of Jagadish Mondal of Kashinathpur and Aminur Rahman Khokon, 35, of Bharukhali villages in Sadar upazila.

Police said Patu killed himself by taking poison at their house on Sunday afternoon.

Sufal took poison at around 11:00pm and died on way to Satkhira Sadar Hospital at night, said locals.

Aminur hanged himself from the ceiling of his room yesterday morning.

Police recovered the body and sent it to hospital morgue for autopsy, said family members.

In Sylhet, a female bank official allegedly committed suicide in Kajalshah area of the city on Sunday, reports UNB. The deceased was identi-

fied as Kalpana Rani Das, 30, an officer of Shibganj branch of Agrani Bank Ltd and wife of Scholars Home teacher Jyoti Prakas Talukder of Noyagaon village under Dirai upazila of Sunamganj district.

Police said as Jyoti failed to reach Kalpana over mobile phone after repeated attempts in the afternoon, he rushed to their residence and found Kalpana hanging from the ceiling.

around 9:00am yesterday when Nuruzzaman and his men equipped with lethal weapons went to the land to harvest boro paddy. On receiving the news,

Mukul Chandra Mohonta and his supporters rushed to the spot and locked in a fierce clash with their rivals. At least 21 people from both sides were injured during the clash.

Being informed, police went to the village, dispersed the clashing group and brought the situation under control. They also picked up three people, including Mukul Chandra The trouble began at Mohonta, from the spot.

The supporters of Mohonta blocked the road and intercepted the police vehicle demanding release of the arrestees. As police charged batons

on the agitating men, they hurled brick chips on the cops, leaving four of them injured. They are subinspectors Mosharraf Hossain and Mofizuddin, and constables Mokhles and Gonesh Chandra.

Police have been deployed at the village to avert further incident.

No one was arrested in connection with the attack on police as of filing of this report at 6:00pm yesterday.
