#### FA charges Barton

Queens Park Rangers midfielder Joey Barton was charged by the English FA on Monday with two acts of alleged violent conduct during Sunday's Premier League match against Manchester City. The controversial player was sent off for elbowing Carlos Tevez and then kicked Sergio Aguero and tried to head-butt Vincent Kompany before being escorted off the pitch.

An FA statement said: "Following the player's dismissal in the 54th minute there followed two incidents involving Sergio Aguero and Vincent Kompany. "As Barton had already been dismissed, both of these incidents fell outside of the jurisdiction of the referee."



#### Tigers go to Harare on June 14

Bangladesh will arrive in Zimbabwe on June 14 to play a tri-nation Twenty20 series that also involves South Africa.

This was confirmed yesterday after the Bangladesh Cricket Board (BCB) approved participation of the national team for the triseries and also for BCB XI's tour of Trinidad for a T20 series against Trinidad & Tobago commemorating the island's Independence Day. The double-league com-

petition, which are not going to be internationals as Zimbabwe Cricket (ZC) could not arrange a television broadcast, will begin on June 18 after the Tigers play a 50-over practice game.

The tournament will be played at the Harare Sports Club; the final will be held on June 24.

The BCB XI will be off for the Caribbean on August 25 and will begin the T20 series against Trinidad from August 30. The second and third matches will be held on September 1 and 2 before they head back home the next day.

The Tigers' schedule for the matches in Ireland and Scotland in late July is expected to be announced in a day or two.

#### Clubs agree to release players

**BSWA BODY RULING SC** halts **HC** stay

The Appellate Division of the Supreme Court yesterday halted the High Court order that stayed the ad-hoc committee of Bangladesh Sports Women's Association for one month.

Chamber judge of Appellate Division Syed Mahmud Hossain passed the order after the National Sports Council challenged order of the High Court yesterday. Attorney General Mahbuby Alam, senior advocate A F MMezbahuddin Ahmed and three other deputy attorney generals argued before the court in favour of the National Sports Council while barrister Masood Reza Sobhan and Fatema S Chwodhury argued in favour of petitioner and former BSWA general secretary Mahfuza Akhter Kiron.

A High Court bench recently issued a stay order on the ad-hoc committee of BSWA for one month and served a show cause notice on the NSC as to why the respondents should not be directed to allow the elected executive committee of BWSA to assume its office and continue functioning till the completion of tenure.

"After the Supreme Court order, the ad-hoc committee of the BSWA has no bar on working and it will work as usual as before," said NSC law official Kabirul Hasan vesterday.

## Eng fear C'paul, pace

Shivnarine Chanderpaul's limpet-like batting and the express pace of Kemar Roach and Fidel Edwards will make West Indies dangerous opponents for strong favourites England in the three-Test series starting on Thursday.

England top the world rankings, six places above their opponents, and have not lost a home Test series since 2008, while West Indies have won only one of their last 18 Tests on English soil and just one of their last 10 series.

With conditions also likely to favour England's potent bowling attack, Darren Sammy's touring side face a daunting task going into the first Test at Lord's.

"They've got Ottis Gibson as a coach who worked within the England set-up for three

years, they've got two bowlers who can bowl very quick, they've got Chanderpaul who's a world-class batsman who's toured England on numerous occasions, so they're certainly a team we have to be very careful of," England fast bowler Stuart Broad told Sky Sports.

"We have to perform the way we can perform and should perform," he added.

"We won't look too far ahead in the series. We'll look to that first hour in the first Test match like we always do, try and set the tone and try and hit them hard."

England lost 3-0 to Pakistan in the United Arab Emirates this year, a series in which their top-order batsmen struggled badly for runs, and although they fought back to draw 1-1 in Sri Lanka there are still grounds for concern.

Captain Andrew Strauss scored the last of his 19 Test centuries 18 months ago and the SEE PAGE 17 COL 2

# Premier League tangle untied

May 31 restart; Abahani-Victoria replay

The Dhaka Premier Division Cricket WALTON League will resume on May 31 after a suspension of two months, Bangladesh

Cricket Board announced yesterday. The long deadlock ended after BCB

president AHM Mustafa Kamal's meeting with the six Super League clubs representatives at the board headquarters in Mirpur. Abahani, Mohammedan and Victoria

Sporting Club, the three clubs embroiled in the controversy, as well as Sheikh Jamal Dhanmondi Club, Old DOHS Club and GaziTank attended the meeting.

The stalemate came to an end after

Victoria agreed that their match against Abahani will be replayed and BCB boss could convince the clubs that it would be wise to leave behind the Victoria batsman Mohammad Yousuf's registration issue considering its legal

complications. The league was suspended since March 28 following the controversy over the legality of Yousuf's registration as Abahani refused to play in the second session for which Victoria were awarded two full points.

Abahani along with the other Super League clubs except Victoria protested the decision and took a strong stance as they were saying that they will not take part in the league until their demands including a fresh match between

Abahani and Victoria and reconstitution of the Cricket Committee of Dhaka Metropolis (CCDM) were fulfilled.

An emergency BCB meeting had called to break the deadlock from where a date was fixed (April 10) but the board ultimately failed to resume the league and after that the board formed a highpowered four-member committee but senior vice-president Mahbubul Anam, Gazi Ashraf Hossain, Sirajuddin Mohammad Alamgir and Dewan Shafiul Arefin could not find a solution.

The clearance papers of Mohammad Yousuf even gave to the government's investigative agencies to take the decision about the legality of it.

#### FIXING ALLEGATIONS Chess looking Suspension on 5

Indian IPL-ers

Five domestic Indian Premier League players were suspended from cricket on Tuesday after a sting operation by a local TV channel highlighted alleged fixing and corruption, sporting authorities said.

The Board of Control for Cricket in India (BCCI) said the players were handed provisional suspensions until its investigations into the allegations were completed.

The five -- TP Sudhindra, Mohnish Mishra, Abhinav Bali, Amit Yadav and Shalabh Srivastava -- are all first-class cricketers signed to various teams in the IPL.

"The BCCI has decided to suspend these players from all cricket till preliminary investigation into the whole episode is completed," IPL commissioner Rajiv Shukla told reporters.

The inquiry will be carried out by former police officer Ravi Sawani, who has previously served in the International Cricket Council's Anti-Corruption and Security Unit, Shukla added. Hindi-language India TV showed Sudhindra, of the

Deccan Chargers, allegedly agreeing to bowl pre-arranged no-balls in a local amateur match, while Kings XI Punjab player Srivastava was reportedly heard boasting he could do the same in the IPL.

Almost all the voters are expected to compete in the much talked about polls of the **Bangladesh Chess Federation** as 108 nomination papers were sold at the National Sports Council yesterday.

A total of 117 voters will elect a 25-member committee, comprising one president (govt nominated), four vice presidents, one general secretary, two joint secretaries, one treasurer and 16 members. The election is scheduled for March 31.

So far four panels -- led separately by GM Niaz Murshed, incumbent general secretary Mokaddesh Hossain, Gazi Tareq Saiful and Khandoker Kayesh -- are campaigning for the BCF polls and they have picked nominations for their respective committees, leaving
