submission of the chargesheet the court usually does not grant bail to them, which might have been the case with the opposition leaders, some legal experts told The Daily Star last night.

They also think the speedy trial law can be the other major reason behind sending the leaders into jail as the charges have been places under this act.

"Granting bail is an absoute discretion of the court,' barrister Tanjib-ul Alam told The Daily Star over telephone.

Tanjib said, "The fact that the charge sheet had already been submitted may have swayed discretion towards not granting bail.' The case was filed against

the leaders on April 29. The police submitted the charge sheet against them on May 10. The court order also came

A total of 45 leaders and workers of opposition 18party alliance, including BNP leaders Fakhrul, Mirza Abbas and Ruhul Kabir Rizvi Ahmed; and Liberal Democratic Party President Oli Ahmad, were accused in the arson case.

Four of the leaders, including Jamaat-e-Islami acting ameer Maqbul Ahmad, did not surrender before the court while police arrested BNP Joint Secretary General Ruhul Kabir Rizvi and six others earlier. BNP leader Mahbub Uddin Khokan obtained bail until May 20. At least 37 accused lead-

ers went to the High Court for bail in the arson case but the court asked them to surrender to the lower court within May 16, noting that the lower court would decide their fate. The accused leaders

surrendered before the court around 9:30am yesterday and filed 20 petitions for During the hearing, BNP

lawyer barrister Moudud Ahmed told the court that the 18-party alliance leaders and activists had been implicated in the case with the intention to politically harass them.

He said the government was trying to prevent them from being involved in active politics. He said three of the accused, including LDP President Oli Ahmad, were not even in Dhaka during the arson incident.

Moudud said the leaders posed no risk of jumping bail and hence they should be given bail.

Opposing the bail petitions, Metropolitan Public Prosecutor Abdullah Abu told the court that according to the law, the charges brought against Mirza Fakhrul Islam and others did not allow awarding bail. The charges brought against them were in the preliminary stage proved as the investigation officer of the case on May 10 pressed charges against them, he

Metropolitan Magistrate Mohammad Erfanullah sent the accused to jail around 1:45pm yesterday. He fixed May 21 for passing an order on whether it would take into cognisance the charges against the accused.

The court in its order said the accused could not be given bail in view of the charges against them. It noted that the investigation officer had already pressed charges against them. It also said the charges had preliminarily been proved.

The pro-BNP lawyers and the BNP leaders and activists who gathered in and outside the court went berserk after the court passed the order. They chanted slogans demanding their unconditional release.

At one stage, police charged truncheons on the demonstrators that left the 10 people injured.

Of the injured, pro-BNP lawyer Hossain Ali Khan was moved to Dhaka Medical College Hospital from National Medical College Hospital as his condition deteriorated.

Security was strengthened in and around the court premises prior to the surrender of the opposition leaders.

However, BIWTA Chairman Shamsuddoha Khondkar was stuck to the decision for eviction and asked the team to remain prepared.

Shah Cement Industries Ltd, a concern of Abul Khair Group, has built the largesize jetties almost in the middle of the river for landing and shipment of their products, said Khondkar, adding that landing stations must be set up within the river foreshores.

He said they arranged the eviction drive in line with a 2009 High Court verdict that ordered to free rivers from encroachments.

"We will not retract until our goal of freeing the river is achieved," said the BIWTA chairman.

However, as the chairman insisted, the eviction team finally stayed back with the ship in the river somewhere

away from the jetty site. The secretary said, "The drive was suspended following a negotiation between the minister and the com-

pany representatives." Differing with the BIWTA chairman, he said it was an unresolved issue of Landing and Shipment Charge (LSC) for using the river foreshores and that was why the eviction drive was arranged.

The company assured that they would pay it soon,

he said. Khondkar said, "The owner earlier held several meetings with the minister in this regard and made commitments; but did not keep the pledges."

According to competent sources, the company had dues worth Tk 11 crores as LSC since 2004.

As served with a notice five years back, the company filed a writ petition with the High Court that stayed effect of the notice and asked the company to pay Tk 10 lakh every year.

Despite several attempts, no official of Shah Cement at Dhaka sales office and Chittagong head office could be contacted for comments. The employees who received the calls said the officials were not available at office.

die everyday," Erken said. He recommended that

women do not have their first child until the age of 20 and this be strictly regulated by law in the country. Statistics show 20 mothers

die each day in the country while giving birth.

The youth population structure in Bangladesh is as follows: 34 percent of the population are under the age of 15; 60 under 30 years and 80 percent under the age of 45, Dr Ahmed Al-Kabir from Training and Management (RTM) International said.

Around half of the youth are female and so if they can be kept healthy, they will be healthy mothers, he added.

SM Ashraful Islam, additional secretary, Ministry of Health and Family Welfare said, "The government's strategy is to strengthen the healthcare system. At present, we have 8,000 facilities where mothers can receive antenatal and neonatal care.'

"Our main challenge is the lack of resources, particularly human resources; for instance, there are 400 vacant posts for anaesthetics in rural areas now," he pointed out.

Islam said there were only 133 anaesthetists working in the public sector.

Doctors are not willing to work in the rural areas because they find it downgrading, he said.

Mothers-in-law in rural areas also prevent young mothers from availing existing facilities, preferring babies to be delivered at home, he added.

Other speakers said transportation issues must be addressed at the same time as there are many hard-toreach areas in the country where women simply cannot access the facilities.

"Poor people are almost never treated well at the medical facilities," said Dr Kausar Afsana, director (health) of Brac.

"A warmer attitude towards them will encourage them to avail the facilities, she suggested. Dr Morsheda Chowdhury, senior programme manager
