**INVITATION FOR BIDS FOR**  
**Design, Supply, Erection, Testing and Commissioning of 132kV Double Circuit Underground Transmission Line Replacing Existing Tongi-Mirpur 132kV Transmission Line (T#47 to T#52) at Rajuk Uttara 3rd Phase Project on Turnkey Basis. Contract No.: PGCB/132kV/UGTL/UTTARA:**

- The Power Grid Company of Bangladesh Ltd. (“the Employer”) invites sealed bids from eligible bidders for Design, Supply, Erection, Testing and Commissioning of 132kV Double Circuit Underground Transmission Line Replacing Existing Overhead Line at Uttara on Turnkey Basis as defined in the bidding document (hereinafter referred to as “the Works”). Details of the scope of work are specified in the bidding document.
- The Works include:
  - Design, supply, delivery, installation, testing & commissioning on turnkey basis of 132kV underground XLPE cable transmission line (approx. 2km) from tower no 47 to tower no 52 of Tongi – Mirpur 132kV transmission line at Uttara 3rd phase project. The line is to be built by 132kV underground XLPE cable, cable straight through joint & accessories, cable termination equipment & accessories, underground optical fiber cable, Optical fiber termination/ jointing equipment & accessories etc.
  - Supply, delivery, installation of Terminal tower and termination gantry.
  - Dismantle existing towers, conductor, insulator, hardware fittings etc. and deposit to near by PGCB’s store.

International Competitive Bidding will be conducted in accordance with Single Stage Two-Envelope bidding procedure and is open to all bidders from eligible source countries.
- Bidders shall meet the following minimum requirements along with other requirements as mentioned in the bidding documents:
  - Bidders (In case of Joint Venture, any one of the partners, who have at least 20% share in the Joint Venture of this Project) must have project management experience of at least one (1) turnkey project as contractor (Contract amount should not be less than United States Dollar 1.5 million) outside their own country within the last fifteen (15) years as on the date of opening of technical proposals. The partner in charge in case of Joint Venture shall meet not less than 51% and each partner of the Joint Venture shall meet the amount at least their proportion of share mentioned in their JV agreement of the minimum criteria given above item (b)(i) & (ii).
- The Works under this turnkey contract shall be completed within 9 (Nine) months from the effective date.
