## HC order on allegation today

The High Court yesterday fixed today for passing an order on the allegation against a joint district judge and three others of occupying "a former Hindu zamindar's palace" at Nawabganj in Dhaka.

During the hearing of a rule, the court asked the four to appear before it further today in connection with the allegation. The court issued the suo moto rule on May 10 following a report published in the Daily Sun under the headline

"Zamindar palace is judge's palace now!" The four, who will have to appear before the court today, are: Abul Hossain Khandker, the then joint district judge of Feni, who is now attached to the ministry of law, his brothers Abul Kalam Khandaker, and Abu Ashfaq, also a local

BNP leader and chairman of Nawabganj upazila, and their uncle Hashem. They appeared before the HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Jahangir Hossain

Selim yesterday as per the court's May 10 order. They told the court through their lawyer that they were not

involved in occupying the land. The court said that Abul Hossain was somehow involved in

grabbing the property, since its house was named as Joj Bari (Judge's house), and the truth behind has to be unearthed. Thana Nirbahi Officer (TNO) of Nawabganj Mirazul Islam

Ukil, also appeared before the bench. He, however, will not need to come to court today as per court order.

Prime Minister Sheikh Hasina inaugurates multimedia classrooms in 1,000 schools and teacher-led contents by pressing a computer button at her office in the capital yesterday.

## 1,000 multimedia classrooms start journey

Prime Minister Sheikh Hasina yesterday said the country had made good progress in its efforts towards building 'Digital Bangladesh' during the last three years as pledged in the ruling party's election manifesto.

"We've achieved many successes to this end," she said, while inaugurating through videoconferencing from her office the multimedia classrooms and digital academic contents developed by teachers.

Hasina said the education system had made a step forward towards the digitalisation goal with the inauguration of 1,000 multimedia secondary and primary school classrooms across the country.

The premier opened the multimedia classrooms in 1,000 schools and the teacher-led contents by pressing a computer button.

She expressed the hope that 'Digital Bangladesh' could be built much ahead of 2021 if the present trend of digitalisation continues.

Hasina said, "Only the information technology can quickly reach the multipurpose flow of development to the grassroots level at a minimum cost."

She said multimedia classroom was the digital version of teaching method, which was widely used in the developed world. The government was attaching priority to ICT education and all books up to secondary level had been transformed into e-books which were also helping the expatriate students, she added. She said the teachers were the main medium of

reaching knowledge to the learners and they were playing an important role in building an educated nation with digital knowledge. Hasina called upon the private sector to come

forward so that multimedia classrooms could be established in all educational institutions of the country very fast. She asked the teachers to get habituated with

the use of ICT and learn the techniques of developing colourful academic contents and build the future generation enriched with science and technology-based education. Hasina called upon the teachers, students,

guardians and ICT experts to work unitedly to build a hunger- and poverty-free prosperous Digital Bangladesh and thus materialise the dream of Bangabandhu.

Terming the teachers and students the pioneers of the country's advancement, she said the

government would establish digital classrooms -at least one in 20,500 secondary schools and madrasas each - by next year.

"It'll help raise the standard of education to international level and remove the discrimination of teaching methods between rural and urban areas as the students could acquire latest knowledge of the world on various subjects to build themselves as worthy and skilled human resources to survive in the global competition," she added.

The premier said her government had already introduced e-governance, e-commerce e-health e-education, and e-service, and the scope of these services are expanding day by day.

Later, she exchanged views with the students of Reazuddin Pilot High School of Debidwar, Comilla, Monirampur Government Girls' School Jessore, and Tungipara GT Model High School of Gopalganj districts, and the teachers of Rangpur Teachers Training College.

Presided over by Primary and Mass Education Minister Dr Afsarul Amin, the function was also addressed by National Project Director of Access to Information Programme NI Khan and Group CEO of Orascom Telecom Ahmed Abu Doma.

The HC stayed process for holding the elections on April 26 for four weeks in response to a writ petition filed by four Supreme Court lawyers. It also issued a rule upon the authorities to explain why the process for holding the election on the basis of 'faulty' voter list should not be declared illegal.

The Appellate Division upheld the order of stay on May 7, asking the HC to dispose of the rule in 15 days.

The bench of Justice Hasan Foez Siddique and Justice Md Jahangir Hossain yesterday delivered the verdict after hearing on the rule.

Additional Attorney General MK Rahman, who appeared for the Bar Council, told The Daily Star that the Bar Council authorities had corrected and

updated its voters' list. His client would send the voters' list to the respective polling centres after finalis-

WAR CRIMES TRIAL

## Decision on indicting Kamaruzzaman June 4

The International Crimes Tribunal-2 yesterday fixed June 4 to decide whether it would indict Jamaat-e-Islami leader Muhammad Kamaruzzaman on charges of committing crimes against humanity during the 1971 Liberation War.

The three-member tribunal headed by Justice ATM Fazle Kabir set the date after both prosecution and defence concluded their arguments over the charges. During his 75-minute argument, prosecutor

AKM Saiful Islam said Kamaruzzaman was the "principal organiser" and shouldered the "commander's responsibility" of Al Badr (an auxilliary force of the Pakistani army) in Mymensingh during the Liberation War. Quoting from the statements of a prosecu-

tion witness, he said the accused was a commander of Al Badr and visited different Al Badr camps during the Liberation War.

Placing a news report of Daily Azad titled, "Fifteen other betrayers held", published on December 31, 1971, he said Kamaruzzaman was the 14th person on the list in the report.

"Those arrested at the time were not regular people," said Saiful. Earlier, the defence counsels claimed that the

showing that Kamaruzzaman shouldered the "commander's responsibility". They claimed that 195 Pakistani army per-

sonnel were the "principal accused" of war crimes and since they were released under a tripartite agreement reached by Bangladesh, India and Pakistan, their abettors or aides could

not be tried. In response, the prosecutor said the tripartite agreement was an executive decision, not an act. Any executive decision cannot deviate from any established law, he said.

The tripartite agreement was signed by Bangladesh, India and Pakistan in 1974 while the International Crimes (Tribunals) Act 1973 was enacted just a year earlier.

Kamaruzzaman, assistant secretary general of Jamaat-e-Islami, facing nine charges of committing crimes against humanity, was not produced before the court yesterday as per the court's earlier decision.

#### Case against Abdul Alim

Earlier on the day, Tajul Islam, a defence counsel of former BNP lawmaker Abdul Alim, completed his arguments in support of the petition seeking his client's discharge from the charges brought by the prosecution.

The tribunal adjourned case proceedings till prosecution had failed to provide documents 2:00pm today, following a time petition by the

prosecution.

Tajul said the trial was being held 40 years after the crimes had been committed only to suppress the opposition in a political atmosphere which has changed.

"Why were allegations not brought against other BNP leaders but your client?" asked Justice Obaidul. Afterwards, Tajul said there are similar allega-

tions against some ruling party leaders but they were not facing charges due to their political affiliation. When the judge asked the defence whether they had filed any application bringing charges

against the mentioned ruling party leaders, Tajul replied in the negative. On why they did not do so, Tajul said it was the
