FROM PAGE 20 Meanwhile, Nato summit, gathering more than 50 world leaders, opened in Chicago yesterday with a minute's silence for all those who have fallen in combat around the world.

Led by Nato chief Anders Fogh Rasmussen and US President Barack Obama, the summit leaders stood and bowed their heads as a uniformed US bugler played the taps.

It is the first summit of the 28-member North Atlantic Treaty Organisation on US soil in more than a decade, and comes as the 63-yearold organisation confronts shifting 21st-century realities and shrinking defence budgets.

Earlier, Nato chief vowed: "There will be no rush for the exits. We will stay committed to our operation in Afghanistan and see it through to a successful

German Chancellor Angela Merkel said yesterday, "Germany supports Nato's idea: We went into Afghanistan together and we want to withdraw from Afghanistan together."

Karzai comes armed with a firm demand for \$4.1 billion a year to fund his security forces after the pullout.

Washington is also hoping that Pakistani President Asif Ali Zardari will agree to reopen key Nato supply routes into Afghanistan closed in November after US air strikes killed 26 Pakistani

But the US-Pakistani talks on reopening vital supply routes for Nato forces in Afghanistan have stumbled over Islamabad demand to charge steep fees for trucks crossing the border, a senior US official told AFP.

Nishat and her fellow mountaineer MA Muhit were descending from Everest and were expected to reach the base camp today (Monday) and Kathmandu in five days. Nishat began her Everest expedition on April 9 from Kathmandu. She reached the summit on Saturday.

They are expected to arrive in Dhaka next Saturday or Sunday, said Enam Ul Haque, president of Bangla Mountaineering and Trekking Club (BMTC), which organised the expedition. He said, "Pemba Dorje Sherpa has informed me over the phone around 1:00pm today (Sunday) that Nishat and Muhit were physically well and that they were on the way to the base camp." Nishat's father Abdul

Mannan said, "It was one of the happiest moments in my life, when I heard that Nishat had succeeded in reaching the summit."

Mannan said Nishat had set another example that women could do everything, given a favourable environment. "Her success will urge all Bangladeshi women to come out of religious and social bigotries and prove their skills," he said. "We, from our family,

always encouraged and supported Nishat, which may be the key factor for her success," said mother Ashura.

Bangladesh Astronomical Association had arranged the programme at the peak of Keokradong, Bandarban, to encourage Bangladeshi youths in climbing Mount Everest. The programme was held on 29 May, 2003, and

exactly 50 years ago to that day **Edmund Hillary and Tenzing** Norgay had conquered Mount Everest.

Nishat as a member of the association had joined the programme. "Many youths were inspired by that event," said association member Mir Shamsul Alam Baboo, who was also there.

Joining BMTC in December 2003, Nishat continued trekking and taking part in expeditions with fellow members of the club.

In 2007, Nishat took part in a training programme in Darjeeling Mountaineering Club, said Baboo.

She climbed Singu Chuli peak of the Himalayas in 2008. She took part in Makalu Expedition-2009 jointly launched by Bangladesh and India. Nishat conquered Nepal-Bangladesh Friendship Peak in 2010 and took part in the Manaslu peak expedition in 2011. Musa Ibrahim was the first

Bangladeshi to conquer the Everest on May 23, 2010, while MA Muhit, now accompanying Nishat, is the first Bangladeshi who scaled Everest twice. Felicitations have started

Mahbub Uddin Khokon, another lawyer for the petitioner, told The Daily Star that different law enforcement agencies, including Rapid Action Battalion, have submitted separate reports to the HC, claiming that Ilias Ali is not in their custody since they have not picked up or detained him.

"We will give a reply to the High Court against those reports," he said.

Ilias Ali, former lawmaker and BNP organising secretary (Sylhet Division), along with his driver has been missing since the night of April 17 this year.

Padma bridge

He said the Malaysian government will submit a final proposal to Bangladesh at the end of this month on financing the bridge's construction work.

"The government will reach a decision in this respect to ensure the interest of the country," said Quader, also incharge of the railways minis-

He reiterated that the construction works of the much-talked about bridge will begin within the tenure of

the present government. "The government is committed to building the bridge," he said, hoping that the construction works will start in 10 months.

Construction of the Padma bridge became uncertain when the World Bank suspended its funding in the \$2.97 billion project in September last year alleging corruption in the pre-bidding

Since then, the government has been looking for alternative funding. On April 10, Bangladesh and Malaysia signed a memorandum of understanding (MoU) as Kuala Lumpur showed its interest to finance the bridge construction.

During yesterday's meeting, the communications minister and the ADB executive director also discussed the progress of implementation of ADB-funded projects in Bangladesh.

good reputation, and claimed that there was no evidence of graft or any financial irregularities in the organisation.

The NGO said Save the Children abruptly terminated a contract with it without giving any reasons. It said Padakhep failed to know the reasons despite frantic efforts and blamed Save the Children and The Global Fund for not showing or sharing any reason for the termination. The rejoinder, signed by

executive director of Padakhep, Iqbal Ahammed, said Padakhep did not accept the termination and took the matter to court. It said Padakhep did not

submit any fake documents; it rather provided all relevant documents, necessary papers and bank information. "As an 'A' category performer and reputed organisation in Bangladesh, Padakhep gave access to all information," says the rejoin-

The NGO said Bangladesh Country Coordination Mechanism (CCM) meeting endorsed its termination from a project subject to the submission of a report on legal process and status of Save the Children to the CCM.

It termed one-sided the sharing of evidence of financial irregularities of Padakhep by Save the Children Country Director Michael McGrath at the CCM meeting and McGrath's claim that Padakhep denied Save the Children and The Global Fund access to relevant information. McGrath's claims should have been validated, said the rejoinder.

Padakhep also contradicted the report that the issue of their corruption dominated the CCM meeting and that the health minister was well aware of it.

The NGO said there was no evidence that Brac and the United Nations Office for Drug and Crime Control (UNODCC) also stopped funding it and termed the information reported in The Daily Star false and motivated, adding that Brac had phased out its activities while the UNODCC project was completed as per contract.

Padakhep is now implementing a project of ICDDR,B, which is also funded by The Global Fund, the rejoinder says.

It rejected the charge of influencing the tender evaluation committee members or government officials for

being qualified for the project. It also denied that its Executive Director Iqbal Ahammed avoided talking to The Daily Star and said the reporter called him once, but did not make any contact later.

Finally, the rejoinder ridiculed the comment of Iftekharuzzaman, executive director of Transparency International, Bangladesh, saying the matter of corruption of Padakhep is pending in the arbitration tribunal and any early comment on it is a contempt of court.

Any person or organisation hostile to Padakhep should not be a news provider, it added. **OUR REPLY**

The Daily Star report was based on official documents of the health ministry and Save the Children, which said that the health ministry recommended Padakhep for a World Bank funded project, though Save the Children terminated the NGO from The Global Fund on charges of corruption and fraud. The Daily Star also talked to some health ministry officials who confirmed those allegations.

The Daily Star obtained some documents that show the financial documents Padakhep submitted to bank and Save the Children were not the same.

During an investigation last year, a team from the Office of the Inspector General, an independent unit of The Global Fund, found in Padakhep financial irregularities done through forgery of documents. The team sought the

intervention of the health secretary as Padakhep denied access to their bank documents. They found gross irregularities when they got the genuine bank documents from National Credit and Commerce Bank. The Global Fund

informed Save the Children about it which led to the termination of Padakhep. The Global Fund did not inform Padakhep of it as it was a highly confidential matter. Save the Children issued a termination letter to Padakhep on September 25, 2011, saying the NGO had failed to meet one or more terms and conditions of a sub-grand agreement.

The CCM meeting held at the health ministry on February 2 this year had an extensive discussion on Padakhep where the country director of Save the Children shared some evidence regarding financial irregular-

ities by the NGO. He informed the meeting that Save the Children had the right to terminate the contract within 60 days and ceasing of all activities of the project.

Inquired by the health secretary, Michael McGrath explained that the termination had not been arbitrary and it was legally valid. The CCM suggested all to be more vigilant in monitoring financial issues and develop a system of transparency and accountability to prevent irregularities.

"The CCM endorsed the phased out plan of Save the Children and terminating all agreement with Padakhep. The CCM also asked for a formal written communication from Save the Children on their legal process and status," the minutes of the meeting show.

The health minister and the health secretary were well aware of Padakhep's corruption. Fund Portfolio Manager another project funded by Artashes Mirzoyan of The Global Fund wrote a letter to the minister informing him about Padakhep's irregularities and misconduct.

McGrath also shared concrete evidence of the irregularities with the minister and the secretary.

"We have substantial evidence that the NGO misappropriated the Global Fund money through creating fake bank documents and invoices," Michael McGrath, Save the Children country director, told The Daily Star last week.

He said The Global Fund would release a report soon revealing how Padakhep had misappropriated its funds.

"As per sub-grand contract, Save the Children can terminate the NGO for any reason through giving a 60 days' notice," said McGrath.

Safiuddin was born in

1922 in Calcutta (now Kolkata), India. He was a student of Calcutta Government School of Art and graduated from the institute in 1942. After Partition in 1947, Safiuddin left Calcutta for Dhaka, where he found himself caught up in a movement to set up the first art institute in the then East Pakistan. He was a friend and colleague of Shilpacharya Zainul Abedin. He was one of the founders of Dacca Art College (now the Faculty of Fine Arts, University of Dhaka). From 1948 to 1979, he served as head of the department of printmaking at the institution.

Safiuddin's art has mainly focused on rural panorama, pastoral life, landscapes, memories of 1971, Language Movement, floods and other natural calamities as well as Santal Safiuddin was particu-

engraving. He devoted much time to a single piece of painting and print. Black is the predominant aspect in most of his works. From the beginning, the maestro had been experimenting with black and its mysterious tones, tenors and layers of colour. Most of his colours look muted and the message has always been one of peace and harmony as he envisaged it for the future. His paintings are technique-oriented as well. Line is another essential part of his paintings. His lines have created a distinct language where one can learn about his perseverance, longing and devotion

Famous for his reserve and soft-spoken nature, Safiuddin lived the life of a recluse, away from the crowd and noise that accompany fame, which he never hankered after.

Some of his outstanding achievements as a young artist included the President's Gold Medal (1945) by Academy of Fine Arts, Calcutta; first prize in the category of black and white in International Contemporary Art Exhibition, New Delhi (1946); first prize in the category of black and white (etching and drawing) in Inter-Asian Art Exhibition in New Delhi (1947) and Patna Maharaja's Gold Medal (1947). He was a proud recipient of the Ekushey Padak and Shadhinota Puroshkar.
