Everest Academy in support with North Alpine Club, Bangladesh (NACB) and Dhaka University Mountaineering and Adventure Club (DUMAC) organised the fest at DU's Physical Education Centre.

"Bangladesh reached new height in the global arena by being the 67th Everest conquering country on May 23, 2010", said

Musa, who touched the peak of Everest on that day.

Within a period of two years, the number Bangladeshi Everest conqueror has increased to three, Nishat Majumder, the first Bangladeshi woman to have conquered Everest on May 19.

Another mountaineer, MA Mohit, who accompanied Nishat, is the first Bangladeshi, who has reached Everest summit twice. Musa congratulated Nishat on her suc-

cess, saying, "I am really delighted to know that Bangladeshi woman has scaled Everest.

"I hope to see such more feats of women in both professional and personal life", said Musa, also the general secretary of NACB and director of Everest Academy.

100 Yaba tablets

An army officer, who is also a doctor of Dhaka Combined Military Hospital (CMH), was arrested with 100 Yaba tablets in the capital's Dakkhinkhan area on Tuesday night.

Capt Basharul Anam Ahmed, 31, was detained in front of Choiti Garments in the area around 11:00pm. He hid the Yaba tablets in a cigarette packet.

Personnel of the Department of Narcotics Control (DNC) led by Deputy Director (DD) Ali Aslam of Dhaka Metro made the arrest after searching the car of Capt Basharul.

Abu Taleb, additional director of DNC, said after the arrest, some army officials had asked the DNC officials to hand him over to them so that they could take departmental action against

"But their demand could not be met, as police already recorded a case with Dakkhinkhan Police Station", he said.

Lokman Hekim, officerin-charge of Dakkhinkhan Police Station, said DD Ali Aslam filed the case against the detained captain under the Narcotics Control Act last afternoon.

Ali Aslam said the detained army official was produced before the court. "But I am not sure whether

Contacted, Shahinul Islam, director of the Inter Services Public Relations (ISPR), told The Daily Star that the army authorities were aware of the incident and they would take stern punitive measures departmentally.

Army officer arrested with HC questions cancellation of JP leader's candidacy

The High Court has questioned the legality of a section of the Representation of the People Order (RPO), under which the candidacy of Abul Kashem from Tangail-5 constituency was cancelled and Mahmudul Hasan was declared elected.

The Election Commission (EC) on May 7 declared BNP leader Mahmudul Hasan elected MP from the constituency, and cancelled candidacy of Jatiya Party MP Abul Kashem, who was elected from the constituency in the parliamentary

polls on December 29, 2008. The EC issued a gazette notification

to this effect on that day in line with a Supreme Court verdict that declared Kashem disqualified for contesting the 2008 polls, as he had been a loan defaulter then.

The HC on Tuesday issued a rule upon the CEC, secretary to the EC, and Mahmudul Hasan to explain in 12 days why the Section 51(2)(b) of RPO, 1972, which empowered the election tribunal to declare any other candidate securing second highest vote as returned, should not be declared contrary to the constitu-

In response to a writ petition, the HC bench of Justice AHM Shamsuddin Choudhury Manik and Justice Jahangir Hossain also asked them to explain why the notification issued by the EC declaring Mahmudul winner and canceling Kashem's candidacy should not be declared illegal.

Twenty five voters of Tangail-5 constituency have jointly filed the writ petition with the HC, challenging the legality the section of the RPO and EC's gazette notification.

They said Kashem had got 147,152

votes, while Mahmudul secured 72,805 votes in the 2008 polls. But the EC had declared Mahmudul elected under the RPO section, which is against the democratic spirit ensured in the constitution. In the democratic system, the

representatives will be elected by the majority votes of people, they said.

Assistant Attorney General Yeadia Zaman, who represented the government, told The Daily Star that the HC bench expressed the parliament speaker would not administer oath to Mahmudul Hasan till the hearing of the rule was finished.

Manusher Jonno Foundation, along with other organisations, will form a human chain before Jatiya Press Club today, protesting the attacks on Adivasis and demanding punishment of the culprits.

Mystery shrouded the death of a Rajshahi University (RU) teacher, who was punished for sexual harassment of a female student, at his in-law's house in Upashohor of the city on Tuesday night. The deceased, Zulfikarul Amin, a lec-

turer of the marketing department, used to

stay in his father-in-law's residence with

his wife Mamtaj Akter Shompa and her family members. Shompa told The Daily Star that around 12:00midnight on Tuesday, he went out of

At 1:00am, he fell into a drain beside Nahar Academy at Upashohor in an unconscious state. Later, pedestrians rescued him and took him to his in-law's residence, she said.

the house to buy medicine on a bicycle.

After 19 hours later around 8:00pm on Tuesday, he was taken to Rajshahi Medical termed the death "mysterious."

College and Hospital (RMCH) where doctors pronounced him dead.

Locals alleged that members of his father in-law's family did not arrange "proper treatment timely" that led to the death.

"He was not taken to the hospital though he was unconscious on Tuesday. When he died at night, his in-laws took him to RMCH to conceal the incident of death," a teacher of marketing department told The Daily Star requesting anonymity.

His wife said he might have died of "high blood pressure" as he was penalised for sexual harassment of a female student of the department.

"He might have taken a medicine named 'Analogue" to recover from the high blood pressure," she added. Teachers and students of the department

BNP hiding Ilias, the court granted him bail or sent him to jail". Contacted. Shahinul Tuku tells JS body

Neither the government nor the law enforcers can do anything if BNP continues hiding their missing leader M Ilias Ali, State Minister for Home Shamsul Haque Tuku told a parliamentary body yesterday. A Jatiya Party lawmaker, who was present in the meet-

ing at the Jatiya Sangsad Bhaban, told The Daily Star quoting Tuku.

Earlier on April 19, the state minister said that his ministry had already directed every law-enforcing agency and detective wing to find Ilias. However, he defended the law enforcers and the government itself following sharp criticisms from members of the parliamentary standing committee on the home ministry

Ilias Ali, 51, a BNP organising secretary and a former MP, and his driver went missing in the wee hours of April

Mujib-ul-Haque Chunnu, MP of Jatiya Party raised the issue of Ilias's disappearance and enquired Inspector General of Police Hassan Mahmood Khandker of the progress made in tracking down Ilias.

"You [IGP] have to inform us [lawmakers who are also members of parliamentary panel] about the progress made and inform us categorically whether you have failed or not," Chunnu quoted himself to the reporters as saying.

The IGP informed the committee that no "desired progress" on the much-talked about issue has been made so far.

At one stage of the conversation between the IGP and committee members, Shamsul Haque sided with the IGP saying, "What can the law enforcement agencies or the government do if Khaleda Zia or BNP keeps him in hiding," meeting sources quoted Tuku.

Maj Gen (retd) MA Salam, chief of the House body then asked the IGP and Rapid Action Battalion Chief to find Ilias within the shortest possible time.

"People want to know about this sort of sensational incidents. So the law enforcement agencies should perform more efficiently," the chief told the reporters at a briefing. In the spate of criticism by the committee members, the IGP assured that his forces were trying their level fessor delivered his best to track down Ilias Ali's whereabouts.

The committee members also blasted Director General of Rapid Action Battalion Moklesur Rahman for Rab's failure to find killers of journalist couple Sagar-Runi who were brutally assassinated early February at their home.
