Delay in implementation South Africa keen emboldens miscreants

Observe civil society, indigenous community leaders

Civil society and indigenous community leaders yesterday reiterated their demand for the implementation of the Chittagong Hill Tracts (CHT) peace accord as the delay is encouraging miscreants to oppress indigenous people.

They also demanded exemplary punishment of all people who oppressed indigenous people at different times in the country.

The leaders were addressing a human chain organised by Sammilito Nagorik Samaj before Jatiya Press Club in the capital, protesting the recent incidents of torture, murder and rape in the CHT region.

Gonoforum Presidium Member Pankaj Bhattacharya said, "The miscreants are becoming stronger, strengthening their oppression on indigenous people with the delay in the Chittagong Hill Tracts peace accord's implementation." "It is not acceptable that grenade

attacks are carried out in the hills while you (the government) keep army rule there. What is the point in keeping the army there?" he asked. Bangladesh Adivasi Forum General

Secretary Sanjib Drong announced that a grand rally will be held at the Central Shaheed Minar within a few days to protest against the oppression.

Prof Mesbah Kamal of the history department of Dhaka University blamed a portion of the government for the delay in the accord's implementation. He also urged all to term the indigenous community"indigenous and human".

Workers' Party of Bangladesh President Rashed Khan Menon blamed bureaucracy for the delay. "They (bureaucrats) are dilly-dallying so that the accord is never implemented."

In recent months, two indigenous minor girls were violated, four indigenous farmers were murdered and an indigenous student died in a grenade attack. Bangladesh Adivasi Forum, Jatiya

Adivasi Parishad, Bangladesh Adivasi Odhikar Andolon, Manusher Jonno Foundation and Brotee expressed solidarity by participating at the programme.

Brotee Chief Executive Officer Sharmin Murshid and Manusher Jonno Foundation Executive Director Shaheen Anam also spoke at the programme.

WAR CRIMES TRIAL

Discharge plea for Mojaheed

At the International Crimes Tribunal-2, the defence for Jamaat-e-Islami Secretary General Ali Ahsan Mohammad Mojaheed yesterday sought his discharge from charges of crimes against humanity committed during the Liberation War.

The defence made the plea in response to the prosecution's prayer to indict the former minister of a BNP-led government. Mojaheed is facing 32 charges of crimes against humanity, allegedly committed during the Liberation War.

Nazrul Islam, one of Mojaheed's counsels, yesterday read out the discharge petition.

The three-member tribunal led by Justice ATM Fazle Kabir and members Justice Obaidul Hassan and Judge M Shahinur Islam adjourned the proceedings until May 29, following a time prayer from the defence.

Nazrul said Mojaheed was merely a 23-year-old student leader then and during the war he spent his days in panic and fear.

"The accused petitioner has no connection with the army officials or high ups of the then Pakistani government," said the counsel, adding, "He [Mojaheed] had no connection with the Razakar, Al Badr, Al Shams or Al Mujahid [collaborator forces] as well," Nazrul said.

The defence counsel claimed that on many occasions, the Jamaat and its then student wing Islami Chhatra Sangha had criticised the attack of the Pakistani army on Bangalees during the war.

"The media were censored totally during that time [during the Liberation War]. In many cases, what was published was not stated and what was stated was not published," said the defence counsel, quoting a statement of his client provided with the discharge petition.

"Especially, the statements of Jamaat and Islami Chhatra Sangha protesting the oppression of the military junta never saw the light of day," he added.

However, the prosecution alleged that the Jamaat leader through speeches and media statements provoked his followers to "eliminate" freedom fighters and pro-liberation Bangalees in 1971 and the prosecution mentioned 12 such incidents in their formal charges.

The defence said charges should not be framed against its client as the prosecution brought the charges on insufficient legal basis and inadequate evidence. The defence said if the trial was held, it would result in an unfair trial by domestic

and international standards. Nazrul said up to October 31, 1973, a total 37,471 people were put on trial under the Collaborators (Special Tribunal) Order, 1972 but the prosecution failed to provide any evi-

dence that Mojaheed was one of the 37,471. When the defence counsel completed reading out the petition, the tribunal chairman drew his attention to page 55

Say BNP leaders

Referring to the comment the PM made on Wednesday to remain alert against those who want to grab state power through unconstitutional means, they said the PM must take the responsibility if any such incident does occur. They also said the PM should run the country in a demo

cratic way and stop incidents of killing and disappearances so that none can get the chance to implement the "minustwo formula".

Dhaka city BNP organised the rally before the party's central office at the capital's Nayapaltan demanding release of the opposition leaders including BNP acting secretary general Mirza Fakhrul Islam Alamgir and city Convener Sadeque Hossain Khoka.

BNP standing committee members Moudud Ahmed, Tariqul Islam, Rafiqul Islam Mia and Nazrul Islam Khan and Joint Secretary General Mohammad Shahjahan spoke at the programme with city BNP Member Secretary Abdus Salam

in the chair. Prime Minister Sheikh Hasina, during a meeting with professionals on Wednesday, said those behind the "minustwo formula" were still active but the opposition BNP failed to understand it.

Two workers electrocuted

A female worker of a plastic factory at Kamrangirchar and an electrician in Tejgaon were electrocuted in two separate incidents in the capital yesterday.

At Kamrangirchar, the victim was identified as Shefali Begum, 30, wife of Abdur Rahim and a worker of Parvez Plastic Factory.

While working, a part of Shefali's saree got entangled with a running floor fan. When she tried to untangle her saree, her hand came into contact with a snapped wire, Abdur Rahim told reporters.

Co-workers rushed her to Dhaka Medical College Hospital (DMCH) where she succumbed to her injuries, he added.

Meanwhile, electrician Ripon, 20, was electrocuted while welding at the ground floor of a four-storied building at West Tejturibazar of Tejgaon. Workers rushed him to DMCH where he was declared dead.

Verdict on 4 'fake' law instts starts

The High Court yesterday started delivering the verdict on a writ petition filed for taking appropriate action against the fake institutions which are giving law degree certificates to

students without legal authority. It fixed May 27 to resume the reading out of the verdict.

The ministry of education has found four fake educational institutions in Dhaka, which have no affiliation with any university of the country or abroad, but giving law degrees for money, petitioner's counsel Manzill Murshid told The Daily Star.

The institutions are Chancery Academy of English Law at Dhanmondi, International University at Uttara, North American University at Lalmatia and Victoria University at Dhanmondi.

Manzill said he had prayed to the HC to direct the government to find out all such fake institutions across the country, shut them down, and award punishment.

One Rehana Ali, who took admission to Chancery Academy of English Law, earned a certificate of law degree last year from the institution after she had given Tk 10 lakh to the authorities of the fake institution.

Bangladesh Bar Council, the authority that gives licence to the country's lawyers to practice law, has refused to allow her certificate, saying that the institution is not authenticated by any legal authority. She filed the petition with the HC in August last year, saying

that Chancery Academy of English Law is running in the name of Williamsburg University of United Kingdom, but she could know from the ministry of education and the British Council in Bangladesh that there is no institution in the UK by the name of Williamsburg University.

The HC bench of Justice Tariq ul Hakim Justice Md Faruque yesterday started delivering the verdict.
