but it was yet to be resumed, they said. Prime Minister Sheikh Hasina, during her recent visit to Sylhet, also assured the people of resuming the flight. But any announcement did not come as yet due some vested quarters in the authorities, they alleged.

Their other demands include stopping of passenger harassment by the immigration police and others at the Osmani International Airport and allowing flight operations of other airlines on the route.

Govt wants good relations with media: Azad

Information and Cultural Affairs Minister Abul Kalam Azad yesterday said the government would do everything to narrow differences with the media. "The government wants to maintain

cordial relations with the media by removing differences, whatever they are", he said. Speaking at a seminar on "Three years of

the grand alliance government, mass media and right to information", he also expressed disappointment over media's role. The government achieved tremendous

success in the fields of health, education, food, agriculture and communication, but those were not properly highlighted in the media, he said.

Bangladesh Awami League (AL) organised the seminar at the capital's Institution of Engineers, Bangladesh (IEB).

President of the AL advisory council, Advocate Syed Rezaur Rahman, presided

over the seminar while AL Publicity and Publication Secretary Nuh Alam Lenin gave the welcome address.

The minister also said the government of Prime Minister Sheikh Hasina believed in the free flow of information and passed the "Right to Information Act" in the first session of the Jatiya Sangsad (JS) in 2009.

Terming the present government as media-friendly, he said the government had given licences to 15 private satellite television channels and 14 community radio stations after coming to power.

Speaking on the welfare of the journalists, Azad said the government had established a welfare fund for journalists with Tk 50 lakh, which would start functioning from the current fiscal year.

BADC takes possession of its 0.33 acre land

The Bangladesh Agricultural Development Corporation (BADC) in Chittagong took possession of its 0.33 acre of land with the help of the district administration in Sholoshahar area of the port city yesterday.

Sources said Mohammad Musa and Mohammad Harun, two businesspersons, took lease the land from the BADC in 2003 for commercial purposes. They built a community centre, Woodland Park, on the land in the same year.

BADC Chief Engineer Ashraf Ali Khan said: "The BADC cancelled the lease in 2009. Later, the two businessmen filed a writ petition with the High Court in this regard." The court dismissed the

writ petition a few days ago, he added. "The BADC authorities issued them notice to hand

over the possession of the land but the lease receivers declined to do it," he said. However, Salah Uddin,
