prepare herself for further trekking. "I will rest here for a few days," she said. Wasfia, who scaled the

Everest on Saturday, dedicated her feat to Bangladeshi Women. In a status update on facebook in the early hours of Tuesday, she wrote,This is to the countless women around the world who are breathing day & night to break our 'manmade' shackles..."

In July 2011, she launched her expedition to scale the seven highest peaks in seven continents under a campaign "Bangladesh on Seven Summits" to celebrate 40 vears of the country's independence. She started her Everest expedition on March 26 this year.

On October 2 last year, she became the first Bangladeshi woman to reach the highest peak in Africa, the Uhuru peak of Mt Kilimanjaro at 5,895 metres in Tanzania. She scaled Mount Aconcagua in Argentina on December 16 last year.

Meanwhile, Nishat and Mohit reached Lukla--about 2,860 metres above sea level--on Sunday. They were scheduled to reach Kathmandu on Monday morning but flights to Kathmandu have remained suspended since Saturday due to bad weather.

"It's a journey of only 30 minutes by air. If we make our way on foot, it will take seven days," Mohit said over the telephone yesterday.

On reaching Kathmandu, it would take at least two days to complete all procedures including receiving certification from Nepal's Tourism Ministry on their climb, he added.

A reception to honour Nishat and Mohit organised by the Bangladesh embassy in Kathmandu yesterday was postponed, he said.

A statement from Plan Nepal yesterday said the organisation would host a reception today (Wednesday) to honour Nishat and Mohit if they could reach Kathmandu by then. The Bangladesh chapter of Plan International co-sponsored Nishat and Mohit's expedition under their campaign "Because I Am a Girl".

The Plan Nepal statement quoted Nishat telling them on Monday over the telephone, "I want to tell every girl: nothing is impossible for them to do. If they want to, they can achieve anything they like. If a woman like me can climb Everest, any girl can do anything they set their mind on doing."

Nishat made history as the first Bangladeshi woman to scale Mount Everest on May 19. Mohit is the first Bangladeshi to have scaled the mountain twice and from both sides.

Sources said the girl and her parents went to the magistrate's court yesterday on her father's motorbike around noon to file a case yers in front of the court against her husband in connection with torturing her for dowry.

As they were entering the court premises, two subinspectors of Kotwali Police Station--SI Zaman and SI Jahangir--stopped them at the gate. The officers claimed that the bike was a stolen one and there was a case against the father.

They seized the keys of the bike. The father refuted the police claim and protested their action.

As the girl's father protested, the two policemen beat him up and took him inside the Police Club near the gate of the court.

When the girl protested the police action against her father, police took the girl and her mother inside the club as well.

After she was let go from the club, the girl went in front of the court around 3:30pm and told lawyers and journalists what had happened and sought their help.

She said the policemen took her to a different room where they hugged her from behind, kissed her on the neck and touched her inappropriately despite her vigorous protests and attempts to get away from them.

She said a senior officer discovered what was going on, rescued her and her parents and ensured safe passage for them out of the club.

Court correspondents of media houses were listening to what she had to say about the incident when the law enforcers swooped on the newsmen and lawyers. They charged truncheons on them allegedly on the directives of Salauddin Khan, officer-in-charge of Kotwali Police Station, and Assistant Commissioner Rajib Al

Masud, sources claimed. The police assault left six newsmen and four lawyers injured.

After a two-hour exchange of fire, several hundred fishermen carrying sticks attacked the robbers, who then started fleeing. The fishermen caught five robbers and beat them dead. They also injured two other robbers. Police took the two

injured in their custody. Jasimuddin, a fisherman, said they participated in the police raid to get rid of the robbers for their survival.

He also sold his food company's dealerships for Tk 4-5 lakh each and pocketed nearly Tk 10 crore from around 200 people. Masud rented an 8,000

square-foot office at DH Tower at Panthapath and created a website branding FALGUNI INT as a leading industrial conglomerate in Bangladesh. Posted on the website was the message that FALGUNI INT had assumed a leadership role in food and bever-

ages, cosmetics and toilet-

ries, infrastructure develop-

ment, power, high-tech agro products, automobiles and IT sectors. "He [Masud] has cheated a lot of people. Most projects mentioned on the website are false and meant to deceive people," said Atiqur Rahman, who was director (production) of Falguni Food

and Beverage. He along with the company's deputy managing director resigned when they came to know that Masud had been cheating people.

The workers of the factory did not even get their salaries, said Atiq.

When The Daily Star managed to contact Masud over the phone after several days' attempt, Masud said he had shut the office as there was no government policy on MLM business. The developments relating to Destiny had also led him to make the decision.

He admitted that 20,000 people were made members of FALGUNI INT and he had sold a financial package of Tk 21,000 to each member.

"I did not take money from all members. My rivals are saying this." Masud claimed that he had paid back many of the members.

Interestingly, Masud claimed that he had been cheated by another MLM company, Revnexx, last year. He had invested more than Tk 50 lakh in that company

Harisa Parveen, a kindergarten teacher in Joydevpur, said, "I deposited Tk 73,000, most of which I had borrowed, in October last year with the MLM company that promised me a double return on deposits in six months. I received only one instalment of Tk 21,000 from the company."

She found the Revnexx office closed after a few months. Like her, Rowshan Ara,

Begum, Shafiqul Islam Khan, Ziaur Rahman, and Lutfar Rahman lost money to the MLM company that existed for less than a year. The main culprits -- Pintu Biswas and Rony of Revnexx -

- have been on the run after swindling people out of Tk 150-200 crore, according to aggrieved investors. Global Guardian Network (GGN) introduced MLM

business in Bangladesh in 1998. Later, some GGN highups, including Rafiqul Amin, left the organisation and formed Destiny in 2000. Destiny's exponential growth encouraged many vested quarters to get involved in MLM business.

According to the office of Registrar of Joint Stock Companies and Firms, 70 MLM companies have been registered with it, but no new companies were given permission to run MLM business in the last one year.
