In the next fiscal year, the government may allow people to whiten black money from any fiscal year, provided that the sources of undisclosed money are mentioned.

The official said the government is under pressure from some influential quarters to give scope for legalising black money -- income obtained illegally or not declared for tax purposes.

As the Asia Pacific Group on Money Laundering, a global anti-money laundering body, strongly opposes giving scope for whitening illegal money, the government is now weighing how to give amnesty for black money without disregarding its international obligations, said

the ministry official. Seeking anonymity, an official of the National Board of Revenue, told The Daily Star last week that none had taken the opportunity in the current fiscal year to legalise undisclosed money by investing in the stockmarket or infrastructure bonds.

Civil society members, economists and even the business community oppose giving such scope. But time and again successive governments have given the opportunity under pressure from some vested quarters.

During the BNP-led government's tenure between 2001 and 2006, the then finance minister Saifur Rahman in a TV interview on the night before a budget day said no scope for whitening black money would be given under any circumstances. But the next day he placed the budget keeping provision for legalising undisclosed money. Despite the fact that

governments have given amnesty for black money almost every fiscal year since 1975, not a big amount of undisclosed money has been legalised each year and the state has not earned much revenue from it. According to NBR statis-

tics, Tk 12,996 crore has been whitened and Tk 1,368 crore has been collected as taxes since 1975. The present government

has been giving amnesty for black money from its first year in office. In fiscal year 2009-10, it allowed whitening undisclosed money in four sectors, where 1,923 people legalised Tk923 crore.

facing 23 specific charges of crimes against humanity committed during the Liberation War, had sought bail so that he could join the parliament session.

On May 27, Salauddin's counsel Ahsanul Haq Hena submitted the bail petition along with another petition seeking arrangements for the lawmaker to be at the Jatiya Sangsad if he was not awarded bail.

The three-member tribunal led by Justice Md Nizamul Huq rejected this petition too and asked Salauddin to contact the authorities concerned for this special arrangement.

"The law does not allow issuing bail to the accused," Justice Nizamul said, adding that the tribunal could grant bail if an accused suffered from serious health and physical problems.

Interestingly, Salauddin's party, the BNP, continues to boycott parliament proceed-

On May 27, defence counsel Hena told the court that Salauddin was served "presidential summon" to join the current parliament session.

ProfAnisuzzaman. On May 14, during crossexamination of Prof Anisuzzaman, Fakhrul called him a liar and the court had warned the counsel about using this word against the professor.

However, Fakhrul, after the court proceedings, called Prof Anisuzzaman a liar before the media.

The tribunal issued the notice up on him the next day. In response to the notice, Fakhrul submitted a prayer in which he apologised unconditionally and sought mercy.

"We want that you put one line in your application. It will help you and us to pass order," said Justice Nizamul.

The defence counsel later wrote in his application that it was unintentional and he regretted calling Prof Anisuzzaman a liar. In the order, the tribunal

said Fakhrul was a highly educated and skilled lawyer and if action against him were taken, it could cause him considerable amount of problems.

"Considering all these the tribunal exonerates him," said Justice Nizamul. Salauddin's defence

yesterday asked for adjournment of proceedings an hour ahead of lunch saying that they needed time to consult with the accused. The tribunal rejected their

plea but allowed them to consult in the court without adjourningthe proceedings. Later, counsel Hena cross-

examined prosecution witness Sirajul Islam.

The proceedings of the case were adjourned until June 4.

WITNESS CALL-BACK

Jamaat-e-Islami leader and war crimes accused Delawar Hossain Sayedee's defence counsel Mizanul Islam yesterday told Tribunal-1 that the defence would bear the expenses of accommodation, meals and transport of three prosecution witnesses it wants to cross-examine again.

Five killed in **US** shooting

A gunman killed five people in a shooting spree in Seattle on Wednesday before turning the weapon on himself as officers closed in, police

The shootings shocked the northwestern US city that has now seen as many murders this year as it did in the whole of 2011.

The suspect, identified by the Seattle Times as 40-yearold Ian Stawicki, is believed to have entered Cafe Racer Espresso, near the University of Washington, at around 11:00am, where he shot five people with a pistol, two of whom died at the scene.

Bedouins abduct 2 US tourists in Egypt

Two US tourists have been kidnapped in Egypt's Sinai peninsula by Bedouins protesting the arrest of one of their tribesmen on a drugs charge, a security official said yesterday. The tourists were abduc-

ted late on Wednesday near the resort of Dahab on the Red Sea, the official said, adding that talks were under way in a bid to secure their release. The two men were driving

near the Dahab resort when they were stopped by a group of Bedouins at a makeshift roadblock and taken to an unknown location, she said.
