Eight hurt in BNP factional clash

At least eight activists of BNP were injured in a factional clash in Azimpur area of the capital yesterday.

The clash ensued around 11:00am before the party chairperson Khaleda Zia reached Battola in the area to distribute food among the destitute on the occasion of 31st death anniversary of the party founder and late president Ziaur Rahman.

Lalbagh police said supporters of Azam commissioner found a lot of posters and festoons containing portraits of Nasiruddin Ahmed Pintu at the programme and asked Pintu's supporters to remove them. It triggered a clash that left at least eight people from the two groups injured.


A 10-member media team from the country will leave for India today to visit the Tipaimukh Dam project in its Northeastern state of Manipur.

Industry fined Tk 31 lakh

The Department of Environment (DoE) yesterday fined a dyeing industry Tk 31 lakh for releasing untreated chemical and wastes into the river Turag in Pagar area of Tongi in Gazipur.

The DoE also directed to shut the industry, Everway Yarn Dyeing Ltd.

A team of DoE, led by its director Mohammad Munir Chowdhury, conducted the drive, said a press release.

The team found that the industry has released 9.8 lakh litres untreated chemical mixed waste recently as its Effluent Treatment Plant (ETP) was out of order.

The industry has been running without the clearance from the DoE since 2009.

People's collective efforts vital in curbing corruption

Eminent citizens tell TIB anti-graft national convention

People's collective courage is vital in fighting corruption. Otherwise, the menace of corruption, according to eminent personalities, may turn Bangladesh into a failed state.

The observation came at the closing session of an anti-graft convention organised by Transparency International Bangladesh (TIB) in the capital vesterday.

The TIB organised the two-day national convention of its youth movement, Youth Engagement and Support (YES), and Sachetan Nagarik Committee (Sanak) on the theme 'Youth in Anti-corruption Movement: Achievement and Challenges', at Bangabandhu International Conference Centre.

Every citizen is obliged to take

his or her stance against corruption, as the responsibility for corruption and rights violation committed through the state machinery eventually lies with the people, said advocate Sultana Kamal, chairman of the TIB trustee board.

"Otherwise, we will be treated as a timid nation in history," she said, adding that a nation must struggle hard with people's collective strength to achieve its goal.

Mahfuz Anam, editor of The Daily Star and treasurer of TIB, said a state with corruption in any of its three fundamental pillars --- the legislative, the executive and the judiciary --- gravely affects the lives of all citizens, a condition that might lead to the collapse of the entire state system.

He termed the youth movement absolutely central to fighting corruption and securing the country's future.

Prof Abdullah Abu Sayeed, noted litterateur and a trustee member of TIB, said all the corrupt and terrorist elements of the country thrived around the two political streams.

People constitute states and pay taxes to run the government for security of their lives and property. But the state machinery in Bangladesh indulges in plunder and rights violation, abusing both pen and weapon, he added.

Citing an example of police extortion on commercial vehicles passing through the Mirpur embankment in broad daylight and the recent police atrocities on women and journalists, he said law

enforcers breaking laws should be handed down punishment five times higher than that in the case of an ordinary citizen.

The people of Bangladesh, as TIB estimates, have to pay Tk 9,500 crore every year due to corruption at public offices, he added.

Selina Hossain, noted litterateur and secretary general of TIB, said the state and its resources belonged to the people, who must protect those against corruption and plundering. The price hike of essentials by business syndicates had far-reaching implications, those that could create a malnourished child population, as parents failed to buy the required food for

It is crucial to undertake all the challenges of the anti-corruption movement, she added.

Dr Iftekharuzzaman, executive director of TIB, who conducted the discussion, said the organisation had dedicated this year's YES convention to the late Samson H Chowdhury and late Prof Muzaffer Ahmad, two former chairmen of the TIB trustee board.

Prof Ahmad was a guru of the anti-corruption movement in Bangladesh, he said.

The event was aimed at reviewing what the young volunteers have done and learned in fighting against all-pervading corruption relentlessly at educational institutions, hospitals and local government bodies.

Around 2,200 of a total of 5,500 YES members from across the country attended the biennial event, armed with the slogan that

FM for dialogue to cut security threats

Foreign Minister Dipu Moni yesterday observed that all security challenges can be addressed through dialogue and appreciation of nations' perspectives to ensure peace and stability in the South Asian region.

She said this while addressing a special session on 'South Asia's growing security threats' at the 11th Shangri La Dialogue in Singapore yesterday, said a foreign ministry press release.

China's influence in Asia and the Pacific, India's aspiration as a major international player, anti-Western sentiments carried by the Islamist groups has turned South Asia into a strategically important region today, she said.

Dipu Moni said a sense of grievance sets in whenever peripheral countries cannot fetch the maximum from the global economic system or feel exploited by the capitalist economy; and this is affecting international security by various means including the rise of extremism.

Food and water scarcity, energy deficit, carbon emission, sea level rise, environmentally induced displacement, bearing the brunt of emissions from industrialised economies by the small countries like Maldives, Bangladesh, Bhutan and Nepal have also constituted a major security threat to the present day world, she observed.


