TRANSPORT STRIKE IN RANGPUR DIVISION

Woes of passengers mount on day two

Road communications from Rangpur division with other parts of the country remained suspended for the second day yesterday as the transport workers continued their 72-hour strike.

Buses and trucks stayed off the roads yesterday as on Tuesday, causing immense sufferings to passengers on at least 72 routes from eight districts.

Passengers frantically looked for buses at different terminals in the districts but failed to avail any since start of the strike on Tuesday.

People crowded Rangpur rail station as an alternative means, but many of them failed to collect tickets because of extremely long queue.

A number of passengers

alleged sale at tickets on black market while others said that the authorities shut down ticket counters without any prior notice.

Admitting pressure for tickets from a large number of passengers, the officials said they had to fine 19 on Tuesday on charge of traveling without tickets. As no truck moved to

other parts of the country perishable items remained struck at wholesale markets causing heavy losses to growers and traders.

The transport workers of Rangpur division went on a 72-hour strike on Tuesday to press for their 10-point demand.

Rangpur divisional unit of Motor Sramik Federation called the strike on May 29 to press home its 10-point demand, including a ban on human haulers like Nasimon, Karimon and Bhutbhuti and battery-run auto-rickshaw on high-

The demands of the federation also include withdrawal of 'false' cases filed against Rangpur District Transport Workers Union General Secretary MA Majid and removal of illegal markets from the highways.

They also demanded a hike in wages of transport workers and providing appointment letters and an end to various irregularities, including illegal toll collection by highway police.

The strike began in the morning after the local administration held an inconclusive meeting with the leaders of the transport workers on Monday night.

200 roadside trees felled in Thakurgaon

Unscrupulous people have cut down around 200 roadside trees in Haripur union under Haripur upazila of the district and sold them to locals.

On receiving a complaint from a ward councillor of the union on Saturday, upazila LGED officials led by Engineer Abdus Samad raided at different places of the union on Sunday and Monday and seized only 38 logs of the felled trees.

Locals alleged that Kutub Ali and Mobarak Hossain, close aides to Haripur Union Parishad (UP) Chairman Mominul Islam, felled around 200 trees, including fruit-bearing mango, jackfruit and guava trees, along Bottali-Khathaldangi Road recently, saying that the chairman gave them permission to cut down the As the duo failed to show

the villagers any paper relating to the chairman's order, they informed ward councillor Shahjahan Ali of the matter.

Being informed, Shajahan Ali went to the area on Saturday and saw Kutub Ali, also a supervisor

of Road Infrastructure Development Project-21, and his associate Mobarak felled the roadside trees and sold many of them.

"When they offered me Tk 20,000, I informed upazila LGED Engineer Abdus Samad of the matter," the ward councillor told this

Contacted, UP Chairman Mominul Islam said he did not issue any such order to cut down the trees. "It's a conspiracy to tarnish my image," he added.

"LGED planted the trees on Bottali-Khathaldangi Road in Haripur upazila

under Road Infrastructure Development Project-21 in 2001.

Engineer Abdus Samad said they issued a show cause notice to project supervisor Kutub Ali and filed a General Diary (GD) with Haripuir Police Station.

Erosion by Jamuna renders 350 families homeless

Victims form human chain in Gaibandha

Erosion by the Jamuna River has rendered at least 350 families of Hasil Kandi village under Shaghata upazila homeless in the last one week.

Demanding steps to stop the erosion, a few hundred char people of the village formed a human chain on the bank of the river on

The erosion hit people took shelter on nearby embankment amid miseries without any food and drinking water.

Amjad Hossain, a farmer at the village, said the river devoured a large number of

homesteads, croplands and trees. A bamboo spar con-

structed by the villagers last year on self-help basis to protect the area from erosion has also been washed away by the river, he added.

Around 500 more families are facing serious threat due to rise of water level in the river, said other villagers. A number of educational

institutes, a mosque and vast croplands in the village may also be engulfed by the river soon, they said. Besides human chain, the

villagers arranged special prayers to get relief from the river erosion.

While visiting the affected areas, this correspondent

found scores of people, fearing further onslaught of the river left there homesteads and took shelter on the embankment.

Victim Saiful Islam said the erosion devoured his cowshed while he was shifting the homestead to a safer place.

Abdur Rouf, former chairman of Shaghata union, said they informed the Water Development Board (WDB) authorities about the matter but to no effect as yet.

Contacted, Gaibandha WDB executive engineer said they have sent a letter to the higher authorities, seeking fund to tackle the situation.

UP chairman arrested

Police arrested an acting upazila parishad chairman on charge of assaulting deputy general manager of Rural Electrification Board (REB) in

Sensing danger, the DGM signed the papers.

The 'long march' would start from Rangpur Zila School ground at about


10:30am and parade the main roads in the town, said Sharfuddin.
