in revenue collection and increases the number of taxpayers," FBCCI President AK Azad said in his reaction to the proposed budget.

"Thus the government can reduce its dependence on the banking system," he said at a press conference at the chamber's office in Dhaka.

The government's target for borrowing from banks was set at around Tk 19,000 crore for the current fiscal year, but within the first half of the year borrowing exceeded Tk 21,000 crore, leaving the private sector entrepreneurs in a liquidity crisis, he said.

"The tendency of this type of borrowing should stop," Azad said.

For the upcoming fiscal year, the government's target for borrowing from banks is Tk 23,000 crore.

The FBCCI also opposed the scope to legalise undisclosed money as the government has taken a stance to allow money whitening through the payment of a certain amount oftax.

The trade body said the scope will give rise to uneven business practices.

Azad also said raising tax at source to 1.2 percent from the existing 0.60 percent on all kinds of exports would have a negative impact on overseas trade as export earnings were already on the decline due to some internal and external factors.

Moreover, the proposed rise in the "advanced and loan fund" for the government employees to Tk 19,568 crore from its current amount at Tk 9,413 crore would also have a negative impact on liquidity in banks, he said.

"Considering all these factors, we think it will be difficult for the government to achieve the targeted GDP (gross domestic product) growth at 7.2 percent," Azad said.

However, the FBCCI welcomed the move of giving Tk 100 crore for the development of women entrepreneurship.

The trade body also appreciated the government for reducing duty on import of equipment for setting up effluent treatment plants at export-oriented industries and the proposal of imposing zero duty on import of capital machinery.

The FBCCI also hailed the proposal to continue zero duty on import of food stuff, fertilisers, seeds, cotton and medicine.

MCCI: BUDGET BOLD BUT CHALLENGING

The Metropolitan Chamber of Commerce and Industry (MCCI) termed the proposed budget a bold and challenging one, and said financing and implementation of the budget would be a tough job for the government.

The huge bank borrowing to meet deficit financing will result in crowding out of private sector credit growth and cause liquidity problems for the primary dealer banks and financial institutions.

"There must be a cap on the government's borrowing from the banking sector and instead, it should improve its ability to use foreign funds, thereby reducing bank borrowings to that extent," MCCI said in a statement.

The chamber also expressed disappointment over the continuation of legalising undisclosed income, saying the scope will discourage the real taxpayers.

The MCCI said the budget, which was framed against the backdrop of the resources,"it said. global economic slowdown, attempts to stimulate rural growth, mobilise revenue, support infrastructure development, and deliver social safety measures.

The budget also focuses on high growth rate of GDP, export, import, remittance and investment, the chamber said, adding that special attention was needed on specific measures to contain inflation.

The MCCI said the government has taken a bold step by increasing the subsidies for agriculture, electricity, petroleum and state-owned enterprises, in spite of advice of the International Monetary Fund to cut subsidies.

"To maintain a sustainable growth, we have no alternative choice at hand."

However, the chamber expressed its concern whether the existing level of subsidies would be manageable and sustainable within the ambit of the current budget, with a high deficit financing component. The chamber urged the

government to be cautious about the volume of subsidies and its sustainability, and to formulate a sound subsidy policy for effective implementation. It said the government's

implementation capacity needs to be developed to accelerate the development of human resources and energy sectors.

policy needs to be immediately announced with appropriate mining methodology identified to harness a valuable resource the country already possesses."

The MCCI expressed dissatisfaction at increasing advance income tax on export earnings for all exporters, and for not raising the minimum ceiling of personal income tax.

The chamber opposed the move of imposing new

tax on mobile phone bills. It also expected a cut in the

corporate income tax rate. The chamber, however, hailed the government for giving priority to the development of the energy sector. "Any significant growth of the economy is inconceivable without high and sustained growth of energy and hence, it deserves high priority in the allocations."

"Top priority should also be given to exploration of gas. The way the energy crisis is progressively increasing, the country needs to be able to harness the domestic

On the targeted GDP growth of 7.2 percent, the chamber said: "We strongly feel that as time progresses, this should be raised to 8 percent in the upcoming years in order to transform Bangladesh into a middleincome country."

FICCI STRESSES STRONG MONITORING

The proposed budget is somewhat bold and challenging against the backdrop of global economic meltdown, said Foreign Investors' Chamber of Commerce and Industry (FICCI). The chamber said the

budget would require further improvements in governance and strong monitoring to achieve the goals.

It said in a statement that the projected borrowing from the banking sector would impact private sector credit and might cause a liquidity problem. FICCI also expressed

concern over the imposition of 2 percent tax on mobile phone bills, saying the move would affect around nine crore people.

The chamber, however, appreciated the initiatives in the energy, power, communication and education sectors. It also hailed measures meant for improving the stockmarket by reducing tax on merchant banks "In particular, the coal and brokerage houses.

CCCI FOR RAISING TAX-FREE INCOME LIMIT

Chittagong Chamber of Commerce and Industry (CCCI) urged the government to increase the tax-free income ceiling to Tk 3 lakh from Tk 1.80 lakh now.

The income tax threshold should be increased considering a number of reasons such as soaring inflation, rise in livelihood expenditure and depreciation of the taka against the dollar, said CCCI President Morshed Murad Ibrahim in a statement.

He also said increasing the minimum income tax payable at individual level to Tk 3,000 from Tk 2,000 will have a negative effect on the general taxpayers.

Ibrahim, however, appreciated the government for "attaching top priority to human resources development, increased use of ICT at the government level and initiative to expand small and medium enterprises." He thanked the finance

minister for undertaking refinancing schemes through the Bangladesh Bank such as various tax rebates and easy loans for environment-friendly industrialisation. "Though an ADP of Tk

55,000 crore is adequately hopeful, it will be a tough challenge for the government to meet the Tk 52,068 crore budget deficit." It would be difficult for

the government to get Tk 18,584 crore from foreign sources, Ibrahim added. The CCCI president said taking loan of Tk 23,000

crore from banking sources -- out of the total Tk 33,484 crore needed -- would fuel inflation. "It will also reduce invest-
