Transport strike in Narail, Patuakhali

Transport owners and workers in Narail and Patuakhali went on strike on the internal routes of the districts yesterday.

An indefinite strike on all local routes in Narail district began yesterday to realise the demand for removal of Nosimon, Kariman, Bhutbhuti and Easy Bikes from the highways, reports our correspondent.

Transport services on Narail-Jessore highway and other roads of the district came to a halt following the strike.

Sufferings of hundreds of commuters including government and non-government officials and staffs, students and traders mounted as they frantically looked for alternative means of transport.

Magura Jubo Dal faction says 'no' to new committee

Demands its dissolution, declares Alal 'unwanted'

Aggrieved Leaders and activists of Magura Jubo Dal formed a human chain in Bhaina area of the town yesterday demanding immediate dissolution of the newly formed convening committee of the district unit.

They also held a rally at the venue with former organising secretary of Jubo Dal district unit Ashrafuzzaman Shamim in the chair.

The speakers alleged that central Jubo Dal President advocate Moazzem Hossain Alal approved the convening committee without consulting them. They declared Alal 'unwanted' in Magura.

Jubo Dal Magura municipality unit President Riadul Hakim Farhad,

former joint secretary of the district unit Tanjel Hossain, district Jubo Dal leader Abdul Kuddus, Joint Secretary of Magura district Jatiyatabadi Chhatra Dal (JCD) Mizanur Rahman Manik and district JCD Vicepresident Kamruzzaman Sumon addressed the rally.

Jubo Dal central committee declared its Magura district unit on May 29 with advocate Washikur Rahman Kallol as convener and Abu Sayeed al Mamun, Amirul Islam, Shahidul Islam Rupak and Ujjal Hossain as joint conveners.

Aggrieved leaders and activists rejected the committee and took out a procession in the town the following day. Led by jubo Dal district unit president Alamgir Hossain, general secretary Aminur Rahman Pikul and organising secretary Ashrafuzzaman Shamim, they paraded the main streets and burnt effigies of Central Jubo Dal President Moazzem Hossain Alal, Magura BNP President Kabir Murad, General Scretary Ali Ahmed Biswas.

They also accused BNP central leader advocate Nitai Roy Chowdhury, also hails from Magura, of dividing the BNP district unit and its associate bodies.

On June 1, the rival group attacked the BNP office at Shaheed Mintu Road and hacked Abu Sayeed al Mamun, joint convener of the newly formed Jubo Dal convening committee, and two others with sharp weapons.

'Stop activities of CHT land dispute body, withdraw Justice Khadem'

Leaders of Nirbachito Jumma Janapratinidi Sangsad (a platform for the elected representatives of Jumma people) have demanded cancellation of the hearing process of CHI Land Dispute Resolution Commission and withdrawal of the commission's Chairman Justice (retd) Khademul Islam Chowdhury.

They made the demands at a rally held on the premises of Sadar upazila parishad office in Khagrachhari town yesterday.

Chaired by Sarbauttam Chakma, President of Nirbachito Jumma Janapratinidi Sangsad and also the chairman of Panchhari Upazila Parishad, the rally was addressed, among others, by United People's Democratic Front (UPDF) leader Sajib Chakma, President of Khagrachhari Karbari Association Ranik Tripura, SecretaryofCHTJummaRefugee Welfare Association Santoshita Chakma Bakul and Nirbachito Jumma Janapratinidi Sangsad memberMilanDewanMonang.

The speakers demanded recognition of the traditional

land law of the hill people and amendments to CHT Land Dispute Resolution Commission Act 2001.

Terming the commission's hearing one-sided, they said a conspiracy is on to give legal recognition of those lands which were illegally occupied by the settlers from the hill people. They requested the gov-

ernment to stop what they said controversial activities of the commission until the amendments to the land commission act are made.

Hundreds of hill people, carrying banners and placards, joined the rally. They also took out a procession in Khagrachhari town and paraded the main streets.

Democratic Youth Forum a front organisation of United People's Democratic Front (UPDF) will besiege the office of Chittagong Hill Tracts Land Dispute Resolution Commission in Khagrachhari town at 10:00am today to press the same demands.

The forum announced the programme through a press release singed by its central office secretary Nikolas Chakma yesterday noon.

Schoolboy electrocuted

Hearing screams, family members rescued the boy and sent him to Jessore Medical College and Hospital in a critical condition where he died the following day.

Police recovered a beheaded body of a girl from Mogra River in Brojer Bazar area of Atpara upazila on Friday afternoon. The dead, Jahara Khatun, 20, of Katli area in the district town, was a call girl, said Salamuzzaman, officer in-charge of Atpara police station. Jahara went out from her residence on Wednesday night on receiving a phone call from one Nayan Mia, son of Abdur Rashid of Bogapara village and did not return home. Being informed by locals, police recovered the girl's body from the river at about 3:00pm and sent it to the hospital morgue for autopsy. They also arrested Nayan in connection with the incident.

The victim was identified as Uzzal Saha, 38, son of Mrinal Saha, of No. 2 Bankers' lane at Bagmara, reports a correspondent. Police quoted witnesses

as saying that Uzzal was

going to Zohora Khatun Kindergarten riding a motorbike to pick up his daughter Tanisha Saha, 6, from the school. When he reached near Rangdhanu Clinic and Diagnostics Complex at

around 10:30am, a gang

intercepted him. They hit

Uzzal with iron rods and

hockey sticks, leaving him critically injured. Locals rushed Uzzal to Khulna Medical College Hospital where he succumbed to his injuries at

around 11:30am. Family members alleged that Uzzal was killed by a gang of drug peddlers as he recently organised a campaign against their activities in Bagmara area.

Sahabuddin Azad, officer-in-charge of Sadar Police Station, said they were trying to unearth clues to the murder of Uzzal Saha.

Newsmen protest assault on colleague in Barisal

Barisal journalists staged a demonstration in the city yesterday protesting assault on one of their colleagues by a ruling party backed transport union leader and his men in the morning.

Kamal Sardar, joint secretary of Awami League backed District Road Transport Union, and his supporters swooped on Kazi Shamim, special correspondent of local daily Ajker Barta and former district correspondent of daily Janakantha, at C&B Road at around 11:30am.

Locals said Kamal and his men intercepted Shamim in

the area near his residence and locked in an altercation with him over publishing reports against him (Kamal) in the local daily recently.

At one stage, they manhandled Shamim. Hearing the news, leaders of Barisal Reporters Unity (BRU) rushed to the spot, rescued Shamim and took him to BRU office.

Local journalists later held a rally in front of the Ashwani Kumar Hall demanding immediate arrest of Kamal and his men for assaulting Shamim. They also protested recent attacks on journalists at different places of the country and demanded immediate arrest and punishment of the attackers.
