AFP said, according to government officials, a second wave of violence swept through remote villages early yesterday, as more Rakhine homes were torched, forcing villagers to flee to temporary shelters in Maungdaw town.

Security forces flooded western Myanmar yesterday to prevent further outbreaks of sectarian violence between Buddhists and Muslims which have left at least seven dead, according to state media.

Two government officials said armed Rohingya had burned Rakhine villages in the early hours of yesterday.

"They came from the neighbouring country by boats," one of the officials told AFP, speaking on condition of anonymity, hinting at Bangladesh.

Talking to The Daily Star, BGB chief Maj Gen Anwar Hossain rejected the allegation of the Myanmar official outright.

Myanmar, which considers the Rohingya as foreigners and not one of the nation's ethnic groups, has an estimated 750,000 Rohingya, living mainly in Rakhine,

According to Dhaka Ahsania Mission, around 28 percent of people are affected by health hazards due to smoking in restaurants.

administration ministry and the prime minister's public administration affairs adviser will discuss with all concerned in the bureaucracy and put the proposed law on official website to elicit public opinion on it.

After reviewing public opinion, the proposed law will be sent to a secretarylevel committee, and then to the prime minister for approval. If the premier gives the go-ahead, it will be placed before the cabinet, and finally in parliament to make it a law.

When enacted, the new law would facilitate use of expertise of local experts in different ministries and divisions, infusing dynamism in the civil administration.

Meanwhile, the move appears to have created dissatisfaction among senior officials in the administration. It would greatly limit their scope of going to top positions, they fear.

Talking to The Daily Star on condition of anonymity, some of the officials also said this move would encourage politicisation of the bureaucracy since the "experts" to be appointed in top positions would be picked up on political consideration.

Contacted, Agriculture Minister Matia Chowdhury, who is considered a top policymaker of the government, said the move to appoint experts was based on the needs of time. Many countries engage their experts in government work

Replying to a question, the minister ruled out politicisation of the appointment of experts in bureaucracy, saying those who want to help the government with their expertise would be considered for appointment, and not those who would sabotage the government step.

Matia said, "There will be more discussions on the proposed law and then a

The government now has to appoint a number of consultants from home and abroad in many sectors at a huge cost, she said. "If we appoint our local experts, we can gradually reduce dependence on consultancy. But to do so, we need to give the experts authority, and for this the government is planning to appoint them as secretary."

Referring to oil and gas there are many local experts in these sectors, who give suggestions to the government. But their suggestions are overlooked many a time since they do not have any authority to implement those.

She went on, "If we can give them [experts] responsibilities, why can't we give them authority?"

Bush's 43 percent favorable rating is the same as it was in 2010 in CNN polling, but is up from his mid-30's favorable rating

during 2009, his first year out of the White House. Former President Jimmy Carter, the one-term Democratic president who was election in 1976 and defeated in 1980, is viewed favorably by 54 percent of the public, with just three in ten seeing him in a negative

Bush's father, George HW Bush, gets a 59 percent rating, with 34 percent saying they have an unfavorable view of the first President Bush, who was elected to the White House in 1988.

Bush was defeated in his bid for a second term by Bill Clinton, who has a 66 percent favorable rating in the poll. Only 31 percent say they hold an unfavorable rating of Clinton. The former two-term Democratic president's favorable rating bottomed out in CNN polling at 51 percent in June of 2008, after Clinton took a very active role in advocating for his wife, then Sen Hillary Clinton of New York, in her historic battle with Sen Barack Obama for the

nomination. The CNN poll was conducted by ORC International, with 1,009 adult Americans questioned by telephone from May 29-31. The survey's overall sampling error is plus or minus three percentage

Tribal chief Issa Abdelmajid said the Toubou quarter of the town of Kufra came under shelling at 3:00am by the Libya Shield Brigade, former rebels under government control sent to quell previous ethnic fighting.

Abdelmajid said at least five of his people were killed and 10 wounded, and that a number of houses in the quarter had been burned.

The Centre for Policy Dialogue in its budget analysis found that more than 43 percent of total incremental revenue will be spent on interest payments. "It [interest payments] is

the outcome of the government's bank-based borrowing," said CPD distinguished fellow Debapriya Bhattacharya. Allocation for interest

payments is estimated to rise by 17.7 percent to Tk 23,302 crore in the coming fiscal year from Tk 19,796 crore in the outgoing year. And the interests on borrowing from domestic market will be Tk 21,604 crore in the coming year.

"Increased pressure of interest payments reduces the government's ability to respond to unexpected shocks," said Zahid Hussain, a senior economist at the World Bank in Bangladesh.

Echoing Bhattacharya, he said increased borrowing from the domestic market is mainly responsible for the inflated interest payments. "This [interest payment]

is non-discretionary expenditure. Once borrowed, it must be repaid." The average effective interest rate for domestic borrowing is much higher than the average effective

Elections in Libya for a constituent assembly, originally set to be held by June 19, are to be postponed for logistical reasons, electoral commission members said yesterday.

One commission member, on condition of anonymity, said the postponement until July or later had been decided mainly to allow time for appeals from candidates who had been ruled out of the contest.

"Several dates have been proposed, but most discussions are pointing to July 10," the official said. The chairman of the electoral commission,
