France to begin Afghan pullout next month

AFP, Kabul

President François Hollande said Saturday France will begin its Afghanistan pullout next month and complete it by year-end, after four French troops were killed in a Taliban attack.

Hollande said France would pay a "national homage" to the men killed in a suicide bombing and that five wounded soldiers would be repatriated rapidly.

France's defence minister arrived in of the soldiers.

Afghanistan yesterday. Shortly after touching down, Defence Minister Jean-Yves Le Drian attended a ceremony to honour the dead soldiers, whose coffins -- draped in flags -- were at

Kabul's heavily fortified military airport. Details of Le Drian's full programme in Afghanistan have not been released but he is expected to address French troops and meet Afghan government officials.

Saturday's attack by a burqa-clad Taliban suicide bomber was the first fatal strike against the French since Francois Hollande took office as president last month.


Hollande said the withdrawal of French troops from Afghanistan, one of his presidential campaign pledges, "will begin in the month of July, will be carried out and be completed at the end of 2012."

"In the meantime, everything must be done for our troops to meet their obligations but with the highest level of security and with the greatest vigilance for the lives

"I am making this engagement here and will be the guarantor for this operation," Hollande said in the central town of Tulle, where he was to attend a commemoration of the massacre of civilians by the Nazis on June 9, 1944.

He added that the attack "does not change anything, it neither accelerates nor delays" withdrawal plans.

Some 3,500 French soldiers are deployed in Afghanistan, mainly in Kabul and in Kapisa, the fifth largest contingent in Nato's 130,000-strong US-led force.

My life is under threat: Fonseka

Former Sri Lankan army chief Sarath Fonseka, who was recently released from prison, yesterday said his life is under threat and he needs to be provided with tighter security.

The country's first fourstar general said he has been provided with a security contingent by the government but it was not enough, Xinhua reported.

Police said the former army chief has been provided with 15 officers from the Ministerial Security Division following a request by Fonseka's associates.

However, Fonseka said he was not satisfied with the security, and he needs more based on threats he faces.

Fonseka led the army against the Tamil Tigers during the final years of the three-decade-long civil war that resulted in the defeat of the rebels in May 2009.

The Prince has big investments in energy, tourism and infrastructure development sectors in different countries and "we sought similar investment in Bangladesh," she added.

Elaborating on the offers made to Prince Talal, she said, among other areas "we have offered to establish a complete special tourist zone, which would have shopping malls and all other facilities, and requested him to invest in tourism sector."

A team from Dhaka will soon visit Riyadh. "We will properly follow up the investment projects with the Saudi Prince aiming to attract the investment opportunities in Bangladesh," the foreign minister said.

While briefing newsmen, Prime Minister's Press Secretary Abul Kalam Azad said the premier has invited investment from Saudi Arabia, and this

could happen under government-togovernment, publicprivate partnership or joint ventures.

Hasina asked the Saudi Prince to recruit more Bangladeshi doctors, engineers, paramedics, nurses, IT specialists, accountants, skilled and semi-skilled workers in its new projects.

She also urged him to remove restrictions on recruitment of certain categories of workers.

In response, the Saudi Prince lauded the role of Bangladeshi workers engaged in different sectors in Saudi Arabia, saying that his country might consider recruitment of more workers in near

Dipu Moni also told reporters that the Saudi Prince credited Bangladeshi workers for being hard-working and also for their high level of integrity and honesty.

On a question, the foreign minister said the Saudi Prince did not make any concrete promise of investment in any specific sector, but nodded to make investments in the prospective sectors such as tourism and infrastructure.

The Saudi Prince, who arrived here on a four-hour visit, highly appreciated Bangladesh's steady economic growth despite global economic meltdown.

Hasina also highlighted her government's successes in the fields of education, agriculture, health, women empowerment and social safety net during the meeting.
