

German FM due June 23

German Foreign Minister Guido Westerwelle will arrive in Dhaka on June 23 on his first official visit to Bangladesh at the invitation of Foreign Minister Dipu Moni.

During his two-day visit, Westerwelle will hold talks with Prime Minister Sheikh Hasina, Dipu Moni, Opposition Leader Khaleda Zia and civil society representatives. He is also expected to address a press conference on the outcome of his visit.

Westerwelle will arrive in Dhaka following his visit to India and is expected to leave on the morning of June 24.

Westerwelle, a member of the Bundestag (the German Parliament) since 1996, was also deputy chancellor of the Federal Republic of Germany for three years.

Though the visit would be brief, foreign ministry officials have attached importance to this as Germany is considered to be one of the most valued development partners of Bangladesh.

German Ambassador Holger Michael told The Daily Star that the two countries have shared 40 years of strong diplomatic

He said Germany will continue to cooperate and support Bangladesh so that it becomes a middle income country and meets the Millennium Development Goals.

Last year German President Christian Wulff came to Dhaka on November 28, on a 3-day official visit while Federal Minister for Economic Cooperation and Development Dirk Niebel came to Dhaka last June.

Likewise, Prime Minister Sheikh Hasina also visited Berlin in October 2011 while Dipu Moni visited Germany

Wounded Myanmar citizens narrate escape

Three Myanmar citizens who were shot while fleeing the sectarian violence in the neighbouring country were being treated at Chittagong Medical College Hospital (CMCH) yesterday under police custody.

One of them, Kala Hossain, 50, has a bullet lodged in his stomach and was bleeding internally.

Doctors said they already collected three out of four bags of AB positive blood, donated by the CMCH staff, needed for the operation to bring out the slug.

Lying on a bed in Ward 25, Kala agonisingly told the correspondent of his escape.

Kala was praying inside a mosque in Maungdaw township on Saturday afternoon when he heard gunshots outside. He got hit while running for the door amidst the hail of bullets being sprayed on the building, said Kala. Kala remembered losing conscious-

ness while running for the Naf river. He thinks four people who were running along with him must have picked him up and boarded him on a fishing boat. He regained consciousness at Teknaf

Upazila Health Complex on Sunday. Border Guard Bangladesh arrested him at around 9:00am that day for illegally entering the country and he was shifted to CMCH in the early hours yesterday. He said he had nothing to do with the violence in his country and expressed his

concern for the safety of his wife, four sons and three daughters, whom he had left behind. He suspected the attackers were not of his locality. Not knowing what to do next, he helplessly said, "Neither do I have any relative

Another Myanmar citizen, Mohammad Selim, 20, was recovering in Ward 24 after

doctors removed a bullet from his chest on Sunday.

Selim said he got shot while running for the river with his mother, Khursheda Begum, 40, and Jane Alam, 25, after his house in the township was set alight on Friday.

Escaping through the same route as Kala's, he was admitted to Cox's Bazar Medical College Hospital on Saturday morning.

Police arrested him and his mother and brother from the hospital for the same offence at around 9:00pm that day and shifted him to CMCH on Sunday.

"What is our fault? We fled from Myanmar to save our lives. How could we manage our passports and visas?" questioned Selim. The third Myanmar citizen,

Mohammad Tayab, 20, was lying uncon-

scious in Ward 28 with a bullet lodged in his skull. Dr Faridul Islam Chowdhury, an assistant professor of the neurosurgery ward,

said they were waiting for a CT scan report before they could operate upon him. Tayab was arrested by police from Cox's Bazar Medical College Hospital on

Sunday and shifted to CMCH in the early hours yesterday. A social service officer of Hospital Social Services Programme at CMCH, Paruma Begum, said they would assist

with the treatment of the three. Police were doing their best to assist in their treatment, said Selim Mohammad Jahangir, superintendent of police of Cox's Bazar, adding that some policemen

CMCH Director Brig Gen Fashiur Rahman said humanity should be the first preference of a hospital and he had directed the hospital's store to provide the medicine the trio needed.

Defence terms report on witnesses 'false'

The defence yesterday told a tribunal that the investigation officer had submitted a false report about 15 prosecution witnesses against Jamaat leader Delawar Hossain Sayedee, who has been on trial for his alleged involvement in crimes against humanity during the Liberation War of 1971.

"At least nine of them [witnesses] were waiting at the Golapbagh safe house in the capital, but they were reported sick or missing," said Abdur Razzaq, chiefcounselfor Sayedee.

DU teacher jailed for torturing wife

A Dhaka University (DU) teacher was sent to jail following his arrest yesterday for allegedly torturing his wife over dowry and committing fraudulent act with the High Court Zafar Ahammed Khan, associate professor of statistics

department of DU, was arrested by Shahbagh police from the court premises at noon. The HC ordered police to arrest Zafar and produce him

family for dowry. Zafar took a total of Tk 50 lakh cash during and after the marriage from Parvin's family for different personal pur-

He also took around 25 bhari gold ornaments, electronics and furniture from Parvin's family during the marriage.

Parvin also claimed that her husband had assaulted her several times and that he had an illicit relationship with one of his female students.

BNP leaders Abbas, Milon released on bail

BNP standing committee member Mirza Abbas and party leader AKM Fazlul Haque Milon were released on bail from Dhaka Central Jail last night.

Senior Jail Superintendent, Altaf Hossain, confirmed that Abbas got released from the prison cell of Birdem hospital around 10:45pm while Milon from Dhaka Central Jail around 10:15pm.

Both of them were accused in a case filed with Tejgaon Police Station for torching vehicle near the Prime Minister's Office (PMO) during the hartal hours on

April 29. They, along with 27 BNP leaders, were granted bail from the High Court on Thursday.

On April 29, police filed a case with Shahbagh Police Station and an arson case with Tejgaon Police Station against opposition leaders after crackers went off inside the Secretariat and a bus was torched near the PMO during the hartal.

"Former BNP MP Nazimuddin Alam and JAGPA president Shafiul Alam Prodhan will be released tomorrow (today). Their documents have already been sent to Kashimpur-2 and Mymensingh jail," said Altaf.
