Lives of 35 schoolboys miraculously saved

Thirty-five students of Saidpur Muslim High School at Nayatola of Saidpur municipality narrowly escaped a serious disaster when the concrete roof of class nine at the 57-year-old school building collapsed yesterday.

"When the students were attending the school assembly at about 10:30am, the concrete roof of class nine of the academic building suddenly collapsed with a thundering sound. Thank God neither the teacher nor any of the 35 students of the class was in the room that time," said Belal Hossain, headmaster of the school.

Recent downpour for several consecutive days had dampened the old building, he said.

Saidpur Muslim High School was established in 1951 and its 60-foot-long concrete academic building was built in 1955, said locals and teachers.

After Liberation, several more tin-shed rooms were made to arrange classes for the increased number of students. There are now 300 students in the school, said school sources.

In absence of repair or renovation, the building became virtually unusable a few years ago and several students were injured as

chunks from the concrete roof fell during class hours at different times. But periods of classes nine and ten were held in the building amid serious risk.

Visiting the school yesterday noon, this correspondent saw broken pieces of the roof lying scattered on the floor and two big pieces hanging from the rusty iron skeleton of the roof.

Visibly panicked, some students and locals were peeping through the window

of the collapsed classroom from where benches and tables had been removed.

School managing committee Chairman Hafizur Rahman Hafiz said, "I contacted with the government department concerned praying for construction of a new academic building for the school. But none responded to our appeal. Due to want of classrooms, the teachers continued taking regular classes in the old and risky building."

Construction of a new academic building has become an urgent requirement to avert more serious accidents in future.

District Education Officer Roksana Begum said that she was unaware of the vulnerable condition of the academic building of Saidpur Muslim High School as none informed her earlier.

"I shall bring the matter to the notice of the government department concerned," she said.

Man gets 44 years' RI for killing son

A Panchagarh court yesterday sentenced a man to 44 year's rigorous imprisonment (RI) for killing his son at Tyagoch village in Tentulia upazila of Panchagarh in 2008.

The court also jailed two others for their involvement with the killing.

District and Sessions judge Mohammad Mahbub Ul Islam handed down the verdict in a crowded courtroom.

Convicts Md. Chan Mian, 45, got RI for 44 years, while Babul, 38, got RI for life and Shukur Ali, 40, sentenced to 2 years RI.

The court acquitted Rafiqul Islam as the allegation against him could not be proved.

According to prosecution, Chan Mian killed his son Shukur Ali with the help of others on 6 October in 2008.

The next day Chan Mian himself filed a murder case with Tentulia police station accusing eight people of their village as he had enmity with them over a piece of disputed land.

Later the case was sent to Criminal Investigation Department (CID). After long investigation, subinspector of CID framed charges against Chan Mian, Babul, Shukur Ali and Rafiqul Islam on 31 January in 2011.

Outsiders assault 7 teachers, staff: Fresh agitation for VC's removal

The situation of Pabna University of Science and Technology has worsened further, as the agitating workers and employees demanded removal of the vice chancellor while outsiders allegedly belonging to the ruling party assaulted seven teachers and officers of the institution yesterday.

The attackers also forced the teaching staff and officials to leave the university office at around 1:00pm, official sources said.

"We were busy with official work at the university administrative building when 30 to 35 people entered the rooms and assaulted us in front of the police," Rahidul Islam Rahid, assistant proctor of the university, said.

Assistant proctors Md Fazlul Haque, Mahmudul Hassan, Tanvir Haidar and Rahidul Islam Rahid, and Shahan Shah, deputy director of finance, Sohrab Hossain, deputy controller of examina-

tions, and Md Kamruzzaman, lab assistant, were injured by the attackers, he said.

The attackers are men of Chhatra League and Jubo League, said Dr Abdul Alim, chairman of Bangla department of the university.

Sub inspector Md Amirul Islam of Pabna police station said that a few policemen deployed on the campus became helpless when the outsiders belonging to the ruling party hurriedly entered there.

Asked about the matter, Ahmed Sharif Dablu, president of Pabna district unit of Chhatra League, said, "Chhatra League and Jubo League men did not assault the teachers and officers of the university. The university authorities are trying to create confusion by blaming the ruling party men for agitation by workers and employees."


The workers and employees of Pabna University of Science and Technology started indefinite work abstention from Tuesday protesting assault of an

employee of the university. "Five representatives of workers and

employees went to talk with the vice chancellor at his office at about 10:00am today [Wednesday] demanding justice for assault of a staff. We also demanded removal of the proctor and assistant proctors and urged the authorities to meet our seven-point demand. But the vice chancellor threatened to terminate the job of agitating workers," said Md

Sohag Hossain, a computer operator. The aggrieved workers and employees then left the university and blocked nearby Abdul Hamid Road and formed a human chain there demanding removal of the vice chancellor. They also held a protest meeting in front of Pabna Press Club where they blamed the vice chancellor for what they said huge corruption and nepotism.

Meanwhile, labour affairs secretary of district unit of Awami League Sardar Mithu Ahmed yesterday said, "We have extended our support for the workers and employees of the university to establish their legal demands."
