Govt directs limiting Ramadan profit to 10pc

.......... The commerce ministry yesterday directed commodity retailers to limit profits on Ramadan sales to 10 percent with an immediate effect.

A notice has been sent to trade bodies and chambers so that business leaders can relay the order to retail traders, an official of the commerce ministry said, seeking anonymity.

The ministry instructed retailers to hang in public view the price charts of commodities to make sure buyers are not ripped off.

The new directive will only bind sales of unpackaged commodities, and will not apply to packaged goods as their prices are written on their labels, he added.

The vigilance teams of the commerce ministry will start market monitoring today.

The ministry in a June 26 meeting decided that the retailers will not be allowed to make a profit of more than 10 percent on sales, as sometimes some unscrupulous shopkeepers make hefty

profit from customers. Demand for some basic commodities such as edible oil, sugar and legumes increase, and a section of sellers create an artificial supply crisis to inflate prices.

Half-baked steps keep RMG sector restive

The government-backed crisis management committees can hardly contribute to reining in violence in the garment sector due to a lack of cooperation among the local lawmakers, garment owners and administrations.

The crisis management committees convene a meeting only when there is an incident of violence although they were supposed to sit every month to discuss the sector.

The labour and employment ministry formed a central crisis management committee and five zonal committees in June 2010 to resolve any crisis in the sector.

State Minister for Labour and Employment Munnojan Sufian leads the central crisis management committee, while the local lawmakers were made the heads of the zonal committees.

Previously, there were several zonal committees, and the additional deputy

commissioners of the respective districts were the heads and the local lawmakers the advisers to the committees.

But, later the government formed the permanent crisis management committees centrally and regionally to prevent any recurrence of violence in the sector.

Currently the heads of five zonal commit-

tees are lawmakers Abdullah-al Kaiser Hasnat (for Narayanganj Sadar, Bandar and Sonargaon), Gulam Dastagir Gazi (for Rupganj and Araihazar) and Talukdar Md Towhid Jung Murad (for Ashulia and Savar Lawmaker AKM Mozammel Haque

was assigned for Gazipur district and lawmaker Zahid Ahsan Russell was made his deputy for the Gazipur zonal committee.

Lawmaker Kamal Ahmed Majumder was made the head for Dhaka metropolitan area, while lawmaker Asalmul Haque was his deputy.

NBR's income tax receipts grow 23pc

Income tax receipts soared 23 percent in the immediate past fiscal year, exceeding the collection target, thanks to taxmen's intensive vigilance and efforts to net more taxpayers.

......

The NBR logged Tk 28,327 crore in fiscal 2011-2012 from Tk 23,007 crore the previous year, MA Quader Sarker, member-in-charge of the NBR's tax administration, said yesterday, citing a provisional estimate.

The NBR set a target to bag Tk 27,861 crore in income tax for the year to June 30.

Over the past five years, the tax authority has maintained more than 20 percent growth in income tax receipts comply with laws. particularly because of steady growth of

the economy and rising incomes.

Tax administration's efforts and measures to collect higher taxes from domestic sources in the face of sluggish growth in customs duty collection also contributed to rising income tax receipts.

The tax collector has been organising income tax fairs since the year 2010 to motivate taxpayers to pay tax as less than 1 percent of the population pays income tax. Tax evasion is persistent, according to the NBR.

Nearly 35 lakh out of the 15 crore population hold tax identification number and a third of TIN holders submit tax returns. NBR officials believe more people have taxable incomes but they do not


