Transport strike starts in 2 districts, called off in 6

Transport owners and workers in Meherpur and Chuadanga districts yesterday went on an indefinite strike while they called it off in six southern districts.

Away in Habiganj, transport workers yesterday threatened strike if their demands were not met by July 5.

Road communications of Chuadanga and Meherpur with the rest of the country remained suspended from morning yesterday as Paribahan Malik Sramik Oikya Parishad enforced the indefinite transport strike reports UNB.

The transport owners and workers had been demanding an end to the plying of illegal human haulers like Nasimon, Karimon and 'Alamsadhu' on highways.

Transport organisations of the two districts jointly called the strike on Sunday following an inconclusive meeting with the administration.

The decision to enforce the strike was taken at a joint meeting at Chuadanga Bus-Minibus Owners Group office on Sunday night.

After the meeting, transport owners' leader Wasiuddin Malik Titu and workers' leader Ripon Mandal informed journalists about their decision for strike.

They said they will continue their strike until their demand is met.

Meanwhile, the indefinite strike enforced on Sunday by bus owners and workers of six southern districts was called off yesterday following a meeting between bus owners, union leaders and police administration.

The decision was taken at the meeting held at the office of Deputy Inspector General of Police of Khulna Range at about 2pm.

Meeting sources said, the strike was called off as the authorities agreed to impose ban on plying of shallow engine-run three wheelers on roads and highways in all routes of Bagerhat, Khulna, Pirojpur, Barisal, Jhalakathi and Satkhira districts.

In Habiganj Zila Sarak Paribahan Sramik Union yesterday asked the authorities to meet their 5-point demand immediately to avoid an indefinite strike from July 5, reports our staff corresondent in Sylhet.

The workers announced their decision at a rally in the district town. Union president Shafiqur Rahman Chowdhury chaired the rally held in Khowaimukh area. A noisy procession followed the rally.

Although the demands were placed before the administration long ago, no step had been taken to meet them, the workers alleged.

The demands include stopping toll collection by police at different points, ensuring timely renewal of the drivers' license and withdrawal of black laws that go against the workers.

Human chain demands arrest of Bipul's killer

Students, teachers and employees of Hajee Danesh Science and Technology University (HSTU) yesterday formed a human chain, demanding arrest of Mrinal Goswami, the prime accused in Bipul murder case.

The hour-long human chain, formed in front of Dinajpur Press Club in the morning, was also joined by the parents of the students.

Professor M Afzal Hossain, vice chancellor, Dr Boloram Roy, registrar (Acting), ATM Safiqul Islam, student adviser and Dr Shahadat Hossain Khan, chief of Soil Science department, were present among the teachers.

At the human chain, the teachers alleged that the HSTU authorities filed a case on the day after the murder of Fahim Mahfuz Bipul on June 9. But the police are yet to arrest the prime accused.

Vice Chancellor M Afzal Hossain told the human chain that although the culprit who killed Bipul was already identified, but mysteriously police are yet to arrest the accused.

Md Fahfuzur Rahman, father of Bipul, alleged that his son was murdered in broad daylight in front of HSTU by a class four employee of the same university.

After the murder, he had mysteriously vanished, and still at large, he said.

According to police, they already arrested two accused in the case and were trying hard to nab the prime accused.

Fahim Mafhuz Bipul 23, a final year student of Veterinary Science, was attacked by a gang, allegedly led by Mrinal Goswami, on June 9.

Critically injured, Bipul later succumbed at Dinajpur Medical College and Hospital in the afternoon.
