PILKHANA CARNAGE CASE Gen Moeen asked to give deposition

A Dhaka court yesterday asked former army chief Gen Moeen U Ahmed and three other high-profile witnesses to give their testimonies in connection with the carnage at BDR headquarters in 2009.

The three others are prime minister's Military Secretary Maj Gen Miah Md Zainul Abedin who was then the chief of Special Security Force, former inspector general of police (IGP) Nur Muhammad, and Lt Col (retd) Dr Jahan Ara Begum, who was serving at the BDR hospital.

"A metropolitan sessions judge's court summoned the four witnesses to appear before it as soon as possible and give their depositions," Public Prosecutor Mosharraf Hossain Kajol told The Daily Star.

Gen Moeen is now living in the US, while Nur Muhammad is serving as the Bangladesh ambassador to Morocco.

The court began its proceedings around 9:30am at the makeshift court set up at Dhaka Central Jail and contin-

A DoE enforcement team on June 11 found that the company had razed hills on 1.85 acres of land, for which it did not have the permission.

HOUSES ON CTG HILL SLOPES Authorities to cut power, water supplies

Utility agencies asked to take step in 7 days

Utility service providers here have been directed to cut power, gas, and water supplies to people on risky hillsides in seven days to discourage habitation there.

The directive came from a meeting of divisional Hill Management Committee (HMC), formed in 2007 following a devastating landslide that left 127 people dead on June 11, 2007. The meeting was held at Chittagong city's Circuit House yesterday.

On June 26, downpour and landslides

left 114 people dead in Chittagong, Bandarban and Cox's Bazar.

High officials of government organisations, law enforcement agencies, and NGO representatives discussed the recent mudslides and took the action plans.

They directed Chittagong Water Supply and Sewerage Authority, Karnaphuli Gas Distribution Company Ltd, and Power Development Authority to disconnect water, gas, and power lines to risky hillsides within the stipulated time.

Japan's PM, ruling party in trouble

Dozens quit over tax hike row

A powerful politician and dozens of his followers quit Japan's ruling party yesterday and are likely to form their own rival bloc, dealing a blow to Prime Minister Yoshihiko Noda.

Ichiro Ozawa and 49 other lawmakers submitted their resignations to the Democratic Party of Japan, and others could follow later, party officials said.

Thirty-eight are members of the lower

house of Parliament, where a loss of 11 more seats would end the ruling party's majority and could force Noda to call new elections.

Ozawa, 70, played a key role in the party's rise to power in 2009, defeating the long-ruling Liberal Democratic Party. He has been a vocal critic of Noda's plan to double Japan's sales tax to 10 percent by 2015.

The tax hike has passed the lower house
