## Govt gives 3 schools 1 month for refund

Five months past its earlier directive, the government yesterday gave three prominent non-government schools in the capital one month to return or adjust in monthly fees the extra money the institutions had charged during admissions.

Punitive measures, including cancellation of monthly pay order (MPO), will be taken if the schools, Ideal School and College, Motijheel; Viqarunnisa Noon School and College; and Monipur High School and College, do not comply, said education ministry officials. The government, on January 30, directed schools having

"a section" of teachers enjoying MPO facilities not to charge over Tk 8,000 in admission and other fees for Bangla and Tk 10,000 for English mediums. Schools having all their teachers enjoying MPO facilities

must not charge over Tk 5,000. But most of the schools did not comply. The ministry, in a letter yesterday, asked the Directorate of

Secondary and Higher Education (DSHE) to serve notices to these institutions. Yesterday's directive came following a report by a four-

member DSHE committee which recently visited 17 schools in the capital to see if January's directive was being complied with. The report found that Ideal School and College realised an excess of Tk 3.39 crore by enrolling 3,049 class I students in Bangla and English mediums.

Viqarunnisa Noon School and College realised Tk 68.17 lakh as extra fee from 1,627 class I students in both mediums while Monipur High School and College realised an excess Tk 5.23 crore by enrolling 3,054 students.

The extra fees had not been returned or adjusted as the governing bodies of the three schools did not have any decision in this regard, said the report.

### COMMON RIVER MANAGEMENT Assam CM wants neighbours' role

Chief Minister (CM) of Assam Tarun Gogoi said China, Bhutan, Myanmar and Bangladesh should be included in the proposed North East Water Resources Authority (Newra). He said this while speaking at a press conference in

Guwahati yesterday. During his visit to Assam in 2004, Indian Prime Minister Dr Manmohan Singh proposed for forming an agency to

manage water resources in the region. However, the plan has not been executed yet as Arunachal Pradesh has been opposing it. As an autonomous body, the proposed authority is supposed to have the power to issue environmental and other clearances to projects in the region.

"We need to set up the Newra as a long-term strategy suggested by experts to mitigate the impact of floods. would again request Arunachal Pradesh to rethink its stand,' Gogoi said.

"We should widen the parameter of the authority by including neighbouring countries," he added. China, Myanmar, Bhutan and Bangladesh are linked to the region's river system in various ways.

Due to erosion, Assam has so far lost more than 4.5 lakh hectares of land.

# Equal facilities for govt, non-govt teachers urged

The two-day strike of teachers and employees of secondary schools and colleges ended yesterday with demonstrations and protest rallies held in several districts across the country.

Under the banner Bangladesh Shikkhok-Karmachari Oikkya Parishad, a platform of five teachers and employees' organisations, the agitating teachers who were boycotting classes from Tuesday urged the government to realise their 17-point demand.

In Dhaka, they held a rally in front of Jatiya Press Club where parishad leaders said they would be compelled to announce tougher movements including non-stop strike if demands are not met.

Their demands include nationalisations of all education system, implementation of the National Education Policy, removal of discrimination between government and nongovernment teachers, and providing facilities

similar to those for government teachers.

"We know it is not possible to meet all the demands at a time but we want the government to implement some of our demands," Ranjit Kumar Saha, coordinator of the Parishad, told The Daily Star.

He said parishad leaders will sit tomorrow to chalk out their next course of action and hopefully announce those on Saturday.

Parishad convenors Atiar Rahman, Nur Mohammad Talukder, and Shahjahan Alam Saju spoke at the rally.

Classes in 240 schools in Bagerhat were suspended for the last two days due to the strike while teachers of 176 schools, colleges and madrasas in five upazilas in Gopalganj observed the strike, report our correspondents in Bagerhat and Gopalganj.

In Chittagong, teachers and employees in 14 upazilas participated in the rally held at Chittagong Press Club.

Fakhrul asks PM, tells her to step down STAFF CORRESPONDENT

BNP acting secretary general Mirza Fakhrul Islam Alamgir yesterday asked Prime Minister Sheikh Hasina to accept the moral responsibility for the corruption charges over the Padma bridge project and step down.

The government was corrupt from top to bottom and that was why no action was taken against the corrupt people identified by World Bank, he said.

He was addressing a rally organised by the city unit BNP at the capital's Naya Paltan protesting repression on the opposition.

"The bribe money had been distributed even before the Padma bridge's construction had begun. The government failed to start the construction only for this corruption," he said.

Protesting the government's decision to provide transit and transshipment facilities to India, Mirza Alamgir stated

that this decision ignored the country's interests.

"We want good relations with each and every country but our country's interest must get top priority. We still did not get Teesta's water and people are being killed at the borders everyday," he said.

Blaming the Awami League-led government for the disappearance of BNP's organising secretary Ilias Ali, he said the country's human rights situation had deteriorated alarmingly due to a decline in the rule of law.

Meanwhile, BNP standing committee member MK Anwar demanded the finance minister's resignation if he failed to ensure the Padma bridge project's funding.

"The finance minister made irresponsible statements regarding World Bank in parliament. As a finance minister he cannot make such statements," he said while addressing a discussion at Jatiya Press Club.

# Libyan embassy refutes media allegations

The Libyan embassy in Dhaka yesterday refuted allegations reported by three news agencies recently that it had forged visas and its chargé d'affaires had fled to Malaysia with Tk 100 crore realised in the excuse of providing visas.

At a press conference in the capital's Hotel Lakeshore, the chargé d'affaires, Kamel Al Mahjub, expressed dismay at Bangladesh foreign ministry's inaction against the media outlets.

The news run by a private television channel on June 22 and two newspapers were "totally false and a propaganda of a certain plotting group", he said.

He demanded an apology from the news organisations. "Otherwise, we will take due role in stopping unwanted practices and proper legal action," he said.
