Govt sells sugar at higher than market price

Bangladesh Sugar and Food Industries Corporation (BSFIC) is selling sugar at a price higher than the current market price.

The state-run agency charges Tk 60 for each kg of sugar on the open market at three points in the city, which is 15.38 percent higher than the retail price at Tk 52-53 in the city markets.

"It appears that the government is setting the price of sugar for Ramadan by selling it at higher prices. Others [private sector] will follow the price soon," said Qazi Faruque, president of Consumers Association of Bangladesh (Cab).

Two locals, Khokon Gazi and Horen Mondol, discovered the tiger standing near Khokon's shrimp enclosure in Golakhali area at the edge of the Sundarbans around 6:00am.

On information, Forest Tiger Response Team, operated by Wildlife Trust of Bangladesh (WTB), along with members of the Village Tiger Response Team, and forest department officials exploded crackers and fired shots in the air to scare the tiger back into the jungle.

Limon charged, secretly

Limon Hossain, the juvenile who was maimed by Rab shooting in Jhalakathi on March 23, 2011, has secretly been charge sheeted in the second case against him in connection with obstructing law enforcers from performing their duties.

Ironically, the investigation into the case lodged by Limon's mother against six Rapid Action Battalion (Rab) personnel with Rajapur Police Station on April 10, 2011 has not been completed in 14 months.

Sub-Inspector Ariful Islam, investigation officer of the case lodged by Rab with Rajapur police on March 23, 2011, submitted the charge sheet to Senior Judicial Magistrate's Court of Jhalakathi on July 1, 2012.

General Registrar of the court Nazmul Haque received two charge sheets -- one against Limon, 17, under juvenile crime prevention act and another against local hoodlums Morshed Jamaddar, Jamal, Hatu Mizan, Jahangir, Halim Jamaddar, Labu Jamaddar and Sumon.

The fact of the charge sheet against Limon came to light Sunday, the day the case was heard. Limon's counsels Nashimul Hasan, Manik Acharya and Akkas Shikder termed the charge sheet unacceptable as it **SEE PAGE 6 COL 4**

Greens question new wildlife law

Fear some provisions will facilitate commercialisation of forests

STAFF CORRESPONDENT

Environmentalists, rights bodies and eminent persons have expressed deep concern over some provisions of The Wildlife (protection and safety) Act 2012, passed in parliament on Sunday.

In a statement yesterday, they said the act, in the name of management, would facilitate commercialisation and social forestry by dividing natural forests into

parts, thus putting wildlife and the forests at stake.

Though the act has been formulated for the conservation and safety of wildlife, it appears to have been enacted only to manage the protected areas, they alleged.

The act depicts 10 new types of protected areas, but the roles of the forest department in this regard are not SEE PAGE 6 COL 4
