'Stop coaching business'

Bangladesh Gono Forum Rangpur unit yesterday formed a human chain in front of Rangpur City Corporation, demanding ban on coaching business. They observed the programme for an hour from 11:00am. Among others, Gono Forum Rangpur district unit leader Anwar Hossain Bablu, Mozammel Hossain Minty and Humayun Kabir spoke at the human chain. The speakers demanded an end to commercial coaching and steps for quality education in all educational institutions of the district. They alleged that most of the teachers at the educational institutions in the district especially of government schools and colleges, were engaged in coaching business. The teachers skip their classroom duties and tactfully force the students to go to their coaching centres for private tuition, they said.

Rly gatekeepers' demand

At least 14 railway gatekeepers yesterday formed a human chain in front of Lalmonirhat divisional railway office, demanding regularisation of their jobs. At the protest programme, several gatekeepers alleged that they gave Tk 1 lakh each to a top railway official and his head assistant in 2010 after they assured them of regularising their jobs. The demonstrators also said they were not getting their wages for the last four months. Contacted, head assistant of Lalmonirhat Railway Divisional Traffic Superintendent (DTS) office said that all the 14 were recruited as temporary gatekeepers under a project. Divisional Traffic Superintendent Mostafizur Rahman said that the authorities discharged the daily wage basis railway gatekeepers from their jobs in March this year following the appointment of permanent staffs.

Man beaten to death

UNB, Jessore

A man was beaten to death allegedly by his rival following an altercation over a piece of disputed land at Khorusa village in Jhikargachha upazila on Tuesday. The deceased was identified as Faruk, son of Habibur Rahman of the village. Locals said there was a longstanding conflict between Habibur Rahman and his step- brother Surot Ali over the land. Locals said an altercation ensued between them over the issue at noon. At on stage, Surot Ali and his supporters attacked the house of Habibur and beat up Faruk with sticks when he tried to resist them, leaving him dead on the spot. On information, police recovered the body and sent it to the hospital morgue for autopsy.

Six children drown in ponds, floodwater

Six children drowned in ponds and floodwater in four districts yesterday and the day before.

Two schoolgirls drowned in a pond near the Batiaghata upazila parishad office in Khulna yesterday, reports a correspondent.

The deceased were identified as Barsa Dey, 8, daughter of Raton Kumar Dey, a trader of Beni Babu Road in the city and Jyoti Dutta, 11, daughter of Mahadeb Dutta, a goldsmith of village Hetalbunia in the upazila.

Police and locals said, Barsa, a class three student of city's APC School went to join a wedding ceremony in Batiaghata upazila.

She along with her cousins went to the pond area at about 11:00am. Suddenly she fell into the water. Joyti, a class six student of Batiaghata Public Secondary School, also drowned in the pond as she tried to save Barsa.

In Sirajganj, two children drowned in floodwater in Shahzadpur upazila on Tuesday, reports our correspondent.

The deceased were Onti, 4, daughter of Helal Sarker of Moshipur village and Nadia Parvin, 2, daughter of Abdul Alim of Potazia

village under the upazila.

Family sources said Onti, while playing in their compound, suddenly slipped into the floodwater at noon and drowned.

Body of Nadia, who went missing on Monday night, was found in the floodwater in the morning.

In Lalmonirhat, a schoolboy drowned in a pond near his house at Taluk Dulali village of Aditmari upazila Tuesday morning, reports our correspondent. He was identified as Sohel Rana, 11, son of

Nur Hossain of the village and a student of class six at Dulali High School. Family sources said, Rana did not know

how to swim. In Barisal, a minor girl drowned in a pond

at Nathullabad Fishery Road in the district town on Tuesday. The victim was identified as Swarna, 7, daugh-

ter of hotel employee Shah Alam of the area, reports UNB. Family sources said, Swarna slipped into deep water of the pond while taking bath along with his

elder brother and three other children at noon. Local people rescued her but she died on

the way to Barisal Sher-e-Bangla Medical College Hospital.

DYF man shot in Khagrachhari

Villagers in Aditmari protest 'cheating' by 'spiritual healer'

House besieged, case filed

A woman, introducing herself as a kabiraj (herbal practitioner) and spiritual healer, allegedly cheated people of lakhs of taka at Khatapara Majhar village in Saptibari union of Aditmari upazila under the district during the last one year.

Affected villagers agitated in front of the alleged imposter's rented house in the village yesterday morning, after hearing that the woman secretly went away with the money, gold ornaments and other valuables at night.

Earlier on Tuesday, a cheated woman filed a case with the Judicial Magistrate's Court at Lalmonirhat.

Locals said Minu Begum, 45, wife of Monu Miah of Pathorghata C & B Colony in Chittagong, came to Khatapara Majhar village in Aditmari upazila a year ago. She posed as an expert kabiraj who can treat any disease with spiritual power.

"Minu Begum recruited some informers at the village

to collect personal and family information of local people. She made people, especially women, believe her by telling the information and took handsome amount of money, gold ornaments and other things in the name of spiritual healing," said former union parishad (UP) member Nobiar Rahman of Khatapara Majhar village.

Asma Khatun Lucky, 35, wife of Shamsul Haque in the village, said, "Minu Begum visited my house early January this year and told me that our five-yearold twin sons Swadhin Islam and Sohag Islam were under life risk and needed better spiritual treatment. She also correctly stated some of our family matters.

"Minu along with me and the two kids visited a few mazars in Chittagong and Sylhet and took Tk 7 lakh from me in the name of saving my sons' lives by her spiritual power till April this year. Finally I understood that Minu cheated me and filed a case against her with the Judicial Magistrate's Court," she said.

Shabana Begum, 45, wife of Yasin Ali of the same village, said, "We are a childless couple. Minu Begum visited me in January this year and took Tk 1.5 lakh from me, saying that we will get a baby through her spiritual power. But I am yet to get any result."

"Minu Begum took about Tk 60 lakh from over a hundred villagers during the last one year. She also built a strong network of drug peddlers in the area. Now she has gone into hiding in the face of villagers' agitation. Necessary legal steps must be taken against the imposter and her gang," local UP member Mizanur Rahman Mizan said.

Contacted over mobile phone, Minu Begum said, "I did not cheat any villagers. It is true that I know treatment by spiritual power. Now I have come to Chittagong for personal work and I will go back to Khatapara Majhar village by July 20."

Kobir Miah, owner of Minu's rented house, declined to make any comment regarding the matter.
