### Obama refuses to apologise for Romney attacks

US President Barack Obama heads to the Midwestern state of Ohio yesterday after refusing to apologise for accusing Mitt Romney of outsourcing jobs while in charge of Bain Capital, a charge his Republican opponent has dismissed as

The US presidential race has taken an acrimonious turn in the past week as the wealthy Republican candidate endures a Democratic onslaught over the Bain issue and for squirreling many of his millions away in offshore tax

Romney, the former governor of Massachusetts, called Friday for an apology for the intensifying character assassination by the Obama campaign and said personal attacks against him were "beneath the dignity of the presidency."

"We won't be apologising," Obama

said, according to the transcript of an interview with a local Virginia TV station airing Sunday.

"Mr Romney claims he's Mr Fix-It for the economy because of his business experience, so I think voters entirely, legitimately want to know what is exactly his business experi-

The manner in which Romney acquired his fortune at the helm of Bain, the Boston-based investment firm he founded, has emerged as a major issue during this campaign as

Obama tries to paint him as out of touch with ordinary Americans before the November vote.

Romney maintains he quit the dayto-day running of Bain in February 1999 and was not making the decisions when companies it worked with subsequently laid off US workers and "outsourced" jobs to plants in Mexico and China.

But a Boston Globe report on Thursday revealed that filings with the Securities and Exchange Commission still listed him as Bain's chief executive between 1999 and 2003. "As the head of a private equity firm

his job was to maximize profits and help investors. There is nothing wrong with that," Obama said in his interview with Virginia's WAVY-TV. "On the other hand that company

also was investing in companies that were called by the Washington Post: 'the pioneers of outsourcing.'"

### Philippines to charge ex-president for graft

The Philippine government ombudsman called for graft charges to be filed against former president Gloria Arroyo yesterday for alleged diversion of state lottery funds in the latest accusation to hit her.

Arroyo remains confined in a government hospital while facing charges of vote-rigging.

Ombudsman Conchita Carpio Morales, whose office is in charge of investigating government officials, called on an anti-graft court to file "plunder" charges against Arroyo and nine other government officials.

In a statement, the Ombudsman said it had found Arroyo, 65, and the others, mostly former state lottery officials, had diverted about 366 million pesos (\$8.7 million) in lottery funds from 2008 to 2010.

"The respondents' series or combination of acts form a pattern... of misuse and raid of (lottery funds) from 2008-2010... all while taking advantage of their respective official

functions," the statement said.

It did not say what became of the money but Arroyo critics have alleged that it was used in the 2010 presidential and legislative elections. If convicted of the crime,

Arroyo, who stepped down in 2010 amid charges of graft and Gloria Arroyo manipulating elections, could face 20 years in jail.

Arroyo's lawyer Anaceleto Diaz said the new accusation was devoid of merit, adding it was "another dark day for the rule of law".

He said in a statement it was just part of a campaign that President Benigno Aquino had been running against Arroyo, his chief political opponent.

Aquino, who was elected in a landslide in 2010, has long accused Arroyo of massive corruption and other abuses of power and has declared his intention of seeing her jailed.

Arroyo, who was in office for nearly a decade, was arrested late last year on charges of allegedly rigging the 2007 senatorial elections.

# cross-border crime

Says UN Office on Drugs and Crime

Turnover of cross-border organised crime is about \$870 billion a year, more than six times the total of official development aid, and stopping this "threat to peace" is one of the greatest global challenges, a UN agency said yesterday.

The most lucrative businesses for criminals are drug trafficking and counterfeiting, the UN Office on Drugs and Crime (UNODC) said, launching an awareness-raising campaign about the size and cost of cross-border criminal networks.

"Millions of victims are affected each year as a result of the activities of organised crime groups with human trafficking victims alone numbering 2.4 million at any one time, UNODC said in a statement.

The total estimated figure of \$870 billion is equivalent to 1.5 percent of the world's gross domestic product, it said, warning that crime groups can destabilise entire regions.

"Stopping this transnational threat represents one of the international community's greatest global challenges," UNODC Executive Director Yury Fedotov said.

A spokesman said it was the first time the agency had compiled an estimate for transnational organised crime, using internal UNODC and external sources, so there were

### \$870b turnover of India dismisses Obama concern over economy

Indian politicians yesterday rejected US President Barack Obama's concerns about the investment climate in the country, which has recently suffered a sharp slowdown in economic growth.

Obama, in an interview to the Press Trust of India (PTI) news agency in Washington, said the American business community had told him it was "still too hard" to invest in

"In too many sectors, such as retail, India

limits or prohibits the foreign investment that is necessary to create jobs in both our countries, and which is necessary for India to continue to grow," Obama said. His comments were swiftly dismissed by

politicians from the ruling Congress party as well as the opposition, which has been fighting to stop reforms in the retail sector.

"The government has taken enough measures and put policies in place which welcome investors," Anand Sharma, the commerce minister, said.

"For the next three years India will remain

one of the top three destinations attractive for investors.'

The opposition Bharatiya Janata Party calling Obama's comments "laughable".

"We have to ensure our national interests on our own," BJP spokesman Mukhtar Abbas Naqvi was quoted as saying by PTI.

India recently posted 5.3 percent quarterly growth -- the slowest in nine years -down from scorching nine percent-plus expansion a few years ago.

Foreign investors have expressed alarm,

in particular, over India's plans for retroactive taxation of some transactions -- a step aimed partly at recouping over \$2 billion in capital gains tax from British telecoms giant Vodafone.

Veerappa Moily, the corporate affairs minister, blamed international companies for colouring Obama's views and said the Indian economy remained strong.

"Certain international lobbies like Vodafone are spreading this kind of a story and Obama was not properly informed about the things that are happening," he told reporters in Bangalore on Sunday.

Says UN chief

United Nations Chief Ban Ki-moon told a Bosnian daily yesterday that the organisation's failure to prevent the Srebrenica massacre of up to 8,000 Bosnian Muslims will stay in UN consciousness forever.

"People there suffered genocide. And ... it will really haunt the international community for a long time," Ban said, quoted by the Dnevni Avaz daily online edition.

"The United Nations were not capable of helping people there in times when they needed that help," he said in comments translated into Bosnian.

"It will remain rooted in the UN and world consciousness forever. That is why I will go there," he said, speaking to Balkans media ahead of his visit to the region due to start this week.

Ban is to arrive on Thursday in Slovenia, at the start of a week-long tour of the Balkans, the first of its kind since the region's 1990s wars. He will also visit Croatia, Montenegro, Serbia, Kosovo, Macedonia and Bosnia.

In Bosnia Ban will visit the Srebrenica memorial centre where victims of the 1995 massacre are buried.

documents and statements about the WB's request to the government in favour of a Chinese company will also be made public. Recently, in a written

response to questions from The Daily Star, WB Country Director Ellen Goldstein said the government may disclose the reports containing "evidence of corruption" for the sake of transparency and in the public interest.

Asked about it, Finance Minister AMA Muhith yes-

terday said, "Let's see."

Earlier on Sunday, he said the government did not believe in character assassination. He was replying to journalists' queries on whether the government would make the WB reports public.

On Goldstein's interview with The Daily Star published on Sunday, he said, "Yes, I have gone through the interview. What the country director said in the interview is much better than the WB's statement [issued by the global lender on June 29 cancelling the Bank's funding for the

The university may plunge into further crisis if unelected persons remained in the top administrative

positions, he added. A well-known Dhaka University teacher belonging to the pro-Awami League Blue panel, Anwar Hossain was appointed JUVC on May 20 following teacherstudent agitations that forced the then VC Shariff
