# Shops pledge power conservancy

Shop-owners yesterday promised to avoid lighting up their markets with colourful lights and switch off airconditions during peak hours in Ramadan.

Leaders of the Bangladesh Shop Owners Association and Dhaka Shop Owners Association gave the assurance in a meeting with Energy Adviser Tawfiq-e-Elahi Chowdhury and Power Secretary Abul Kalam Azad at the Bidyut Bhaban in the capital.

"We will not use AC during peak hours and will keep the AC temperature at 26 degree Celsius in other times," said Amir Hossain Khan, president of BSOA.

He said most shop-owners have already installed energy-saving bulbs, replacing energy-incandescent bulbs.

The leaders were unanimous in saying that it would not be possible for them to shut down shops at 8:00pm in Ramadan, as the holy month offers them the best sales throughout the year.

"We have kept the shops shut throughout the year after 8:00pm. Now we want service from the government this month," said SA Quader Keron, secretary general of BSOA.

"Please do not pressurise us into shutting down at 8:00pm in Ramadan. Please do not send police and officials of the power distributing agencies to shut down the shops," Khan said.

## BB plans to meet growth target, lower inflation

Allah Malik Kazemi, a senior consultant of the BB, said, whether the GDP growth target for the current fiscal year will be achieved depends on the world economy.

Kazemi said, given the ongoing global economic slowdown, there are significant downside risks for Bangladesh's export and remittance growth, and therefore for the GDP growth target.

"To overcome the risks, steps as far as possible have been incorporated in the monetary policy," he

However, the BB governor said, due to different reasons including the Summer Olympic Games in the UK, orders for Bangladeshi garments have been on the rise. He said exports in the current fiscal year would be good.

In order to strengthen the financial system, new loan classification and provisioning guidelines are in place, Rahman said.

Banks will have to implement these within the period of the current monetary policy, and while these may make a one-off difference to bank profitability, they will not affect access to credit, the BB governor said.

Citing a study of the central bank, its Deputy Governor SK Sur Chowdhury said default loans in banks may rise slightly in the September quarter.

But in December, it will get adjusted, he added. "As a result, there will be no impact on banks' profitability."

Chowdhury said, if the banks follow the new loan

#### Bangladesh signs deals for 12 projects under Indian credit

The \$7.43 million contract for the fifth project to buy 100 metre gauge bogie tank wagons and five metre gauge brake vans was signed with Texmaco Rail Engineering Ltd in March and the LC was opened in May.

Delivery is expected in March 2013.

Under the sixth project, 30 broad gauge diesel electric locomotives will be purchased from India and a contract for this has been signed with RITES in June this year.

Bangladesh Railway will now open an LC.

Construction of the Khulna-Mongla port rail line, including a feasibility study, under the seventh project, will cost \$175 million.

A contract for feasibility services, detail designs, tendering and construction supervision was signed with Egis India Consulting Engineers Pvt Ltd Coin June.

Apart from the seven projects, the bidding for four other projects is ongoing.

The projects involve procurement of 50 metre gauge flat wagons and five metre gauge brake vans with air brakes to carry containers at a cost of \$2.9 million; purchase of 170 metre gauge flat wagons and 11 metre gauge bogie brake vans with air brake systems to carry containers at a cost of \$9.49 million; construction of the third and fourth dual gauge rail track between Dhaka and Tongi and doubling of dual gauge tracks between Tongi and Joydevpur at a cost of \$88.38 million, and procurement of six dredgers at a cost of \$67.43 million.

The Bangladesh Tariff Commission (BTC) yesterday launched the world trade directory containing macroeconomic, trade and tariff-related information of 176 countries, for businesses' assistance.

The directory, the first of its kind in Bangladesh, will equip businesses with the necessary knowledge to venture into international trade.

"It is a milestone step for Bangladesh in the develop-

ment of bilateral trade," Commerce Minister GM Quader said at the launch of the directory at the Dhaka Chamber of Commerce and Industry (DCCI) office. He, however, asked for regular updates of the direc-

tory, and encouraged the business community to make the best of it. "Printed document creates problems as there is no

chance to update. International business leaders avoid paper-based documents," he suggested. According to Mozibur Rahman, chairman of BTC,

the trade directory would be the largest after International Trade Commission and World Trade Organisa-"The WTD will provide Bangladesh's businesses with

the information of target countries, right business partners, custom duties and so on, needed to develop and eventually sustain in the competitive global market," said Asif Ibrahim, president of DCCI.

Ferdous Ara, chief executive officer of Business Initiative Leading Development, however, urged the commerce minister to design a government-approved country directory to promote businesses in the international stage.

"We are facing problems aboard due to lack of country directory," Ara said.

The commerce minister also took the opportunity to warn commodity retailers of spiking prices for the Ramadan.

"We are ready to take action against the price manipulators if the prices are illogical."

Fazlur Rahman, chairman of City Group, a major enterprise of basic commodities, right away acquiesced to the commerce secretary's request.
