Increasing number of Bangladeshis study in US

Says Mozena at inauguration of TV and film studies department at DU

US Ambassador to Bangladesh Dan W Mozena yesterday said the enrolment rate of Bangladeshi students in US educational institutions was the fastest compared to those from South and Central Asia.

The potential for academic and research exchange between American and Bangladeshi educational institutions was enormous, he said... The ambassador was addressing the

launching ceremony of the newly created Department of Television and Film Studies at Nabab Nawab Ali Chowdhury Senate Bhaban in Dhaka University (DU).

Addressing the ceremony, Chief Justice Md Muzammel Hossain said television and film were not only tools for entertainment but also for informing and educating people.

"Our constitution assures freedom of the media. I believe graduates of the department will be able to use television and film to portray the country's rich culture, language and history before the nation and the world," he added.

DU Vice-Chancellor Prof AAMS Arefin Siddique said television and film were two significant sectors which could help countrymen observe western ideas and devise a democratic model for the country itself.

"While media has many positives to play, it can also be a lethal weapon in the hands of spin-doctors," he added.

Prof Janet Wasko, knight chair in communication research, University of Oregon, USA, presented a keynote, "New challenges for global Hollywood". The department Chairman Dr AJM Shafiul Alam Bhuiyan also spoke at the programme.

A High Court (HC) bench yesterday started hearing on the writ petition, filed on July 18, that challenged the legality of Speaker Abdul Hamid's June 18 ruling.

The Speaker had stated that the HC judge, Justice AHM Shamsuddin Choudhury Manik, violated the constitution by making "derogatory remarks" about parliament and the Speaker. The HC bench of Justice Hasan Foez Siddique and Justice

ABM Altaf Hossain yesterday adjourned the hearing on the writ petition till 10:30am today.

Earlier on July 18, Justice Naima Haider of a two-judge HC bench expressed embarrassment to hear the petition. The bench, including Justice Muhammad Khurshid Alam

Sarkar, also returned the petition to the petitioner, Supreme Court (SC) lawyer AKM Shafiuddin. Shafiuddin filed the petition praying for an HC rule upon the

Speaker and the secretaries to parliament and the law ministry to explain why the June 18 ruling should not be declared illegal. He prayed to the HC to direct the Speaker not to issue

such rulings in the future, saying that the Speaker cannot

issue such a ruling against any SC judge as per the parliament's rules of procedure. The Speaker had abused his constitutional mandate as it does not permit the parliament to challenge any SC proceeding

over any sub-judice matter, Shafiuddin cited in the petition. Justice Manik, during a court hearing on June 5, observed that the Speaker had committed an offence tantamount to sedition by

The Speaker said it looked odd when the courts, though neutral and independent, took quick decisions to resolve their own problems while people wait for years to get justice.

Life changed in a matter of seconds for Shamma Nasrin when a bus ran over her legs in front of Jatiya Press Club in the capital on Sunday.

The 22-year-old student of Bangladesh University of Engineering and Technology (Buet) is undergoing treatment at the National Institute of Traumatology and Orthopaedic Rehabilitation (Nitor).

Doctors had to amputate her left leg on the same day while her right leg was fractured in the accident.
