PADMA BRIDGE Quader frustrated over fiasco

Communications Minister Obaidul Quader yesterday expressed his frustration over how the donor agencies were handled for funding Padma bridge while a ruling party MP accused the finance minister of misleading the premier about the issue.

According to sources, at a meeting of the parliamentary standing committee on the communications ministry, Quader also said the finance minister did not inform him about the details of the World Bank loan agreement to fund Padma bridge.

After the meeting, which was held at the Jatiya Sangsad Bhaban, Quader said construction work of the bridge would begin on time.

At the meeting, committee member and Awami League MP Golam Mawla Roni criticised the finance minister for his remarks on Padma funding. "Sometimes we become confused by his remarks," Roni said.

"The finance minister is misleading the prime minister by giving her various information," Roni told The Daily Star after the meeting. Roni said he urged

Quader to talk to the prime minister and clear his position on Padma bridge financing.

Contacted by The Daily Star, Omar Farul Chowdhury, AL MP and another committee member, said he told the meeting, "There are some ministers who are speaking about other ministries. They should comment on their own ministries."



ARSON CASE AGAINST FAKHRUL

Charge framing date deferred

A Dhaka court yesterday for the third time deferred until July 31 the hearing on charge framing against 46 opposition leaders, including BNP acting Secretary General Mirza Fakhrul Islam Alamgir in an arson case.

Police filed the case against the accused hours after a vehicle was set ablaze near the Prime Minister's Office in the capital during hartal hours on April 29.

Metropolitan Magistrate Mohammad Erfan Ullah passed the order following a time petition placed by Barrister Moudud Ahmed, a counsel for the accused.

In the petition, Moudud said former Dhaka City Corporation mayor Sadeque Hossain Khoka had gone abroad for treatment. So, he prayed for the deferment of the hearing.

Another Dhaka court yesterday deferred until August 27 the hearing on charge framing against Juba Dal President Moazzem Hossain Alal and 57 others in a case for creating violence in the capital's Motijheel area on December 18 last year.

HC questions legality of Bar Council election

The High Court yesterday questioned the legality of Bangladesh Bar Council election which was held on July 18.

In response to a writ petition, the court

issued a rule asking the Bar Council chairman and 38 candidates of its election to explain in 10 days why holding of the polls based on the panels should not be declared illegal. The writ petition claimed that as there is

no provision or rules in the Bangladesh Bar Council law for holding its election based on panels of candidates, but the election was held on July 18 based on the panels backed by two political parties. The HC bench of Justice Naima Haider

and Justice Muhammad Khurshid Alam Sarkar issued the rule following the petition filed by Advocate Yunus Ali Akand.

Yunus filed the petition on July 18 saying

that candidate lawyers contested the election under the panels, Jatiyatabadi Ainjibi Oikya Panel (JAOP) and Sammilito Ainjibi Samannoy Parishad (SASP), which are supported by two major political parties, for their political interest which was against the Bar Council law.

Bar Council Chairman Attorney General Mahbubey Alam and 38 candidates of the election have been made respondents to the rule, Deputy Attorney General Mokleshur Rahman told The Daily Star.

Bar Council authorities yesterday announced the official results of the election, M Tasdiqul Karim, assistant director of the Bar Council, said.

According to the results, JAOP, a body of BNP-led 18-party alliance, has won nine posts of executive member of Bar Council out of total 14 posts.

SASP, an Awami League-led alliance backed forum, has got five posts.

Bangladesh needs to pursue Rio+20 climate fund

Says top official

Bangladesh should take effort to solicit money from a US\$ 513 billion fund pledged at the Rio+20 conference on sustainable development this June, a top government official told a seminar yesterday.

"As governments, private sector, civil society and other groups expressed their commitments at the summit, now our goal is to secure climate funds for the country," said SM Ahsanul Aziz, deputy director (climate change), Department of Environment (DoE), while delivering his keynote speech.

Rio+20 summit or the United Nations Conference on Sustainable Development (UNSCD) was held in Rio de Janeiro, Brazil, on June 20-22.

In the keynote paper, the DoE deputy director said Brazil pledged \$16 million for developing, least developed and small island nations, while China offered \$20 million to unlock private financing for clean energy projects. The European Commission also promised a fund of 400 billion Euro to support sustainable energy projects, he added.

Ahsanul Aziz said Bangladesh also needed to ensure its inclusion in the intergovernmental committee to assess financial needs for sustainable development financing. Reflecting on the achievements of Bangladesh at

Rio+20, he said Bangladesh was honoured by the UNDP's Equator Initiative for its outstanding contribution to sustainable development, and for the first time, the country became one of the vice-presidents of UNCSD. Promoting green economy in the context of sustainable

development and poverty eradication, the Rio+20 accepted Bangladesh's text, which says that each country should choose an appropriate approach in accordance with the national sustainable development plans, strategies and priorities, he said. The seminar titled "The achievement of world people

and stand of Bangladesh in Rio+20" was organised jointly by Bangladesh Climate Change Journalists Forum, IEDB and Rahimafrooz at the capital's Institute of Diploma Engineers, Bangladesh. Special guest at the programme, Bangladesh Bank

Governor Dr Atiur Rahman said the government had to take initiatives to establish green economy in the country to strengthen the fight against climate change.

"The more developed we are, the more resources we consume, consequently polluting the environment more than ever before," he said.

He said "green banking" had been introduced in banks across the country where a "paperless banking system" was aimed at promoting emailing to replace use of papers.

Environment and Forests Minster Dr Hasan Mahmud who addressed the seminar as chief guest, said, "Bangladesh as a Least Developed Country too needs to reduce carbon emissions but not at the cost of its inclusive development activities."

About "green economy", he said that initially the cost might be high but in the long run it would be cost effective.

HUMAYUN AZAD MURDER CASE

Show cause notice for not producing accused

A Dhaka court yesterday issued a show cause notice asking the superintendent of Dhaka Central Jail to explain why the jail authorities failed to produce two accused in Prof Humayun Azad murder case before it yesterday. The superintendent will have to submit the

reply in written form before the court by August 23. Earlier in the day, the court also fixed

September 10 for hearing on charge framing against the five accused in the case. Judge AHM Habibur Rahman Bhuiyan of

Fourth Additional Metropolitan Sessions Judge's Court passed the order as the jail authorities did not produce two JMB leaders Salehin alias Salahuddin and Hafiz Mahmud alias Hassan before it yesterday as per the court order. Two other accused Anwarul Alam alias

Anwar and Mizanur Rahman alias Minhaz were produced before the court while another accused in the case Nur Mohammad is still at large.

On February 27, 2004, Jama'atul Mujahideen Bangladesh activists stabbed the 56-year-old Azad, a professor of Bangla department at Dhaka University, while he was trying to hire a rickshaw for going home from the Ekushey Boi Mela (book fair) on the premises of Bangla Academy in the capital.

Following the incident, an attempted murder case was filed against several unknown people.

He died of cardiac arrest in Munich on August 12 that year, according to an autopsy report.

Criminal Investigation Department (CID) Inspector Kazi Abdul Malek, also the investigation officer of the case, submitted a charge sheet on November 15, 2007 accusing three JMB leaders. They were Minhaz, Nur Mohammad and Anwar.

But later another Dhaka court on October 20 of 2009 ordered a further investigation on the death following an application filed by Azad's brother on October 6 the same year.

CID investigated the matter and found that the JMB leaders were directly involved in the killing of Azad, said CID Inspector Lutfor Rahman.

CID on April 30 this year pressed charges against five JMB leaders appealing to the court to turn the case into a murder case.

The Local Government Division (LGD) has failed to take a proactive disclosure policy to ensure people's access to information under the Right to Information (RTI) Act, 2009, said Nepal Chandra Sarker, former secretary to Information Commission.

The LGD, under the Ministry of LGRD and Cooperatives, was asked to take initiatives for publishing annual reports, setting up a RTI complaint website to take feedback from information seekers, and modernising the citizen charter, he said while addressing a meeting yesterday.

Progati, a partner organisation of USAID, organised the meeting jointly with LGD and Information Commission at the conference room of Department of Public Health Engineering in the capital.

According to the RTI act, the LGD and its all departments must publish annual reports and interlink to ensure easy access to information by information seekers, said Nepal Chandra, also an adviser to MRDI.

However, Akhter Hossain, joint secretary of LGD, said they have already taken initiatives to fulfill the recommendations.
