# Accident triggers protest

## Road blocked, bus torched in Barisal

A road accident injuring a college student triggered violent protest in Goma ferry ghat area of the city yesterday.

Agitating locals and students torched a bus and damaged another four and also blocked Goma-Charkawa road for about three hours.

The injured, Shahnaj Sultana, 18, of Krishnakathi in Bakerganj upazila and a second year HSC student of Barisal Ataharuddin College, was rushed to Barisal Sher-e-Bangla Medical College Hospital.

She was then shifted to Dhaka Medical

College and Hospital as her condition deteriorated.

Locals and witnesses said a bus hit a tempo carrying a few students including Shahnaj from behind on the eastern bank of Kirtankhola River in the area at around 11:00am, leaving her critically injured while they were going to the college.

As the news spread, the protestors torched and damaged the vehicles and blocked the road, halting traffic movement.

On information, police rushed in and brought the situation under control at about 2:00pm, said Nurul Islam, officer in-charge of Bakerganj police station.

### 10 injured in BCL attack at Kurigram Govt College

Chhatra League (BCL) activists of Kurigram Government College unit yesterday attacked the activists of Progotishil Chhatra Jote allegedly for observing a token strike at the college.

Six of the ten injured Jote activists were admitted to Kurigram Sadar Hospital.

According to student sources, filling of forms for the Honours final year examination was going on at the college. Demanding reduction of fees, some of the final year students under the banner of Progotishil Chhatra Jote held a rally and later started observing a token strike in front of the college academic building Monday morning. At that time, some BCL activists asked them to call off the strike.

Yesterday noon when the Jote activists called the strike again, the BCL activists assaulted them, leaving at least 10 Jote men injured.

A BCL leader, however, said that general students, not BCL activists, attacked the Jote men and ousted

# One shot dead as rival groups clash in Sunamganj

A man was shot dead while seven others were injured as two rival groups clashed at village Raibangali under Derai upazila of Sunamganj district yesterday.

Of the injured, 3 were injured by bullets and admitted to the upazila health complex.

Police said there had been a longstanding rivalry between Zahir Ali and Abdul Malik of the village over establishing supremacy in the area. As the supporters of both men locked in an altercation over an issue on Sunday last at a local market, a negotiation meeting was called yesterday morning to settle the matter.

But defying the decision, Zahir Ali's men, equipped with sticks and firearms, attacked the house of Ali Hossain, 35, all on a sudden at about 11:30am. During the gunshots, Ali Hossain died on

Police yesterday rescued two abducted siblings from a hospital at TA Road in the municipality and arrested a man in this connection. The victims are Ziaur Rahman, 25, son of Abdus Salam of Ashuganj and his sister Asma Begum, 28. Family sources said a gang allegedly led by Matiur Rahman, 40, son of Bazlur Rahman of Nabinagar, picked up the duo at gunpoint from a road. The gang confined them to a room of the hospital and demanded Tk 2 lakh ransom from their family members. On information, a police team raided the hospital and rescued the siblings. The team also arrested Matiur while the others managed to flee the scene.
