#### Five doctors suspended

UNB, Dhaka

The government yesterday suspended four physicians for remaining absent in their workplaces without permission and another for submitting false academic documents.

The four are Chhanda Dhar, former medical officer Shakpura Health Centre at Boalkhali Upazila in Chittagong; Muhammad Chanchal Azad, medical officer of Sworajganj sub-centre at Doulatkhan Upazila in Bhola; M Ekram Hossain, medical officer of Gaibandha Sadar Hospital; and Dr Samina Sharmin, medical officer of Chittagong Medical College Hospital, said a health ministry press release vesterday.

Chhanda remained absent in workplace since June 5, 1996 while Chancal since November 11, 2011, Ekram since April 24, 2005 and Samina since April 8, 2002.

# No provision for foreign lawyers: Shafique

Law Minister Shafique Ahmed yesterday said there was no scope for foreign lawyers to defend the accused of crimes against humanity before the International Crimes Tribunals as per relevant laws.

As per the Bangladesh Bar Council laws, only lawyers who are citizens of Bangladesh can practice law in the country, he said, adding that the council regulates the profession of the country's lawyers.

Shafique was talking to journalists after presiding over a meeting on Chittagong Hill Tracts Land Dispute Resolution Commission Act 2001 at CHT affairs ministry's conference room in Bangladesh Secretariat.

The journalists raised the issue against a

backdrop of a recent statement made by a defence lawyer in the ICTs.

The lawyer, Tajul Islam, said they were planning to seek the council's permission in allowing foreign lawyers to defend their clients.

On July 23, 2011, the council had rejected an application seeking permission for three foreign lawyers to defend five Jamaat-e-Islami leaders detained in connection with war crimes committed during the 1971 LiberationWar.

The lawyers were Steven Kay QC, Toby Cadman and John Cammegh.

Justifying the rejection, the council authorities said anyone not having an enrollment certificate, issued by the council allowing lawyers to practice law in the country, cannot represent anyone in a case.

# BUSINESSMAN MURDER IN CAPITAL No motive found

The motive behind the murder of 72-year-old businessman Mohammad Fazlul Haque still remains unknown to police and his family members.

Fazlul, an importer and the owner of Haque Paint, was stabbed in the neck in the first floor bedroom of his duplex house some time between Friday night and Saturday morning.

Sub-Inspector Pushpendu Debnath of Gulshan Police Station said, "We could so far ascertain that there was a single killer who fled through the main gate. But how he entered

is still unknown. "Besides, the killer had searched the bedroom for something specific and important."

He said police were trying to unearth how the killer entered and fled despite the presence of three security guards.

Eight people employed in the house, including the security guards, two drivers, and three housemaids, were detained for interrogation.

Police were also trying to locate the missing cellphone. With no sign of a tussle, the post-mortem report would confirm whether Fazlul was sedated before being killed, said Pushpendu.

### Burnt student dies at DMCH

A university student, who had set himself on fire on Saturday in the capital's Tejgaon Industrial Area, succumbed to his injuries early yesterday at Dhaka Medical College Hospital (DMCH).

Victim Monirul Islam Shraban, 22, a sixth semester student of BBA in Ahsanullah University of Science and Technology, had been admitted to the burn unit of DMCH with 55 percent of his face, neck and chest burned. He died around 12:10am.

According to police and victim's friends, Shraban tried to kill himself at the house of a schoolgirl, who refused his romantic advances.

Shraban, hailing from Khulna, used to stay in a university dormitory in Kunipara.

Shraban's roommate Sabbir Ahmed Kajal said the girls' house was adjacent to their dormitory. Shraban had fallen in love with her and tried to establish a romantic relationship. A few days back the girl's

mother called Shraban to their house and asked him to give up his romantic advances. He may have committed suicide because of the rejection, he said. "The night before the

incident we had sehri together and I went to sleep. In the morning the watchman of the girl's building came to the dormitory and informed me of the suicide attempt," Kajal said.

Shraban was very emotional. He also took about 30 sleeping pills over a trifling matter a few months back, Kajal said.

Shraban was buried at his village in Khulna.

# No progress in finding fire source

Widow blames investigators' insincerity

Over three and a half years into the death of former Ganotantri Party president Nurul Islam in a fire incident, no significant progress has been made to unearth the cause behind the fire, said Nurul's frustrated widow and political associates yesterday.

NURUL ISLAM'S DEATH

Nurul Islam, a nominee of the Awami League-led grand alliance at the last parliamentary election for Noakhali-1 constituency, died 36 hours after suffering from burns in the mysterious fire at his Lalmatia apartment on December 3, 2008. His son Tamohar Islam Puchi was burnt alive in the blaze.

Nurul Islam's wife, lawmaker Ruby Rahman, and his associates were talking to journalists at a views exchange meeting in the capital's Dhaka Reporters' Unity marking his 71st birth anniversary.

"Despite the government's assurance to hold a fair probe and trial, we see no progress in the investigation. We are frustrated due to the investigation team's lack of sincerity in completing the probe," said Ruby Rahman.

Expressing frustration over the investiga-

tion's slow pace, they questioned the role of the investigators, accusing them of being negligent in taking some important clues into consideration. One of the clues that the Criminal

taken into account was that no plastic object or clothes were burnt in the fire, they said. The investigation officer of the case, CID Inspector Shahinur Bari, told The Daily Star

that the investigators had noted all possible clues and were carrying out the investigation with the help of the Bangladesh Council of Scientific and Industrial Research. Workers' Party of Bangladesh Presiden Rashed Khan Menon urged the home minis-

ter to clarify the ministry's stance over the investigation delay and urged the government to take effective steps in this regard. Ruby Rahman hoped that the govern-

ment would ensure the completion of the investigation and trial within this year.

Prof Syed Manzoorul Islam of Dhaka University urged the prime minister to monitor the investigation progress herself. regard.

# JS body for fish export ban in Ramadan

The parliamentary watchdog on commerce ministry will recommend for halting export of fish during Ramadan to ensure its sufficient supply in the market.

"We'll suggest the [commerce] ministry today to stop fish export ... hope the fish export will stop," said Chairman of the committee ABM Abul Kashem told reporters after visiting two kitchen markets in the city yesterday.

On Sunday, apex trade body FBCCI urged the government to halt the export of fish during Ramadan mentioning that the monitoring cell of the FBCCI had found the export of fish created supply shortage in the markets and therefore, the prices shot up with the start of Ramadan.

#### COMMODITY PRICES STABLE

Yesterday, Abul Kashem expressed satisfaction over the market situation after visiting Karwan Bazar kitchen market.

He talked to buyers and sellers regarding the prices of fish, edible oil, rice and other commodities. "I'm very happy to hear that the prices of essentials remain at tolerable level though the prices were higher on the eve of Ramadan," Kashem said.

The JS body's monitoring team also visited Mohammadpur kitchen market at noon.

Senior officials of the commerce ministry, FBCCI Director M Helal Uddin, magistrates and police personnel were also present during the visit.
