Ex-UP member drowns

A man drowned in Bhabanipur River of the district on Monday night. The deceased, Kalachand Dewan, 65, was a former member of Katulee union in Sadar upazila. Katulee UP chairman Sumon Dewan said Kalachand fell into the water when he was crossing the river by a boat. Other passengers of the boat rescued him and sent him to Tangail General Hospital where he died after sometime.

Smuggled goods seized

Member of Border Guard Bangladesh (BGB) seized Indian clothes and motorbike parts worth Tk 10 crore at Hili port in the district yesterday. They also arrested eight people in this connection, said Lt Col Mehdi Hasan, commanding officer of Joypurhat-3 Battalion. The BGB men of Joypurhat-3 and Phulbari-40 Battalions in a joint drive recovered the goods from four trucks at noon, he added.

KU admission tests

Truck driver shot
UNB, Jessore

Criminals shot a truck driver at Hushtola in the district town on Monday night. The injured, Sumon Hossain, 32, son of Ayub Ali of Bezpara area of the town, was admitted to Jessore Medical College and Hospital. Police said when Sumon was standing in front of a tea stall, a gang on a motorbike opened fire on him, leaving him injured and fled the scene.

Man found dead
UNB, Bogra

Police recovered the body of an old man from Nador River in Talora-Saranjabari area of Dupchancia upazila on Monday. Locals found the body of the octogenarian floating in the river and informed police at noon. The body was sent to the hospital morgue for autopsy.

Boy commits 'suicide'

A teenage boy allegedly committed suicide by hanging himself at Shantiganj Bazar in Dakkhin Sunamganj upazila of Sunamganj district on Sunday. The deceased was identified as Islam Uddin, 17, son of late Batir Ali of Shibpur village in the upazila. Locals said Islam Uddin committed suicide by hanging himself from the ceiling of the closed tea shop of his uncle Lukman Mia at about 4:00pm. The reason behind the suicide could not be known immediately.

Criminals abduct teacher

Criminals abducted a school teacher from his home at Noddapara village in Madhyanagar upazila of Sunamganj district early yesterday.

Victim Chandan Sarker is a mathematics teacher at Ramdigha High School.

Family sources said a gang of 10/12 stormed into the residence of the school teacher at about 2:30am and picked him up at gunpoint after beating the family members.

Victim's wife Archana Sarker said the incident occurred when they were asleep.

The gang entered the house by breaking open the door, she said.

A case was filed with Madhyanagar police station in this connection.

The reason behind the kidnapping could not be known immediately, said Mizamul Haque, officer in-charge of the PS.

The school teacher was not rescued till filing of this report at 6:00pm yesterday.

Teachers form human chain

Teachers of non-government colleges formed a human chain, followed by a rally, in front of local press club yesterday to press home their seven-point demand.

Bangladesh College Shikhhak Samity, Chapainawabganj unit arranged the programme joined by over 200 teachers of different colleges.

At the rally, the speakers criticised the government for giving them only TK 100 as house rent and TK 150 as medical allowance.

They demanded prime minister's intervention to end the discrimination in education sector.

DINAJPUR 2005 SERIAL BLASTS

Absconding accused jailed, 7 others acquitted

A special tribunal yesterday awarded an absconding accused ten years imprisonment in the case for serial bomb blasts in Dinajpur town on August 17, 2005.

The convict, Md Afzal Hossain, 38, son of late Joynul Abedin of Khetripara area under Dinajpur municipality, was also fined Tk 10,000, in default to suffer six months more in jail.

Afzal, a regional leader of banned Islamist outfit Jama'atul Mujahideen Bangladesh (JMB), was the mastermind of the serial blasts in Dinajpur, said police.

Md Gazi Rahman, judge of the special tribunal at Dinajpur, issued the verdict in a crowded court at noon in presence of seven of the eight accused in the case, court sources said.

The court acquitted the seven people as their involvement in the incident was not found.

They are Razu Mia of Amtoli village of Borguna district, Abu Razin and Md

Abdul Motin of Dilanpur village in Badarganj upazila of Rangpur district, Tozammel Hossain of Mohabbatpur village under Dinajpur Sadar upazila, Nazrul Islam of Khanpur, Rashib Bin Mokbul of Shikdarhat, Aminul Islam of Ramnagar of Dinajpur Sadar upazila and Raihanur Rahman of Chhatoil village under Bochaganj upazila of Dinajpur district.

Nazrul Islam, Rashid Bin Mokbul and Razu Mia were produced before the court from Dinajpur jail while the other accused had earlier got bail from the High Court, police said.

Md Abdus Salam, the then sub inspector of Dinajpur Sadar police station, filed a case on August 17 in 2005 mentioning that at least 10 bombs were exploded at different places in the district headquarters on the day.

JMB set the bombs, including five inside Dinajpur court complex, one each in front of Dinajpur police station, Dinajpur Sadar Hospital intersection, Dinajpur Eye Hospital intersection, Dinajpur Jailmore and Central Bus Terminal in the district town.

The serial blasts triggered panic among the locals.

Later, Dinajpur police recovered two unexploded bombs, leaflets of JMB and some books on Jihad from different places, police said.

Police arrested the aforesaid seven people, suspecting their involvement in the serial blasts.

The Criminal Investigation Department carried out an investigation in the case and filed a charge sheet accusing the eight people in November the same year.

During the trial, the court examined 39 witnesses.

Extortionists injure five of a family

Five of a family were injured as a gang of criminals stormed into their house and beat them up for not giving illegal toll at Bazitpur village in Keshobpur on Monday night.

The injured were identified as Jahangir Sardar, 49, his wife Abeda Begum, 42, their two sons Akram Hossain, 30, and Zakir Hossain, 16, daughter-in-law Jasmine, 25. Their neighbour Bhanu Bibi, 25, was also injured by the attackers.

All the injured were admitted to Jessore Sadar Hospital.

Police, quoting Abeda Begum said Shahidul, a

local criminal used to sexually harass her for long.

A few days ago, he made an indecent proposal.

As she refused, Shahidul demanded a big sum of money from her family as toll which they declined to pay.

At this, the criminal along with his 6/7 accomplices, equipped with lethal weapons stormed into their house at night. They vandalised two rooms, looted cash Tk 15,000 and gold ornaments worth Tk 40,000.

Abeda alleged that the extortionists earlier threw her four-year-old daughter into a ditch beside their home and sexually harassed Abeda.

A case was filed.

Jubo Dal activists assault newsman

Jubo Dal men assaulted a journalist in Kalanka bus stand area of the district yesterday morning.

Police and locals said a few Jubo Dal activists led by Nannu, 43, intercepted Russel Mollah, 30, Kalapara upazila correspondent of daily Ajkal published from Barisal, in the bus stand area when he was heading for Patuakhali from Kalapara upazila riding a motorbike.

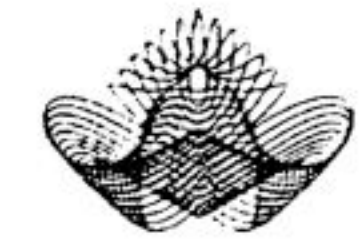
They said Nannu and his men beat up Russel for publishing reports in the newspaper against him (Nannu).

At one stage, the Jubo Dal men tried to slit Russel's throat but local people foiled their bid and rescued him.

They chased the Jubo Dal activists and caught Nannu and his nephew Sakhawat while the rest managed to flee. The two were later handed over to the police.

Seriously injured Russel is undergoing treatment at Amtali Upazila Health Complex.

Babul Akhter, officer in-charge of Amtali police station, said they have arrested the two and are looking for others involved in the attack.
