# Extortion from vehicles rampant in Thakurgaon

The malpractice ahead of Eid adds to prices of commodities

Illegal toll collection by a section of transport workers and dishonest traffic policemen from vehicles at different points in Thakurgaon Sadar upazila has appeared as a nuisance ahead of the Eid-ul-Fitr.

"I have given Tk 800 as toll while bringing my goodsladen truck through the highway from Tangail at different points in different districts," truck driver Rafiqul Islam told this correspondent on Thakurgaon-Dhaka highway in front of Ejab Cold Storage near the BGB Battalion Headquarters.

"We are forced to pay toll at many points. Even after maintaining all documents properly, we have to face harassment by police who demand money. There is none to look after the matter," said Liton Mian, another truck driver who was coming from Chittagong.

Wednesday, this correspondent saw a group of members of Thakurgaon Distinct Truck, Tank-Lorry and Covered Van Workers' Union forcing every truck coming from both sides on the highway to give Tk 20 in the name of workers' welfare fund. The money collectors

were also giving receipts to the drivers.

Kamal Hossain, vice president of Thakurgaon Distinct Truck, Tank-Lorry and Covered Van Workers' Union, claimed that their money collection is not illegal as they give receipt against the received money. He admitted that different groups of transport workers collect money

## One killed, 50 hurt as supporters of 2 UP members clash

A man was killed and at least 50 others were injured in a clash between the supporters of two union parishad (UP) members at Manika village under Bahubal Upazila in Habiganj district yesterday.

The deceased was identified as Abdul Ali. Of the injured, 26 were admitted to the Upazila Health complex while the rest to Habiganj Sadar Hospital.

Locals said there had been a long standing rivalry between Satkapon Union Parishad members Joinal Mia and Dilara Khatun over establishing supremacy in the area.

Recently, Dilara raised a boundary wall of a graveyard at the village with financial help from Zila Parishad, but Joynal and his men demolished the wall at midnight on Tuesday.

As Dilara along with her supporters tried to rebuild the wall yesterday morning, Joinal and his men swooped on them, prompting their opponents to retaliate.

During the clash, Abdul Ali of Dilara group died on the spot while 50 others from both sides injured. Police recovered the body and sent it to Sadar Hospital morgue for autopsy.

Officer in Charge of Bahubal Police station Azizur Rahman Sarker said the incident was a sequel to long standing rivalry between the two UP members over establishing supremacy at the village. No case was filed in connection with the incident as of 5:00pm yesterday.

In Sunamganj, over 40 people were injured in a clash between two groups of people at Betura-Asadnagar village in Chhatak upazila of Sunamganj district on Tuesday evening, UNB.

Local sources the clash was a sequel to rivalry between Nur Mia and Abdur Rahim of the village.

Supporters of the two equipped with lethal weapons locked in a clash at around 7:00pm, leaving at least 40 people from both sides injured.

Additional District and Sessions Judge Md Motahar Ali pronounced the verdict in presence of the convict. According to the prosecution, Ayesha Akhter Bithi, daughter of Abdul Mannan of Rasulpur village, was stabbed to death by her husband Sadek Sarkar on May 18 in 2007 following a quarrel over dowry. Awlad Hossain, brother of the victim, filed a murder case with Matlob (South) police station against Sadek. After investigation, police pressed charges against Sadek.

#### Stalker jailed

### Two girls commit 'suicide'

Two girls allegedly committed suicide in separate incidents at Amlapara in the district town and Deghol Beltoli village in Shahjadpur upazila on Wednesday night. The deceased were identified as Happy, 23, a domestic help at the house of one Minatullah in the town and Phuljan, 26, daughter of Kurban Ali of Deghol Beltoli village. Police said locals found the body of Happy hanging from the ceiling fan of a room on the second floor of the house at night and informed them. The law enforcers went to the spot, recovered the body and sent it to hospital morgue for autopsy. The reason behind the suicide could not be known as of yesterday. In another incident, Phuljan allegedly committed suicide by hanging herself from the ceiling of her room following a quarrel with her mother. Later, police recovered the body and sent it to the hospital morgue for autopsy.

## Overflowing Nautara River causes massive erosion

Usually a quite and smoothly flowing river, the Nautara has turned turbulent, causing massive erosion at Satjan village in Dimla upazila.

This situation arises every year during the rainy season as BangladeshWater Development Board (BWDA) releases excess water of Teesta Irrigation Project to reduce pressure on the infrastructures, to Nautara River through an escape regulator two kilometres away from the affected village, locals said.

When the BWDB releases water through the regulator, the river swells rapidly and flows with strong current devouring the bank at Satjan village, they said.

Visiting the affected area on Saturday, this correspondent found that within a week the river devoured 42 homesteads, making 225 people homeless. It also washed away 200metre approach road of Nautara Bridge, cutting off the village from a large part of the upazila.

Sixty acres of cultivable land with newly transplanted amon paddy and vegetables and a madrasa were also eroded by this time.

The erosion victims have taken refuge at their relatives' houses and at a nearby government land making makeshift shelters with polythene, paper and clothes while the people still staying at the village are passing their days amid fear of serious erosion any moment.

Local resident Nurul Islam, also former chairman of Nautara union parishad, said,

"The problem appeared after the start of Teesta Irrigation Project. If water in the Teesta River swells alarmingly, consequently the main irrigation canal (coming out of the river) overflows and the authorities open the gates of the escape regulator at Kakra village. The released water, after proceeding about half a kilometre, falls into Nautara River. It creates violent current causing massive erosion at Satjan village." This time the erosion is more serious than

that of previous years, he added.

Erosion victims Saifullah, 45, Rabiul, 35, Jamiar, 45, Momin, 48, and others said Teesta Irrigation Project has become a bane of them although it is a boon to many.

It has become an urgent task of BWDB to save the people of Satjan village from erosion by Nautara River, said Aftabuddin Ahmed, chairman of Dimla upazila parishad.

When contacted, Zohurul Islam, executive engineer of BWDB in Dalia Division, said, "We have started making spurs with bamboo and sandbags in the river as a temporary measure to protect Satjan village from erosion by Nautara River. For permanent solution, we have submitted a project to the higher authorities to divert the river course by excavating a new channel."

"Nautara River is very long and winding. Water from nearby villages flows into it, causing strong current there. We do not open gates of the regulator unless it is necessary," he said.
