TAX EVASION CASE ETV chairman summoned by court

A Dhaka court yesterday summoned Ekushey Television Ltd (ETV) Chairman Abdus Salam, hours after a tax evasion case was filed against him.

Judge Md Zahirul Haque of Senior Special Judge's Court of Dhaka asked Abdus Salam to appear before it on September 11.

Bazlur Rahman Khan, deputy tax commissioner of National Board of Revenue (NBR), filed the case.

The case statement said the ETV chairman evaded tax upon his income of Tk 17.64 crore in the fiscal years 2006-2007 and 2009-2010.

Earlier on March 20, Abu Sayeed Sohel, deputy tax commissioner of NBR, filed a case against the ETV chairman and its managing director Ashraful Alam for not submitting their tax returns within a stipulated

ARSON CASE AGAINST OPPOSITION LEADERS

Govt seeks resumption of proceedings

The government yesterday filed a petition for vacating a High Court order that stayed the proceedings of an arson case against 46 opposition leaders and workers, including the BNP acting secretary general.

Attorney General Mahbubey Alam placed the petition before the HC bench of Justice Naima Haider and Justice Muhammad Khurshid Alam Sarkar.

Accepting the petition, the bench yesterday fixed today for a hearing.

The same bench on August 6 stayed for eight weeks all the function of Speedy Trial Court-5 regarding the bus torching case filed against the opposition leaders and workers.

The HC also issued a rule upon the authorities concerned to explain in two weeks why the Chief Metropolitan Magistrate Court's decision to give judicial powers to the Speedy Trial Court-5 to conduct the case should not

be declared illegal. The HC's move came since the government could not show any copy of gazette notification "giving judicial power to Speedy Trial Court-5 to conduct cases having the same nature like that of the arson case".

The attorney general's office yesterday annexed a gazette notification issued by the government in 2008 along with its petition, Deputy Attorney General Ekramul Haque Tutul told

The Daily Star. Chief Metropolitan Magistrate Bikash Kumar Saha on July 31 in an order gave judicial powers to Metropolitan Magistrate Harun-or Rashid to conduct the Speedy Trial Court-5 for hearing and disposing of the case.

The Speedy Trial Court-5 the same day framed charges against the 46 accused in the case.

Police filed the case with Tejgaon Police Station hours after a bus was set ablaze near the Prime Minister's Office during the opposition's April 29 hartal.

RAPE OF SPEECH IMPAIRED GIRL

HC orders DNA test to identify culprits

The High Court yesterday directed police to immediately get Dhaka Medical College Hospital doctors to carry out a DNA test on a speech impaired girl, who was raped in Munshiganj's Louhojang upazila last month, to identify the rapists. Hearing a petition filed on the basis of an

August 1 Janakantha report, the court also directed police to submit the test report to it as early as possible. The report said one, Shipan Bepari of

Singherhati village of Kanaksar union under Louhojang upazila, abducted the girl from a road, confined and raped her for two days in a house and left her on the road at the end of July.

Police rescued the girl on July 30, held talks with local Awami League leaders led by one, Monir Hossain, and sent her to her village in

Bhola on July 31, without carrying out any medical test, to suppress the incident, it said. Yesterday, the HC bench ordered police to arrest the rapists and provide security to the

girl and her family. The judges also heard from the girl's mother in their chamber, where the girl was present. They were brought by police as per

Bodies of microbus, taxi drivers found

Five days after a microbus driver of Tangail went missing on his way to Dhaka, police recovered his decomposing body near Water Development Board's pump house in Mirpur Beribadh area in the capital on Saturday night.

In another incident, the body of a taxi driver, who was taking three to four youths from Feni's Dagonbhuiyan Bazar Petrol Pump to Feni sadar on Friday night, was found at Sonagazi upazila yesterday. The taxi had gone missing, said police.

The microbus driver, Adam Ali Miah, 35, had been slaughtered, said police.

The microbus owner, Md Selim Miah, who is Adam's brother-in-law, told this correspondent that one, Binimoy, son of Rabiul Guerrilla of Tangail town, hired the microbus on August 6 evening, saying he would go to the capital's Uttara.

Selim last talked to Adam around 10:00pm that night, when Adam said he was passing Mirzapur in Tangail en route to Dhaka. After midnight, Selim found

switched off. Selim went to Binimoy's house, where

Rabiul revealed that Binimoy was a mugger. Selim received a ransom demand, through sources on August 8, of Tk 2 lakh for the return of Adam and the vehicle. The next day, the captors claimed that Adam had escaped and their demand was Tk 1 lakh for the vehicle's return. Selim said he had disagreed.Selim filed a murder case on Saturday night with Tangail Police Station against Binimoy and his unidentified accomplices.

A Feni correspondent reports, police said the CNG-run taxi driver, Nizam Uddin Rubel, 24, son of Abul Kashem of Sreedharpur in Dagonbhuiyan municipal area, was hired by three to four youths around 8:00pm to take them to Feni.

Rubel's body, with the hands and mouth tied up, was found by the locals in a field at Saheber Haat area of Amirabad union.

Police sent the body to Feni Sadar Hospital Morgue for autopsy.
