### 'Criminal' held after gunfight

A 'top criminal' injured a gunfight with the law enforcers was arrested in Jihashtola area of Sadar upazila on Saturday at night. The arrestee was identified Amir Khashru, 32, son of Suruj Mia of Bollalbari village.

At least five policemen were also injured during the gunfight.

Officer in-charge of Sadar police station Abu Bakar Siddik, sub-inspectors Nazrul Islam, Mostafa Kamal, Moniruzzaman and ASI Moniruzzaman were admitted to Munshigan General Hospital.

Sultan Uddin, second officer at the PS, said Khashru along with his two accomplices were going towards Sardarpara from Panchasar intersection by a

motorbike. The criminals opened fire on the policemen as they tried to intercept them. In retaliation, the law enforcers

also fired at them. Later, police arrested Khashru while the rest man aged to flee, said Sultan.

### Protesters demand arrest of criminals

Several hundred locals formed a human chain in front of the office of deputy commissioner in the city yesterday, demanding immediate arrest and punishment of the criminals who attacked a college student.

They also submitted a memorandum to DC Farid Ahmed in this regard.

Victim Wakimul Islam Shakil of Alhajnagar area in Sadar upazila is a first year student at Rangpur Collectorate School and College.

Locals said, there was a longstanding conflict between the family members of the victim and one of their neighbours over a piece of disputed land.

The protesters said a gang beat up Shakil mercilessly and at one stage, attempted to kill him on August 1.

Hearing the hue and cry, locals rushed to the spot and rescued him.

Motruza Begum, mother of the victim, filed a case with Kotwali police station

in this connection. Following the case, the criminals continued to give Shakil's family death threat but police did not take any steps as yet to arrest them for unknown

## Ghior Bridge remains risky, authorities turn blind eye

The road passengers from Daulatpur upazila of Manikganj, Chowhali of Sirajganj and Nagarpur of Tangail district are badly suffering as Ghior Bridge over the Dhaleswari River on Ghior-Daulatpur road has turned risky due to loosening of soil under its two pillars.

The authorities on July 19 suspended plying of vehicles except rickshaws, rickshawvans and auto-rickshaws on the bridge, and consequently, road journey between Manikganj district headquarters and Daulatpur upazila has remained a troublesome one.

The people of Chowhali upazila of Sirajganj and Nagarpur upazila of Tangail also use Ghior-Daulatpur road to go to the capital Dhaka.

Local Government Engineering Department (LGED) built the 180-metrelong and 3.66-metre-wide Ghior Bridge with Tk 2 crore in 2007 and it was opened in June for vehicular movement, said sources of Ghior upazila office. There are eight pillars in the bridge.

As the bridge has turned risky, the authorities have set warning signboards and fence with tree logs and iron chain on both sides of the bridge to prevent vehicular movement there. The police have been deployed three "We have taken the steps

according to decision of the authorities concerned. However, we allow government vehicles and ambulance to cross the bridge," said Ashraf-ul-Islam, officer in charge of Ghior police station.

Now the people travelling on the road have to spend more time and money for the purpose, locals said.

Ahead of the Eid, the situation has appeared as an added worry especially for the homebound people travelling with family mem-

During this correspondent's visit to the spot on Wednesday, locals alleged that a section of people have been lifting sand from 60-70 yards off the bridge for long although soil lifting within 200 yards of the bridge is

"The bridge is now under threat as the soil from the bottom of its two pillars has been washed away by the river current. The LGED high

officials have already visited the bridge two times. The soil has been sent to the research unit of LGED head office for test. We will take necessary steps after getting the soil test report," said Md Yusuf Hossain, Ghior upazila LGED engineer.

#### Boy abducted for ransom murdered

A six-year-old boy, abducted for ransom from Bishulia Katabri village in Gobindaganj upazila on Tuesday, was found dead in a bamboo cluster at the village yesterday.

A gang abducted Mesbahul Hasan Musa, son of Akbar Ali, while he was playing outside their home in the afternoon. His father filed an abduction case with Gobindaganj Police Station the same day.

On Wednesday, the gang members phoned Musa's father Akbar, demanding Tk four lakh ransom for release of his son. As Akbar failed to meet the demand, the gang killed Musa and dumped the body into the bamboo cluster.

Locals found the decomposed body of Musa in the bamboo cluster yesterday morning and informed the police who recovered the body and sent it to Gaibandha Sadar Hospital morgue for autopsy.

They also picked up eight people from there and took them to the police station for interrogation. The arrestees are Lokamn Mondol, 50, Majedul Islam, 30, Aynul Huq, 20, Nasim Mondol, 22, Anwar Hossain, 30, Golapi Begum, 23, Amena Begum, 30 and Lipi Khatun, 24.

Police said the abductors killed the boy as his family did not pay heed to their demand.

### UP chairman held for attack on policemen

The law enforcers on Saturday night arrested a union parishad chairman and an aide on charge of attacking police in Phulpur upazila.

The arrestees are Rokonuz-Zaman Rokon, 36, chairman of Rambadrapur union and Alam, 40.

Police said, a gang allegedly led by Rokon ransacked a shop at Char Bahadurpur village on August 10.

Following the incident, one Azharul Islam of the village filed a case, accusing the UP chairman and his supporters. Later, police arrested six people, including a woman.

Angered at filing of the case, the chairman and his men held a motorbike procession on the upazila headquarters premises at around 9:15 pm.

On information, a team of police rushed to the spot and asked them to stop the rally.

At one stage, Rokon attacked the on duty police men, leaving three constables--Nabiul Islam, Sohag and Kawsar--injured, said S. Alam, officer in-charge of Phulpur police station.

Later, police arrested the duo, said the OC.

The arrestees were produced in a court yesterday which sent them to jail, he added.



### Hilsa still remains out of reach of common people

Demand up ahead of Eid

The price of popular fish hilsa is yet to come down as expected, following the ban on export, due to increased demand ahead of the Eid festival.

The government on July 31 banned export of all kinds of raw fishes except shrimp during the month of Ramadan to ensure adequate supply to the local market and keep the prices at tolerable level. Hilsa supply became

abundant following its huge netting at different fishing points of the estuaries and coastal fishing zones in the first week of last month while imposition of ban on its export contributed to decrease in its price. But the price again rose

by 10 percent compared to that of last week, said Aslam Khan, manager of hilsa trading house Five Star. Increased demands due

to Eid festival amid shortage of supply caused the price hike, said hilsa trader Yunus Ali. Now hilsa weighing 600

grams is selling at Tk 500-600 per kg, hilsa weighing 800-900 grams at Tk 800-900 per kg while the fish weighing 1,000 grams or over is priced at 1,000-1500 perkg. The prices were Tk

1100, Tk 1600 and Tk 2500-3000 per kg last month. Only solvent people are

now buying hilsa as a

medium-sized hilsa costs Tk 800 to 1000, said Sentu Mia, a retail hilsa trader at the market.

"Several factors including demand, supply, investment, costing, profit, purchasing capacity of consumers determine the price of hilsa. Only ban on export cannot bring any sustainable solution to control the hilsa price in the local market as only 10-15 percent of netted 3,50,000 tonnes of hilsa is exported yearly," local hilsa trader Yunus Ali said.

The amount of hilsa netting reduced in the second week of this month, fishermen said, adding that the catches depend on the flow of current in river and sea, amount of rainfall and periods of lunar calendar, such as full and new moons.

In last week, 20-30 fishing trawlers, each carrying 150-200 maunds of hilsa, daily reached Barisal fishing port from the estuary and coastal areas but now the number has come down to 10-15, said Kalam, a worker engaged in unloading hilsa at the port.
