# High prices throw a wrench in Eid shopping

High prices of clothes and cosmetics have disheartened Eid shoppers from low income group, a scenario which is reflected by the dearth of buyers in some hawkers' markets of the capital.

Sales at the city's Gulistan and Farmgate hawkers' markets remain quite low although the market at New Market is faring better.

Talking to The Daily Star, many people from the low income group have claimed that to make larger profit, sellers this Eid have increased price of all kinds of garments by Tk 50 to Tk 100 and price of cosmetics by Tk 10 to Tk 30.

But their income has not increased in proportion to the increase in price of garments and cosmetics, they said.

Ahsan Habib, a shopper who works at a private bank, said although his budget was Tk 2,500, he spent Tk 4,000 for Eid shopping for a family of four. Ahsan, who has an income of Tk 21,000 monthly, said

he is worried about how he will cope financially for the

rest of the month. "I am worried about how to manage the remaining days of the current month, as I have already spent a chunk of my salary on house rent, shopping and some

other errands ahead of Eid," he said. On the other hand, the sellers have said the prices of goods have increased but it is due to high taxes and production cost.

Amajd Hossain, a makeshift shop-owner selling clothes at the city's New Market area, said the price of shirts that he sells has increased from Tk 200 to Tk 250, price of trousers has increased from Tk 320 to Tk 350 while the price of each three-piece has increased from Tk 400 to Tk 500.

"I had to increase the prices of clothes as I have also paid high prices to the garment suppliers," he said.

However, Ahsanul Haque Jewel, employee of a multinational company, said sellers are taking advantage of Eid to sell at a higher price.

"Although it is difficult for me to spend a lot of money for Eid shopping I still have to buy clothes and sellers are taking advantage of this," he said

Jahanara Parvin, a college teacher, said it is very diffi-

cult to buy toiletries as price of each item of cosmetics has increased by Tk 15 to Tk 35 from previous year. "I bought toiletries for myself and my daughters but

I had to pay Tk 10 more for each item on average, which is really difficult for someone with a low income," she said.

Mainul Islam Sumon, a cosmetics and toiletries shop owner, said the prices have increased due to high production cost and taxes.

Sadia Islam, a receptionist, said the delight of Eid is for the rich not the poor.

# War crimes trial maintaining standards

Says NHRC chief

The trial of war criminals is being conducted independently maintaining all international rules and regulations, chief of National Human Rights Commission Prof Mizanur Rahman said yesterday.

"Some people, who want the trial, are also saying the international crimes tribunal is not free. This kind of speech is misleading common people since it's a great mistake," he told the inauguration of a rehabilitation programme for released prisoners.

The programme was jointly organised by Bangladesh Jail and Lions Club International at Prisons Directorate Officers' Mess in the capital.

Law Minister Shafique Ahmed said about 60 percent prisoners in the country were serving jail terms due to pending cases.

"We are amending the code of criminal procedure to complete every trial quickly so that

people do not need to remain in prison for long." He said the government would also make necessary amendment in the jail code to turn the prisons into reform centres.

### INT'L CRIMES TRIBUNAL Mojaheed to meet lawyers in jail

The International Crimes Tribunal-2 yesterday permitted three counsels of war crimes accused Jamaat leader Ali Ahsan Muhammad Mojaheed to meet with him in jail custody

to prepare their case. Defence counsels Nazrul Islam, Munshi Ahsan Kabir and SM Shahjahan Kabir will be allowed to have 'privilege communication' with Mojaheed on August 25 from 10:00am to 1:00pm.

Jamaat-e-Islami Secretary General Mojaheed is now in Narayanganj jail.

The three-member tribunal headed by its Chairman Justice ATM Fazle Kabir with members -- Justice Obaidul Hassan and Judge Md Shahinur Islam -- gave the permission following hearing on a petition filed on August 12.

Moving the petition, defence counsel SM Shahjahan yesterday told the tribunal that prosecution has provided eight new witnesses in the case but the defence could not take instruction from the client in this regard for preparing their case.

Although they have already met three times with Mojaheed in jail, they need another meeting with him to prepare their defence, said Shahjahan.

Prosecutor AKM Saiful Islam said the court might allow the defence petition as

per the jail code. On June 21, Mojaheed was indicted on seven charges of crimes against humanity, including murder, genocide and conspiring to kill intellectuals, dur-

ing the Liberation War. First prosecution witness in the case is expected to testify on August 26.

KHALEDA'S BIRTHDAY CELEBRATION BNP won't make mistake this year

The opposition BNP will not make yet another mistake by celebrating the party chairperson's birthday on the National Mourning Day, as politics is not devoid of humanity, minister without portfolio Suranjit Sengupta hoped yesterday.

The discussion was titled "Celebrating false birthday targeting the National Mourning Day is equal to encouraging the killers of '71 and '75". The programme marked the 37th death anniversary of Banganbandhu Sheikh Mujibur Rahman, which falls on August 15.

The theme of this year's national mourning day should be tolerance to each other among the political parties, as tolerance is vital for democracy and politics, said the senior AL leader.

He also thanked BNP and its leader Moudud Ahmed for their initiative to discuss the framework of "an interim gov-

A government without political party cannot be neutral, he said, adding that a government with representation from all political parties could a neutral and fair one, and transparent election could be held under it.

Surnajit hoped BNP and AL would talk to remove uncertainty about how to hold the next election.

## Mosharraf gets bail

The High Court yesterday granted anticipatory bail for eight weeks to former BNP state minister for energy AKM Mosharraf Hossain in a corruption case.

Shahidur Rahman, assistant director of the Anti-Corruption Commission (ACC), filed the case with Shahbagh Police Station on February 12 accusing Mosharraf and one Kashem Sharif.

According to the case statement, Mosharraf, in 2005, took a land cruiser jeep worth about Tk 95.58 lakh as gift, and 5,000 Canadian dollars as bribe from Niko, a Canadian oil and gas exploration company, to strike a contract between the government and Niko.

An HC bench of Justice Mir Hashmat Ali and Justice Jahangir Hossain Selim granted the bail to Mosharraf after hearing a bail petition filed by him on August 12.
