Woman kills husband

A man was killed allegedly by his wife at Bhojendrapur village in sadar upazila early Sunday over a family feud. Police later arrested the housewife. Victim Shipon Hossain, 35, was son of Tofazzal Hossain of the village. Police and locals said Shipon and his wife Champa Khatun locked in an altercation at about 12.30am on Sunday. At a stage, Champa stabbed her husband with sharp weapons leaving him dead on the spot. Officer in-charge of Pabna Sadar police station Md. Afzal Hossain said, Shipon often locked in quarrels as he had two wives.

10 injured in stampede

At least 10 women were injured in a stampede at the house of Water Resources Minister Ramesh Chandra Sen at College Para in the municipality area on Saturday. Witnesses and police said, the incident occurred in the afternoon when around 300 poor women of the adjacent areas gathered in front of the house of the minister for monetary help ahead of Eid. Of the injured, police took five women to Thakurgaon Sadar Hospital.

Fake ASP arrested

A fake assistant police superintendent (ASP) was arrested at Kamargram village in Boalmari upazila on Tuesday night. The arrestee was identified as Tapan Chaki of the village. Police said, identifying himself as an ASP of the Special Branch of Police, Tapan rebuked Ruhul Amin, the officer in-charge of Boalmari police station, a few days ago over mobile phone and ordered him to release a recently seized motorbike. Later, the OC lodged a general diary in this connection. After tracking the mobile phone of Tapan, police raided the village at night and arrested him. A fake identity card of ASP was recovered from his possession.

Youth murdered

Police recovered the body of a young man from a pond in Nandail upazila on Tuesday night. The victim was identified as Zahirul Mia, 26, son of Ekram Hossain Bhuiyan of Purbo Dolilla village in the upazila. Police said locals spotted the body of Zahirul floating in the pond of Shah Newaz Tafiria Alia Madrasa at Purbo Dolilla at about 9 pm and informed police. Later, the law enforcers recovered the body, which bore injury marks in the head, and sent it to hospital morgue for autopsy. Police said Zahirul, a rice-mill trader, might have been killed by rivals following a previous enmity.

Patuakhali mayor's clinic vandalised, 5 injured

Criminals vandalised a clinic and injured five people including a director of the clinic owned by Patuakhali municipality Mayor Dr Shafiqul Islam on Tuesday midnight.

With serious injuries, the director, Jahirul Haque Khokon was admitted to Barisal Sher-E-Bangla Medical College Hospital from where doctors referred him to Dhaka Medical College Hospital for better treatment yesterday afternoon.

Four other injured took primary treatment at the clinic.

"At about 12:30am a gang

of around 20 people ity, a few eyewitnesses also attacked the clinic and started searching for director Jahirul Haque Khokon. They found him on the third floor where he was sleeping. The criminals beat him up and hit him with a brickbat on the head, making him badly injured," said Md

of the clinic. "The attackers also broke the windowpanes of the reception room of the clinic. I could not identify them," he said.

Jahirul Haque Khokon told this correspondent over cell phone that a gang led by the youngest son of a state minister made the attack on the clinic and injured him.

This correspondent failed to communicate with the alleged leader of the attacker gang as his cell phone was found off.

Dr Shafiqul Islam, mayor of Patuakhali municipality, who is now staying in Dhaka, said his political rivals might have made the attack on his clinic.

Md Monirul Islam, officer in charge of Patuakhali police station, said, "We do not know who attacked the clinic. Nobody has submitted any written complaint in this regard. If anybody files a case over the matter we will take lawful action."

Criminals kill schoolboy 6 weeks after abduction

A schoolboy, kidnapped in Kashiani upazila about one and a half months ago, has been murdered by the criminals.

Victim Mahfuz, 9, was a Class III student at a local kindergarten and son of Italy expatriate Rezaul Haque of Barasur village in the upazila.

Locals said, Mahfuz went missing after he had gone to local mosque on the night of Shab-e-Barat to say prayers on July 5.

Police arrested Billal Sheikh, Shamim Sheikh and Chittai of nearby Mukundapur village, following a case filed after the incident.
