Yesterday, a six-member ACC probe body quizzed four more officials, all from the bank's GM office in Dhaka. So far 17 officers of the state-run commercial bank have been interrogated by the team as part of its ongoing investigation into the irregularity.

Of the four, Sabita Siraj is a general manager now on leave preparatory to retirement (LPR). She was a deputy general manager when the loan scam took place.

The rest are assistant general managers Golam Nabi Mallick and Ashraf Ali Patwari and senior executive officer Waheed Uddin Ahmed. In a late night development, the bank suspended the trio along with 14 others for their alleged involvement in the scandal.

ACC sources said like others who have been quizzed by the commission, the four too denied complicity.

Of the accused, seven officials have already retired. They are general managers Sabita Shiraj, Nowsher Ali Khondker, Ali Hossain Khan Md Musa and Mahbubu Huq, assistant general manager Shamim Akhter and senior executive officer Shahida Khanam.

Humayun Kabir, who was managing director at the time of the scam, has also retired.

The suspension came after Sonali Bank conducted an audit inspection into the embezzlement of Tk 3,547 crore by Hallmark Group and five other groups from the bank's Ruposhi Bangla Hotel branch.

The audit report blamed 31 officials for the scam.

The Anti-Corruption Commission, which launched an inquiry into the fraud, would interrogate Humayun Kabir on Sunday, a competent source has said. TIB FOR PROBE

Transparency International Bangladesh yesterday called for an investigation into the scam and demanded exemplary action against those behind it.

Expressing concern over the alleged fraud, TIB Executive Director Iftekharuzzaman said such misappropriation of money in a state-owned bank reflected colossal deficiency

in the bank's management and auditing system.

Links of influential quarters to the scam also indicate corruption through exploitation of state power, he said in a statement.

"The conflicting stances of Bangladesh Bank and Finance Minister AMA Muhith are of grave concern. The questionable stance of the government will hinder transparency and accountability in the entire banking and financial sector, Iftekharuzzaman added.

It follows on from other studies that have suggested eating chocolate can improve the health of the heart.

However, researchers and the Stroke Association warned the findings were not an excuse to overeat choco-

Everyone taking part in the study was asked about their eating habits and their health was monitored for a decade.

They were split into four groups based on the amount of chocolate, with the bottom group eating, on average, no chocolate each week and the top group having 63g - slightly

more than an average bar. Comparing the top and bottom groups showed those eating the most chocolate were 17pc less likely to have a stroke during the study, published in the journal

Neurology. One of the researchers, Prof Susanna Larsson, from the Karolinska Institute in Sweden, said: "The beneficial effect of chocolate consumption on stroke may be related to the flavonoids in choco-

"Flavonoids appear to be protective against cardiovascular disease through antioxidant, anti-clotting and antiinflammatory properties." "It's also possible that

flavonoids in chocolate may decrease blood concentrations of bad cholesterol and reduce blood pressure." The study also noted that

while dark chocolate had been linked to benefits for the heart in the past, milk chocolate was the preferred option in Sweden and in the study. Dr Clare Walton, from the

Stroke Association, said: "Past research has shown that eating dark chocolate might go some way to reducing your stroke risk if it is eaten as part of a healthy, balanced diet.
