#### Housewife dies from snakebite

A housewife died from snakebite at Pataitari village in Taraganj upazila on Friday night. The victim was identified as Taskina Khatun, 27, wife of Shahidar Rahman of the village. Family sources said a snake bit Taskina when she was in the kitchen at around 10:00pm. She was immediately taken to the upazila health complex where the doctors declared her dead.

#### Farmer found dead

Police recovered the body of a farmer from a paddy field near Sayestapur Bazar in Pirganj upazila yesterday morning. The dead was identified as Ashu Mia, 35, son of former union parishad member Fazo Mia of Soyekpur village. Hasan Shamim Iqbal, officer in-charge of Pirganj Police Station, said criminals killed Ashu when he was returning home from Dhaperhat area of Gaibandha on Friday night. Locals found Ashu's body in the field and informed the police who recovered the body and sent it to Rangpur Medical College Hospital morgue for autopsy, the OC added. Victim's father said the gang killed his son as a sequel to a previous enmity.

#### Man injured in clash dies

UNB, Gopalganj

A man, who was injured in a clash between two rival groups at Dighulia village in Kotalipara upazila on National Mourning Day, died at Gopalganj General Hospital on Friday morning. The dead is Atiar Fakir, 50, of the village. There was a longstanding conflict between Kibria Molla and Atiar Rahman over establishing supremacy at the village. Police said an altercation took place between the supporters of the two over distributing 'tabarak' (milad's food) at a local mosque on the night of August 15. Later, both groups equipped with lethal weapons attacked each other, leaving Atiar critically injured. He was rushed to the upazila health complex and then shifted to the hospital where he succumbed to his injuries.

#### Two shops gutted

UNB, Benapole, Jessore

Two shops were gutted in a fire at Public Library intersection in Monirampur upazila on Friday night. Police said the fire originated at Samrat Khan's shop at about 11:30pm and soon engulfed a stationery stall. On information, firefighters rushed to the spot and extinguished the blaze with the help of locals. The affected shop owners claimed that the loss caused by the fire could go up to Tk 5 lakh.

#### One held with gun

Members of Rapid Action Battalion (Rab) arrested a man along with a gun in Monihar area of the district town yesterday morning. The arrestee is Shamsher Ali Tuku, son of Panjab Ali of Barandi Mollapara area of the town. Major Arif, deputy commander of Rab-6, said on secret information, they raided the area and arrested Tuku along with the gun and a bullet.

#### **Outlaw killed**

An alleged outlaw was stabbed to death in Chatmohar upazila early yesterday. The Deceased, Nayeb Ali, 40, son of Kashem Ali, of Hadal Pashchimpara village in Faridpur upazila, was a regional leader of outlawed Purba Banglar Communist Party (PBCP-Red Flag) faction. Habibul Islam, officer in-charge of Chatmohar Police Station, said locals found Nayeb's body in Aulipur sluice gate area and informed the police. The law enforcers recovered the body and sent it to Pabna Medical College Hospital morgue for autopsy. Internal feud might be the reason behind the killing, said the OC.

#### 4 drug peddlers jailed

A mobile court in Sadullapur upazila town yesterday sentenced four drug peddlers, to different terms of imprisonment. The convicts are Ferdous Mia, 45, his son Ripon Mia, 20, of Idrakpur village, Thanda Sheikh, 50, of the town and Shahan Shah, 40, of Baishtabdas village. Court sources said police arrested the four along with phensidyl and hashish from the area and produced them before the court led by Executive Magistrate Golam Mowla.

# Gourd cultivation changes his lot

Mohsin Ali, a poor farmer at Banuria village under Kaliganj upazila, has changed his lot by cultivating gourd.

Inspired by his younger brother Humayun Kabir, an NGO worker in Dhaka, Mohsin undertook a project to cultivate 'Diana', a China highbreed variety in February and till end of July he earned Tk 3.60 lakh. In August, Mohsin made another Tk 1.50 lakh.

From dawn to dusk Mohsin toils in the gourd field with hired labourers, nurturing the creepers and blossoming flowers. Days are over for Mohsin when with traders coming to buy Alam added.

he had to struggle to bring a morsel of food for the family.

"As it is my first venture, I had to spend Tk 1.20 lakh to lease the land and prepare the field for gourd cultivation. I hope the costs will drop drastically next year," he said.

### 7 hurt as BCL, Jubo League clash

At least seven people were injured in a clash between the activists of Jubo league and Bangladesh Chhatra League (BCL) in Kalapara upazila town under Patuakhali district on Friday night.

Police quoted locals as saying that a group of BCL men led by Azim swooped on Zakir Hossain Juku, general secretary Kalapara upazila Jubo League, while he was taking tea at a tea stall in the town at around 9:30 pm. The BCL men hit Juku with sharp weapons and left the scene, leaving him seriously injured.

Locals rushed to the spot and took Juku to the heath complex. After a few minutes, over 100 activists of both Jubo League and Chhatra League locked in a clash that left at least seven people from both sides injured.

### 3 cops injured by snatchers of arrestee

Police sue 70, arrest 6 in Barisal city

Three policemen were injured as locals attacked a team of plain-clothes policemen to snatch away an arrestee, also wanted in several cases including those for robbery, in New Kashaikhana area of Port Road-Hatkhola part of the city on Friday night.

After failure to re-arrest the accused after nightlong operation, police lodged a case on Saturday against 30 named and 40 unnamed people and arrested six locals including a female on charge of creating obstructions in performing government duty, and attacking and injuring law enforcers, said Matiur Rahman, officer in charge (OC) of Barisal Kotwali police station (PS).

A large number of locals fled the area in fear of arrest and police harassment.

Witnesses said a team plain-clothes policemen of Bakerganj police station (PS) beat up and arrested Mojibor Rahman, a tea stall owner and an alleged member of a dacoit gang, from his house in the city at about 9:30pm Friday.

Suspecting them to be extortionists engaged in abduction using false identity, Mojibor's family members and local people attacked the plain-clothes team with lethal weapons, and snatched the handcuffed Mojibor.

Assistant sub inspectors (ASI) Manirul Islam and Shakhawat Hossain, and Abdus Salam, a constable of Bakerganj PS, were seriously injured in the incident.

A team of Barisal Metropolitan Police led by Rabiul Islam, assistant superintendent, rushed to the spot, rescued the three injured policemen and sent them to hospital at about 10:30pm, said the OC of Barisal Kotwali PS.

ASI Shakhawat is likely to be referred to Dhaka for better treatment as his condition is critical, said Dr Fakhrul Alam, medical officer of Barisal Sher E Bangla Medical College Hospital.

Bakerganj police conducted the operation under the jurisdiction of Barisal Kotwali PS without any prior information or permission, said the OC of Kotwali PS.

Nurul Islam, OC of Bakerganj PS, said, "Mojibor was wanted in several cases and general diaries. A plain-clothes police team conducted the operation secretly to arrest the accused, also son of dacoit gang leader Abdur Rashid Sardar of Birangal village under Rangosree union of Bakerganj."

Dev Das Bhattacharjee, Barisal district superintendent of police, said, "Perhaps the plainclothes police team conducted the operation in the area under the jurisdiction of another police station secretly to prevent leakage of information in arresting a notorious criminal gang member who was wanted for long. The authority will investi-

gate the matter."

spondent of Ekushey Television, bdnews24.com and the daily Sangbad, lodged the case with the Chief Judicial Magistrate's Court in the district against Parimal Mazumder, former bureau chief of a national daily, and Niranjan Chakrobotty, staff reporter of an online news portal of Rangpur. The court summoned

## for posting man's Transport workers block road for 5-hour in C'nawabganj

Vehicular movement on Chapainawabganj-Sonamasjid highway remained halted for five hours from 8:45am yesterday as transport workers blocked the road near the town protesting further rise in toll for crossing Bir Shreshtha Captain Mohiuddin Jahangir Bridge.

The Roads and Highways Department has again increased toll for vehicles crossing the bridge over the Mahananda River with effect from midnight on Friday. With this, the department has hiked bridge toll rates thrice since May this year, said transport owners and workers.

Angered by the latest rise in toll rates, drivers and helpers of buses, minibuses and trucks blocked the highway, keeping vehicles haphazardly near the toll plaza at Baroghoria point.

Several hundred buses,

trucks and other vehicles got stranded on both sides of the bridge, causing immense sufferings to the passengers and hampering smooth supply of goods.
