# Importers on indefinite strike at Hili land port

Export-import through Hili land port in Hakimpur upazila of the district remained suspended for the second day yesterday due to an indefinite strike enforced by the importers.

The importers began the strike on Sunday protesting alleged mismanagement at the land port. They gave the call through a press conference

held at Dinajpur Chamber of Commerce and Industries on Saturday.

At the conference, the importers also brought allegations of corruption and extortion by the men of port operating authorities.

Different trade organisations of both India and Bangladesh have expressed their solidarity with the strike.

Port sources said

local lawmaker Azizul Haque Chowdhury sat with the importers and the officials of the private port authorities at the office of the upazila nirbahi officer (UNO) on Sunday evening to end the stalemate.

But the meeting ended inconclusively as Ananta Kumar Chakraborty, director of Panama-Hili Port Link Ltd, was not present there, sources added.

'We will continue strike until our demands are met, said Harun-ur Rashid, convener of the Importers Group of Hili Land Port.

Contacted, Director Ananta Kumar Chakraborty said port activities are being hampered due to the strike enforced by a group of importers. "They are hatching conspiracy against me." He alleged.

## BSF returns body of cattle trader

The victim was identified as Babul Hossain, 31, son of late Jasim Uddin of Islampur village.

## Cops, villagers clash in Habiganj: 20 hurt

At least 20 people, including a sub-inspector, were injured in a clash between police and locals at Uchail village under Habiganj Sadar upazila yesterday.

One Zakia Parvin Beauty, wife of Zohur Hossain of Habiganj town, had been claiming the ownership of 8.53 acres of land at the village for long.

Assistant commissioner (Land) of Habiganj on August 29 issued an order, saying that Zakia Begum is the owner of the land, which was being used by the villagers as public property.

Accordingly, a police team led by Executive Magistrate M M Mahmudur Rahman yesterday went to the village for handing over the possession of the land to Zakia.

As the magistrate along

with cops reached the area, hundreds of villagers surrounded them. They asked the team not to hand over what they said public land to Zakia.

At one stage, they swooped on the law enforcers and vandalised their microbus. Police resorted to baton charge, leaving at least 19 villagers injured. A police sub-inspector of Sadar Police Station also sustained injuries during the incident.
