## PCP blocks road in Rangamati

Pahari Chhattra Parishad (PCP) yesterday blocked the Rangamati-Naniarchar road in Naniarchar upazila, demanding unconditional release of one of their fellows detained on charge of extortion.

The activists of PCP, a student front of United People's Democratic Front (UPDF), also blocked a local river route during the agitation.

Mohammad Mostafa, officer in-charge at Naniarchar police station, said the security personnel picked up Sohel Chakma, Prashanta Chakma and Supayan Chakma, members of PCP, from the upazila headquarters on Wednesday noon.

The arrests were made at around 12:00pm when the trio were collecting money through coupon from the shopkeepers, said the OC.

However, Prashanta Chakma and Supayan Chakma were later freed and Sohel Chakma was handed over to police, Mostafa added.

At a protest programme, the leaders of PCP also threatened to go for a tougher movement if their demand was not met immediately.

# Parts of the lone inoperative vessel being stolen

Ferry service on Andharmanik River at Baliatali point of Kalapara-Kuakata alternative road has remained suspended since the lone ferry on the route went out of order 22 months ago.

In 2008, Local Government Engineering Department (LGED) set up the ferry terminal at Baliatali near Kalapara town on Andharmanik River and arranged a ferry service on the alternative road to Kuakata tourist spot.

The alternative road link offers easier journey as it requires only one ferry crossing instead of three on the 22-km-long main road and so, it became popular to tourists as well as d local commuters.

LGED handed over the ferry to Kalapara upazila parishad for management and maintenance, upazila parishad sources said, adding that about 60,000 people of Lalua, Mithaganj, Baliatali and Dhulashar unions under the upazila got facility to communicate with the upazila headquarters and Kuakata tourist spot. But shortly afterwards,

the ferry faced troubles and Kalapara upazila parishad repaired it three times.

Lastly in June 2010, the

ferry went out of order, causing indefinite stoppage of the service.

Unscrupulous people are stealing different parts of the ferry that is lying idle on a char (landmass emerged from riverbed).

The lessee now uses country boats to carry passengers across the river for extra fares. "I started for Kaukata on

# Jubo League men injure 2 Jubo Dal activists

Two Jubo Dal activists were injured in Dashmina upazila as Jubo League men pounced on them in two separate incidents on Wednesday afternoon. Police quoting locals said

Iubo Dal activist Hasan Jahangir, 25, was returning home from town by his motor bike. While he was crossing T&T

road, a few Jubo League activists, led allegedly by Ripon and Sujon waylaid Hasan.

They stabbed Hasan with sharp weapons before taking away his motorbike and cell phone.

As the victim raised a hue and cry, locals rushed to the spot and sent the victim to Dashmina upazila health complex. In another incident,

Kawsar Alom, 27, was attacked allegedly by Jubo League men in bazaar area at about 4.00pm. Locals admitted him to

the upazila health complex. Contacted, officer-in-

charge of Dashmina police station Md Mobarak Ali said, on information, an officer visited the injured but the victims were yet to submit any complain in this regard.

# Injured Chilmari BCL leader dies after 4 days

A local leader of Bangladesh Chhatra League (BCL) succumbed to his injures at Rangpur Medical College Hospital on Wednesday, four days after attack on him allegedly by his rivals.

The deceased was identified as Raihanul Islam Bahadur, 22, cultural secretary of Chilmari upazila unit of Chhatra League, also the son of Ataur Rahman Badshah of village Demnarpar Thanapara in the upazila.

Party sources said activists of a faction of local Chhatra League stabbed Bahadur and cut off his tendons near Momtaz Medicine Corner at the upazila headquarters on Saturday noon, leaving him critically injured. He was admitted to the

RMCH where he died early Wednesday, mounting tension in Chilmari upazila.

Locals said there had been a long-standing dispute between two factions of Chhatra League in the upazila. Bahadur was the sup-

porter of Zakir Hossain, MP of Kurigram constituency-4, while his rivals back Shawkat Ali Sarker, Chilmari upazila chairman and president of upazila unit Awami League. Victim's father Aataur

Rahman filed a case accusing 17 people of their involvement in the mur-Additional police have

been deployed in Chilmari to avoid any untoward incident. Meanwhile, Kurigram

district unit Chhatra League president Minhazul Islam Ayub said they brought the matter to the notice of their central leaders and they will take necessary steps in this regard after getting the decision.
