The Appellate Division of the Supreme Court last night released its full verdict declaring illegal the constitutional provision for a nonparty caretaker government system.

All seven judges of the apex court bench that delivered the

historic judgment over 16 months ago put their signatures to the full text around 10:00pm yesterday.

Of the seven judges, four -former chief justice ABM Khairul Haque, Chief Justice Md Muzammel Hossain, Justice SK Sinha and Justice Syed Mahmud Hossain -- were in favour of

declaring the caretaker provision unconstitutional; two -- Justice MA Wahhab Miah and Justice Nazmun Ara Sultana -- were for keeping the provision; and one --Justice Md Imman Ali -- opined that the matter should be left to

parliament. In the present political context, the complete verdict was deemed crucial to explaining how the next general election could be held.

Turn in bank details

Central bank asks 32 Sonali officials; scam buster not allowed to probe suspicious loan

The central bank yesterday asked 32 Sonali Bank officials, including a former managing director, to submit their bank statements within 10 days.

The statements will be sent to the Anti-Corruption Commission for legal action if it is found that they have illegal incomes, a Bangladesh Bank officials said.

The names of these officials came up during separate investigations after the loan scam at the bank's Ruposhi Bangla branch was unearthed in May this year, he added.

They will have to submit statements of their savings, current, fixed or any other accounts and also statements of their loans.

Of the 32 officials, 17 have been suspended over their alleged involvement in the Tk 3,606-crore loan scam involving Hall-Mark Group and five other companies. Of the sum, Hall-Mark alone swindled Tk 2,686 crore.
