BDR CARNAGE TRIAL Incumbent IGP refuses to disclose ex-IGP's directives

Pandemonium gripped a Dhaka court yesterday after Inspector General of Police (IGP) Hassan Mahmood Khandker for several times refrained from disclosing the exact directives he received from the ex-IGP during the 2009 BDR mutiny.

"I will not give the answer due to strategic reasons," said Hassan Mahmood after Judge Mohammad Zohurul Hoque intervened and the commotion had settled down. Defence lawyer Aminul Islam, while cross-examining the

IGP, had sought the exact directives the latter had received and the instructions he had given to his subordinates.

Hassan Mahmood was avoiding a direct reply, going on to alk on other issues.

times and asked the judge for assistance. At one stage, prosecutors came to the IGP's help and locked in a noisy argument with the defence lawyers, leading to the commotion.

Earlier, the Metropolitan Sessions Judge's Court, set up at Alia Madrasa playground in the capital's Bakshibazar to hold the BDR carnage trial, started recording Hassan Mahmood's

deposition around 11:20am. Hassan Mahmood, who was the director general (DG) of Rapid Action Battalion (Rab) in 2009, said he was called to the former IGP Nur Mohammad's office to discuss over the situation at Pilkhana on February 25, the first day of the mutiny.

"We talked about the situation in Pilkhana in presence of IGP and other high officials and the IGP gave us some directions. "Later, from there, I contacted the additional DG of Rab and

the company commanders over phone to give necessary instructions over the situation at Pilkhana," he said. He added, "As the rebels began deploying heavy weapons

around 11:00am, it became risky to send Rab members inside Pilkhana to conduct an operation."

The BDR rebels had introduced deputy assistant director Towhid as their new DG several times and he had witnessed Towhid actively leading the mutineers on the first day, he said. He said he heard that the bodies of two slain army officers

were found in a sewerage at Nababganj but did not inform the home minister before going to Jamuna. Seventy-four people including 57 army officials were killed in the two-day mutiny in the Bangladesh Rifles (BDR)

GOING TO MALAYSIA FOR WORK

Cost should not exceed Tk 80,000

Says expatriates' welfare minister

Migrant workers' travelling cost through the government's legal channels to Malaysia should range from Tk 75,000 to Tk 80,000, Khandker Mosharraf Hossain, minister of Expatriates Welfare and Overseas Employment, said yesterday.

He was speaking at the launch of an information campaign programme "Shabdhaner Mar Nai" to create awareness on safe migration. The campaign is also aimed at spreading information about legal ways to travel abroad among prospective migrant workers from Bangladesh.

Recently, Malaysia has announced that it will hire workers from Bangladesh, the minister said, adding that it was unfortunate that potential workers who did not know this information would fall victim to unscrupulous middle-men who would promise to help them migrate for large sums of money ranging from Tk 2 lakh to Tk 3 lakh.

Migrant workers, especially women, fall victims to fraud brokers and unscrupulous recruiters because they are unaware of the legal procedures to migrate abroad, the speakers said.

The awareness campaign will be carried out through radio, television and newspapers, and a door to door awareness programme will also be conducted in Manikganj since a large number of women workers go abroad from there.

The minister said many developed countries had extremely low birth rates, in some cases negative. These countries with aging populations have a decreasing young and productive population, he said.

In contrast, South Asian and Sub-Saharan African countries, including Bangladesh, have a growing young population who could migrate to those developed countries to support the growth of the economy, he added.

"It is noteworthy that we have about 26 lakh migrant workers in Saudi Arabia presently, 15 lakh in the UAE and about 2 lakh workers each in Kuwait, Qatar and Oman. This huge population of migrant workers sends home a large amount of remittance which shapes the balance of payment of Bangladesh's economy," the minister said.

Information Secretary Hedayetullah Al Mamoon and Expatriates' Welfare and Overseas Employment Secretary Dr Zafar Ahmed Khan also spoke on the occasion.

The event was organised by the International Organisation for Migration (IOM) with Asiatic Marketing Communications taking part in coordination and supervision.

AUG 21 GRENADE ATTACK

Babar showed negligence in arresting real culprits

Ex-police officer tells court

A former police officer yesterday told a Dhaka court that the then state minister for home Lutfozzaman Babar had showed negligence in arresting the real culprits after the August 21 grenade attack on an Awami League rally in 2004.

SM Mizanur Rahman, who had become the acting commissioner of Dhaka Metropolitan Police three hours before the attack, said this while replying to a question of the defence lawyer Abdus Sobhan Tarafder.

Mizanur is now on leave preparatory to retirement (LPR).

He told Speedy Trial Tribunal-1 that he had given his statement to the investigating officer, narrating Babar's negligence and reluctance in investigating the August 21 grenade attack cases and arresting the real accused.

Additional Superintendent of Police of CID Abdul Kahar Akond recorded his statement on

February 3, 2008.

Meantime, the defence lawyers for 26 other accused, including BNP leader Abul Harris Chowdhury, have completed cross-examining

Mizanur. Judge Shahed Nuruddin of Speedy Trial Tribunal-1 recorded Mizanur's statement yesterday and fixed September 23 and 24 for the next hearing.

The August 21 grenade attack was aimed at assassinating Awami League President and the then opposition leader Sheikh Hasina. Though she survived the attack, 24 AL leaders and activists were killed and 300 others injured. AL leader Ivy Rahman, wife of President Zillur Rahman, was among the

Advocate Syed Rezaur Rahman, chief counsel for the August 21 grenade attack cases, appeared for the state, while Mahboob Ahmad and Abdullah Mahmud Hassan defended the accused.

No test has been conducted yet to determine the type and purpose of the medicines, they added.




