## Kasab moves mercy petition before president

The lone surviving gunman from the 2008 Mumbai attacks has applied for clemency from the Indian president in a final bid to avoid the gallows, media reports said yesterday.

Pakistan-born Mohammed Kasab, one of 10 gunmen who laid siege to Mumbai in attacks that lasted nearly three days, sent his petition through officials at the Arthur Road Jail in Mumbai where he is being held, the Press Trust of India

"We have sent a mercy petition to the president filed by Kasab," the news agency quoted a senior official at the high-security prison as saying.

He said he and his band of freedom fighters could not prevent the attack as they were not armed.

On September 4, the 67year-old witness testified that a group of Pakistani army troops led by Joypurhat Shanti Committee leader Abdul Alim and Panchbibi Shanti Committee leader Joyber attacked Panchbibi from the east.

They looted and torched homes, and conducted mass killing there, he had said.

2001, Rahat was arrested with seven firearms in his possession including an AK-47 rifle, following which he was sentenced to 46 years of rigorous imprisonment by Kushtia District and Sessions Judge's Court in 2002.

However, he obtained bail in 2005, and began to organise the members of the outfit.
