Power tariff hike protested

Siege of energy ministry threatened STAFF CORRESPONDENT

The National Committee to Protect Oil, Gas, Mineral Resources, Power and Ports yesterday threatened to lay siege to the energy ministry on September 30, if the government does not withdraw its decision to increase the power tariff.

The committee leaders said the government has already increased the power tariff several times to cover the deficits in the economy caused by the plunderers of the country.

The country's people are bearing the brunt of this corruption through paying higher and higher power tariffs, they said.

The remarks came at a rally organised by the committee in front of Mukti Bhaban in the capital in protest of the government's decision to increase the power tariff once again, said a press release of the committee.

Prof Anu Muhammad, member secretary of the committee, also spoke.

SC upholds HC bail to Hizb ut-Tahrir adviser

The Supreme Court yesterday upheld a High Court order granting a six-month bail to Prof Syed Golam Maola, a senior adviser to Hizb ut-Tahrir, in a case filed on charge of organising the banned Islamist outfit to overthrow the government.

Maola's counsel Mansur Habib said now there was no legal bar to his client's release from jail.

Chamber Judge of the Appellate Division of SC Justice MA Wahab Miah passed the order after dismissing the government's September 18 petition seeking stay on the HC order.

Police filed the case against Maola, a former teacher of Dhaka University who allegedly introduced Hizb ut-Tahrir in the country, with Uttara Police Station on March 2, 2010.

Several high officials of the Sonali Bank's Hotel Ruposhi Bangla branch are involved in Hall-Mark loan scam, said Shyamal Kanti Nag, an assistant general manager (AGM) of

He, however, denied his involvement in the scam.

Shyamal spoke to the reporters on his way out of the Anti-Corruption Commission (ACC)'s Segunbagicha office in the afternoon, where he was called for interrogation.

"After we heard about the loan scam through newspapers the head office formed a three-member team including me and sent us to the branch for investigation. We discovered that Hall-Mark misappropriated the bank's money through Inland Bill Purchase (IBP) using forged documents," he said. "As we probed deeper into the matter we found some high

officials of the branch were involved," he added. However, he declined to reveal the identities of those officials. When asked how many of them are involved in the

scam, Shyamal chose to ignore the question. A Bangladesh Bank (BB) investigation found that the Hotel Ruposhi Bangla branch of the Sonali Bank had lent

Hall-Mark Group and five other companies Tk 3,547 crore between 2010 and May this year on forged documents.

Of the amount, Hall-Mark alone borrowed Tk 2,667 crore.

Primary textbooks contain misinformation on Adivasis

Despite making corrections, the primary school level textbooks still contain some wrong and misleading information about the culture and lifestyle of the country's indigenous communities, speakers said at a roundtable yesterday.

The inaccurate information is leaving a negative impression on the young minds and may put communal harmony at stake, they said, calling for bringing more modifications in the books, portraying Adivasis positively and including their contributions.

The roundtable "Ethnic identity in textbooks: Our attitude" was organised by Development Initiative for Inclusive People (DIIP) and Zabarang Kalyan Samity in cooperation with Manusher Jonno Foundation (MJF) and Ministry of CHT Affairs at Jatiya Press Club.

Speaking on the occasion, DIIP Executive Director Chowdhury Ataur Rahman Rana gave some examples of misinformation. The class V textbook Poribesh Porichiti Samaj (Social Science) says Garo women wear blouse and lungi, which is not correct, he said. "Garo women put on a traditional dress which resembles their identity."

He also said the social science book for class IV described rabbit meat, pork, and crabs as favourite food items for Santal community, which was irrelevant in the children's textbooks and might create a mental distance between people who consumed them and who did not.

Ataur Rahman urged the writers of the National Curriculum and Textbook Board (NCTB) books to be more responsible while writing about indigenous people.

"The textbooks portray mostly negatives things on indigenous people," claimed Shaktipada Chakma, organisational secretary, Bangladesh Adivasi Forum. Shaheen Anam, executive director of MJF

Students of two private universities yesterday clashed over parking a car and vandalised each other's institutions, halting traffic in the capital's Asad Gate area for half an hour.

Police said the clash ensued around 1:00pm following an altercation between Rector Obaidur Anwar of Mohammadpur Preparatory School and College and two students of People's University of Bangladesh.

While parking his car near Bangladesh University's campus-2 at Asad Avenue, Anwar hit another car of a student of People's University of Bangladesh, said Officer-in-Charge (OC) Azizul Islam of Mohammadpur Police Station. Seeing this, the student, who could not be identified, along

with his fellows locked in an altercation with Anwar and, at one stage, vandalised Anwar's car's windshield, he said.

University engaged in a chase-counter chase with the students of People's University of Bangladesh, the OC said.

During the clash, vehicular movement in the area was

interrupted, creating long tailbacks. Contacted, Deputy Registrar Sohel Ahsan Nipo of Bangladesh University denied the involvement of his institution's students in the incident.

The authorities of People's University of Bangladesh could not be contacted for a comment over the incident.

Govt facing criticism for taking action: PM

Prime Minister Sheikh Hasina yesterday told parliament that her government was facing criticism as it had been taking action against corruption, which took place in the past.

"Corruption took place when others were in power in the past. The corruption was kept suppressed. Now all of that is surfacing, and we are taking action," Hasina, also leader of the House, said in her winding up speech of parliament's 14th session.

Citing the Hall-Mark loan scam, Hasina said the managing director of Sonali Bank Humayun Kabir was a leader of Zia Parishad, a pro-BNP organisation.

Similarly, Hall-Mark MD Tanvir Mahmud, who laundered the money, was a man of Hawa Bhaban, popularly known as an alternative power house of Khaleda Zia during the past BNP-led government, she

Hasina said the culture of looting bank money and defaulting on loans begun after the assassination of Bangabandhu Sheikh Mujibur Rahman when the military rulers gave patronage to split political parties and form new parties.

The prime minister said the Anti-Corruption Commission was preparing to sue people involved in the Hall-Mark loan scam.

The AL chief also blasted her arch rival BNP chief Khaleda Zia for what she said declining to appear at court despite repeated summons. "When court summons her [Khaleda],

she feels sick. But later she feels well and makes statements against our government.

"Why does she fear to appear at court if she did not embezzle the money of Zia Orphanage Trust?" Hasina asked. Her repeated refusal to appear at court proves that she has embezzled the money, she said.

Int'l conference on Bangladesh to be held at Harvard

An international conference on "Achieving Edge for Bangladesh" will be organised at Harvard University in the United States on October 13.

The conference will discuss "Sustainability of Good Governance" and "Management of Strategic Resources" in reference to Padma Bridge and shared water resources, said a press release.

Bangladesh center for Development Studies, a civil society think-tank in North America, will organise the conference where all parties concerned, including top ranking leaders of the ruling Awami League and the opposition BNP, will exchange their views.

The first session will focus on how to sustain good governance and its impact on the development of Bangladesh. Geraldine Fraser-Moleketi, a director of UNDP, is expected to deliver the keynote speech at the session.

While newly appointed Home Minister Mohiuddin Khan Alamgir, acting secretary general of BNP Mirza Fakhrul Islam Alamgir, AL lawmaker Nazmul Hasan and BNP's information and research secretary Shakil Wahid will speak at the session.

The second session which is expected to be chaired by John Briscoe and Peter Rogers of Harvard University, will discuss the challenges that Bangladesh has faced so far in ensuring effective management of shared water resources.

This session will be addressed by Bangladesh's Ambassador and Permanent Representative to the UN Dr AK Abdul Momen, acting editor of the Daily Amar Desh Mahmudur Rahman and Dr Enamul Haq, said the press release.
